BOARD OF ELECTRICAL EXAMINERS

APPLICATION PROCESS FOR OBTAINING A PUTNAM COUNTY ELECTRICAL JOURNEYMAN LICENSE

There are three steps involved in the process of becoming an Electrical Journeyman in Putnam County.

First, the Electrical Board must review your application.
Please complete the enclosed application form and **supply proof of your experience**
The application fee is **\$150**.

- . Application Form – completely filled out by you
- . Proof of Employment Form – filled out by employer
- . Proof of **five (5) full years** in the electrical trade, including completion of attached worksheet
 - Proof can be in the form of, but not limited to:
 - . w-2 tax forms
 - . Letter from employer(s) - Notarized
 - . Social security statements
 - . Notarized statements of hours worked from employers or from benefit funds detailing experience.
 - . Notarized examples of jobs performed on company letterhead
 - THESE MUST BE ON ORIGINAL EMPLOYER LETTERHEAD FROM CONTRACTORS and NOTARIZED
 - . Inspection certificates – 5 residential, 5 commercial, at a minimum
- . Copy of driver's license – If address on license is different than home address, please provide documentation that reflects home address, e.g., utility bill.
- . Check or money order (no cash accepted) in the amount of \$150 made payable to: Commissioner of Finance

The above process can take between three to six months. Fees are subject to change.

Second, if the Electrical Board approves your application, you will be eligible to take the Journeyman Electrician's test. The testing fee is \$100 payable directly to testing provider.

Third, once you pass the test, you will be eligible to obtain a Putnam County Electrical Journeyman License. You must be a Putnam County Electrical Journeyman before you can test for an Electrical Master license.
