#### COMPLIANCE:

Joseph Madigan/McCool and Sons was referred to the legal department for collection. No action taken.

Euro Style Stone has paid for their violation in full, however, the check written was returned as non-sufficient funds. We are awaiting a new check.

Mechanical Installations Corporation pled guilty to working without a license and paid a reduced fine of \$1,250.00.

Findings of Fact were mailed to Angelo Prunella. Mr. Prunella sent an email trying to negotiate for a lower fine. The email was forwarded to the legal department. This case has been referred to the Putnam County Sheriff's Office for investigation. Mr. Prunella continues to send emails to Ms. Sorrento and has sent a letter to the Board requesting they reverse their findings. He has also sent a letter to the County Executive. This email has been forwarded to the Legal Department and Sherif's office. A final notice for payment was mailed to Mr. Prunella. Suraj Schneider, who was found guilty by default in June 2018, paid his \$1,500.00 fine.
