The meeting was called to order at 7:37 P.M. by Chairwoman Conklin who led in the Pledge of Allegiance. Upon roll call, Legislators Tamagna, Oliverio, Othmer, Albano, Birmingham, LoBue, DiCarlo and Chairwoman Conklin were present. Legislator Gross was absent. Also present was Legislative Counsel Van Ross.

PROCLAMATIONS

Chairwoman Conklin requested that Legislator Tamagna present the proclamation for the "Bells For Peace 2013".

Legislator Tamagna stated that "Bells For Peace 2013" was mentioned before our December Full Legislative Meeting. He wanted this to be captured as part of our history and to be part of our future Legislative meetings held at the beginning of December each year. He felt that this was a beautiful way for us to capture, not only something that is worthwhile for our Armed Forces and Veterans, but also for the incoming New Year and Christmas season. He stated that the "Bells For Peace 2013" was a brand new initiative led by Director of Tourism, Libby Pataki which promotes peace in the New Year.

BELLS FOR PEACE 2013

WHEREAS, Bells for Peace 2013 is an initiative led by Director of Tourism Libby Pataki which promotes peace in the New Year. Promptly at midnight on December 31, 2012, the Bells for Peace will join numerous church bells ringing out in harmony to bring in the New Year; and

WHEREAS, the American notion of peace is refreshed with every New Year and our way of life and peace is fought for by those men and women who serve in the United States Armed Forces. These men and women of the Armed Forces are trained to defend our nation and protect our freedom, which allows us the privilege to embrace peace in our everyday lives; and

WHEREAS, Director Pataki acquired the Bells for Peace, hand bells each engraved with "Bells for Peace 2013", in support of our Armed Forces and Veterans by raising donations for the Wounded Warrior Project, a project which raises awareness, aid, and provides programming to our injured service members; now therefore be it

RECOGNITION OF WILLIAM STAHL, PH.D., FOR HIS DEDICATED YEARS OF SERVICE AS PUTNAM COUNTY CORONER

WHEREAS, WILLIAM STAHL, Ph. D., Putnam County Coroner, earned a Bachelor of Arts degree from Merrimack College, a Master of Science degree from Fordham University, and a Doctor of Philosophy degree from St. John's University. WILLIAM STAHL has in depth knowledge of forensic science and was a faculty member at John Jay College of Criminal Justice, part of The City University of New York system, for over thirty years; and

WHEREAS, WILLIAM STAHL, Ph. D., was first elected as a Putnam County Coroner effective January 1, 1978. He has proudly and efficiently served as a Coroner for Putnam County for thirty-five years; and

WHEREAS, WILLIAM STAHL, Ph. D., was elected as Coordinator of Coroners in 1986 by a majority of all Coroners and has held the position ever since. As Coordinator of Coroners, WILLIAM STAHL, is responsible for coordinating the schedules of all Putnam County Coroners to insure that there is coverage 24 hours a day, 7 days a week. As Coordinator, WILLIAM STAHL also prepares and submits the annual department budget, recommends standardized forms, and insures that the Office of the Coroners is in compliance with all statutes, laws, rules, and regulations of both the state and the county; and

WHEREAS, WILLIAM STAHL, Ph. D., has responded to an unparalleled number of Coroner calls, night or day, sleet or snow, and performs his duties with the utmost professionalism and expertise; and

WHEREAS, after thirty-five honorable years as a Putnam County Coroner concurrently with twenty-seven revered years as the Coordinator of Coroners, WILLIAM STAHL, Ph. D., will retire from both positions on December 31, 2012; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby congratulate and thank WILLIAM STAHL, Ph. D. for his many years of dedicated service to the Putnam County community and wish him all the best in his retirement.

WHEREAS, Putnam County, herein called the MUNICIPALITY, has examined and duly considered the applicable laws of the State of New York and the MUNICIPALITY deems it to be in the public interest and benefit to file an application under these laws; and

WHEREAS, it is necessary that a Contract by and between THE PEPOLE OF THE STATE OF NEW YORK, herein called the STATE, and the MUNICIPALITY be executed for such STATE Aid;

NOW THEREFORE BE IT RESOLVED by the Putnam County Legislature

- 1. That the filing of an application in the form required by the State of New York in conformity with the applicable laws of the State of New York including all understanding and assurances contained in said application is hereby authorized.
- 2. That the Commissioner of Health or his/her designee is directed and authorized as the official representative of the MUNICIPALITY to act in connection with the application and to provide such additional information as may be required and to sign the resulting contract if said application is approved by the STATE;
- 3. That the MUNICIPALITY agrees that it will fund the entire cost of said household hazardous waste program and will be reimbursed by the State for the State share of such costs.
- 4. That five (5) certified copies of this Resolution be prepared and sent to the NYSDEC together with a complete application.
- 5. That this resolution shall take effect immediately.

WHEREAS, on August 30, 2012, the Worker's Compensation Board indicated that "since there is a difference in the medical opinions regarding the schedule loss of use, the parties are encouraged to speak with each other to come to an agreement"; and

WHEREAS, claimant is no longer seeking treatment and is desirous of entering into an agreement with the County, subject to the Legislature's approval, in which the County would agree to pay the sum of Fifty Five Thousand Nine Hundred Thirty One dollars and Fifteen cents (\$55,931.15) representing a 26.5% schedule loss of use of the right leg; and

WHEREAS, the Law Department and our third party administrator, The Triad Group, both recommend the settlement, as there is a difference of medical opinion and if a hearing is conducted, it would likely result in the claimant's favor; and

WHEREAS, Triad Group, through its claims representative, has in fact settled the matter with the claimant for the sum of Fifty Five Thousand Nine Hundred Thirty One dollars and Fifteen cents (\$55,931.15) dollars and has obtained settlement documents, which, upon approval of the Putnam County Legislature and the Worker's Compensation Board, will discontinue this matter with the Court; and

WHEREAS, the settlement is in the public interest and will avoid additional exposure and expense; now therefore be it

RESOLVED, that the settlement of this matter for the sum of Fifty Five Thousand Nine Hundred Thirty One dollars and Fifteen cents (\$55,931.15) is approved; and be it further

RESOLVED that from said settlement the County will be reimbursed Five Thousand Sixty Four dollars and Seven cents (\$5,064.07) for time paid to claimant, Seven thousand (\$7,000.00) will be paid to claimant's attorney and the claimant will receive Thirty Nine Thousand Five Hundred Seventy Six and Six cents (\$39,576.07) in full settlement of this matter; and be it further

APPROVAL/LOCAL LAW/CELL PHONE AND ELECTRONIC DEVICE USAGE AND SAFETY POLICY/ AMEND THE CODE OF PUTNAM COUNTY / ADDING A NEW CHAPTER 19 TO THE CODE OF PUTNAM COUNTY

A LOCAL LAW TO AMEND THE CODE OF PUTNAM COUNTY BY ADDING A NEW CHAPTER TO THE CODE OF PUTNAM COUNTY ENTITLED "CELL PHONE AND ELECTRONIC DEVICE USAGE AND SAFETY POLICY"

BE IT ENACTED BY THE LEGISLATURE OF PUTNAM COUNTY AS FOLLOWS:

Section 1.

A New Chapter 19 is hereby added to the Code of Putnam County Entitled "Cell Phone and Electronic Device Usage and Safety Policy" to read as follows:

§19-1 – Legislative Intent.

The Putnam County Legislature is acutely aware of the increasing dependence upon cell phones and electronic devices in everyday life, particularly in the work-place, and the potential for injury and/or accidents that improper use of said devices can cause to people and property.

The Putnam County Legislature recognizes the need for a cell phone and electronic device usage and safety policy to protect the well-being of the County workforce, taxpayers, citizens, and property owners from unwarranted injuries and/or accidents due to improper usage of cell phones and electronic devices.

The Putnam County Legislature is also desirous of creating a Cell Phone and Electronic Device Usage and Safety Policy by amending the Code of Putnam County to add Chapter 19, §§19-1, 19-2, 19-3, 19-4, 19-5, 19-6, 19-7, 19-8, 19-9, 19-10, 19-11, 19-12, 19-13, 19-14, 19-15, 19-16.

§19-2 – Establishment (Usage); Purpose.

There is hereby enacted a Cell Phone and Electronic Usage and Safety Policy which shall direct its efforts to providing guidelines for the purchase, use, and payment of cell phones and electronic/personal communication devices for county related business.

§19-3 – General intent and policy.

Cellular phones are provided to improve public service.

In order to be eligible for cell phone use, employee justification must be approved by the Department Head, and either the telephone committee or the County Executive or

designee. If approved, they will be subject to the guidelines set forth in this cell phone and electronic device usage and safety policy.

The Cell Phone Committee is comprised of the Deputy County Executive, County Auditor, Purchasing Director, Director of Information Technology, Chief Deputy Commissioner of Finance, and the Deputy Commissioner of Finance.

Cell phones shall be issued to employees that are required to be available 24 hours a day, 7 days a week.

Cell phones shall be issued only to those employees who have a frequent need for remote telephone access and paging type activity, whose job responsibilities require them to be out of the office more than 50% of the workday.

The following considerations shall apply when determining whether a cell phone should be issued:

A. Whether issuance of the cell phone will promote communication in emergency circumstances;

B. Whether the employee is frequently in business-related travel status;

C. Whether the employee's primary work location requires access to a cell phone;

D. Whether there is a reasonable expectation for other members of Putnam County to be able to contact the officer or employee at times other than regular busines

County to be able to contact the officer or employee at times other than regular business hours; and

E. Whether other means of communication are available and less expensive to obtain and/or maintain.

F. Cell phones are not a personal benefit and shall not be the primary mode of communication, unless they are the most cost-effective means to conduct County business.

§19-4 – Cell phone option.

a) County-owned Cell Phones:

- All personal phone calls are highlighted and employee reimburses County at the current rate per minute. The cell phone bill is to be fully reviewed by Finance.
- b) Personally-owned Cell Phone (Reimbursement):
 - Upon submittal and approval by the telephone committee, employees not eligible for county-owned cell phones may be reimbursed for county business phone-calls made from their personal cell phones.
 - Any employee seeking reimbursement must provide proof of business related calls on their personal cell phone.

§19-5 – Billing statements and reconciliation for County-owned cell phones.

- The Department will receive a monthly activity statement from the cell phone provider showing the usage and call detail for each phone.
- The Department must review the statement for accuracy and forward it to the Finance Department for payment. If the statement has any charges in excess of the base monthly plan, the supervisor must sign the statement.
- All statements will be analyzed by the Telephone Committee for any plan changes that may be necessary.
- The County will pay the monthly cellular phone bill from the invoice. No further action is required from the employee unless there were excess charges.

- This paragraph will not apply to cell phone records used in confidential law enforcement activities where such review would compromise the operational security of any law enforcement agency.
- §19-6 Personal use for County-owned cell phones.
 - While we discourage the use of personal calls from a County owned cell phone, we realize that there may be situations where a personal call is necessary. When personal calls are made or received they must be highlighted on the monthly statement and reimbursed to the County at the current rate per minute.*
 - Excessive abuse of personal calls will lead to removal of cell phone, and may lead to other disciplinary actions.

§19-7 – Financial Affairs.

- The Telephone Committee and/or the County Executive will approve all requests for cellular service.
- This approval will include the equipment, and the plan needed for each individual employee.
- Service will be dependent on the individual's needs. The Department Head, and a representative from the Telephone Committee will evaluate these needs.
- The smallest plan available that accommodates the business need shall be utilized based on prior usage.
- Any upgrades or changes to the equipment or service must go through the same approval process.

§19-8 – Purchasing.

- The Purchasing Department will order and monitor all equipment.
- Under NO circumstances should equipment be ordered without PRIOR approval from the Telephone Committee.
- Any repair to the equipment should be sent through the Purchasing Department unless impossible to do so.
- The Purchasing Department will maintain an inventory of all phones and forward a copy of the inventory to the Auditing Department on a quarterly basis.

§19-9 – Personal responsibility.

- The employee must accept the Cell Phone Policy and Procedures of Putnam County.
- All equipment must be returned to the employee's Department upon leaving employment with that Department.
- The Department will notify the Telephone Committee upon an employee's departure from the County so appropriate measures can be taken.
- Damaged, Lost or Stolen Telephones:
 - The user has sole responsibility for their telephone. Replacement will be at the employee's expense in case of negligence. Employee must notify their Department Head immediately if their County owned cell phone is lost or stolen.

- Calls made from a stolen phone prior to the date of notification are the responsibility of the employee.
- Phones may not be assigned to another person without the consent of the Telephone Committee. Cell phones should not be used while driving.
 Please be aware in many states the use of a cell phone while driving is prohibited.
- Cell phone bills for County-issued cell phones are not private. The County has the right to monitor all bills.

§19-10 – General intent and policy (safety).

Of increasing concern to County are the dangers of distracted driving. Recent deadly crashes involving drivers distracted by talking, texting, or using electronic devices while driving highlight a growing danger on our roads. Numerous studies have demonstrated how the use of cell phones while driving pose a significant risk to motorists, their passengers, and others on the road. In addition, Highway Work Zones are one of the most dangerous places for both drivers and highway construction workers. Therefore, County will not tolerate the use of electronic devices, including, but not limited to, the use of hand-held or hands-free cell phones in any manner, the use of any hand-held electronic devices, certain use of GPS and/or the use of headsets while operating a County vehicle, while using a County issued cell phone while on duty and operating a personal vehicle, or at any time when an employee is functioning in the capacity of "Traffic Control Personnel."

County employees are required to comply with the following:

§19-11 – Cell phones.

The use of cell phones or personal digital assistant (hereinafter "PDA") while operating a County vehicle, while using a County issued cell phone or PDA while on duty and operating a personal vehicle, or at any time when an employee is functioning in the capacity of Traffic Control Personnel, is strictly prohibited. This includes, but is not limited to, using hands-free headsets; answering or making phone calls; engaging in phone conversations; utilizing the camera and/or recording function(s); reading or responding to e-mails; using the internet and reading; or typing or sending text messages. Voicemail must handle all calls while driving; calls may only be returned when stopped and pulled off the road. The only exception to this policy is to place a 911 call in an emergency.

§19-12 – Electronic devices.

Use of Electronic Devices, including, but not limited to, laptops other than installed police vehicle laptops, PDA, cameras, pagers and digital audio player(s) (IPods, MP3 players, etc.), while operating a County vehicle, while using a County-issued electronic device while on duty and operating a personal vehicle, or at any time when an employee is functioning in the capacity of Traffic Control Personnel, is strictly prohibited, unless said electronic device(s) are directly linked to the vehicle.

§19-13 – GPS or any positioning/navigation/timing systems.

While operating a County vehicle, or while using a County-issued GPS or positioning/navigation/timing system while on duty and operating a personal vehicle, the following is strictly prohibited:

- GPS, or any other positioning/navigation/timing systems, may not block or obstruct the driver's view in any way.
- GPS, or any other positioning/navigation/timing systems, must be voicenarrated and must not require the driver to look away from the road for directions.
- Programming or otherwise engaging with GPS, or any other positioning/navigation/timing systems, may only occur prior to departing, or while stopped and pulled off the road.

§19-14 – Headsets.

Employees may not under any circumstances use headsets with any cell phones or digital audio player while operating a County vehicle, while using a County-issued cell phone while on duty and operating a personal vehicle, or at any time when an employee is functioning in the capacity of Traffic Control Personnel. Such conduct is strictly prohibited.

§19-15 – Traffic Control Personnel.

All County employees who are assigned to Traffic Control may not use any cell-phones, and/or electronic devices, including but not limited to, cell phones, pagers, radios, digital audio player, and PDA. Furthermore, Traffic Control Personnel may not use any cell phones or such electronic devices with headphones.

Only such devices as two-way radios used for telecommunications between Traffic Control Personnel to direct traffic, or ensure Traffic Control Personnel safety are acceptable.

§19-16 – Expectations.

All County employees are expected to conduct themselves in accordance with all applicable laws and regulations, in addition to County and Departmental policies. Any violation of this Policy by an employee will result in the employee being counseled to correct inappropriate work behavior and/or any other appropriate disciplinary action in accordance with his/her applicable Collective Bargaining Agreement.

Section 2.

THIS LOCAL LAW SHALL TAKE EFFECT AS FOLLOWS:

- With regard to current County employees who are not members of a collective bargaining unit, one calendar week after this local law passes and the policy is distributed;
- The cell phone and electronic device usage and safety policy shall be included in the current negotiations with the Civil Service Employees Association, the Putnam County Sheriff's Department Police Benevolent Association, and the Putnam County Sheriff's Employees Association for incorporation in Collective Bargaining Agreements; and
- This local law shall take effect immediately with regard to new County employees immediately upon commencement of employment.
