### REGULAR MEETING OF THE PUTNAM COUNTY LEGISLATURE HELD IN THE HISTORIC COURTHOUSE CARMEL, NEW YORK 10512

The meeting was called to order at 7:00 P.M. by Chairwoman Conklin who led in the Pledge of Allegiance. Upon roll call, Legislators Tamagna, Oliverio, Othmer, Albano, Gross, Birmingham, LoBue and DiCarlo and Chairwoman Conklin were present. Also present was Legislative Counsel Van Ross.

Chairwoman Conklin recognized Mr. Peter Pennelle, Commander of the Putnam County Joint Veterans Council and Mr. Karl Rohde, Putnam County Director of Veterans Affairs, who presented Lt. Col. Mahoney with a proclamation. They commended him for his service to our local veterans and for his work at Castle Point Veterans Center.

### PROCLAMATION

Honoring Brennan P. Mahoney, Lieutenant Colonel, US Army Reserve (By the Putnam County Joint Veterans Council)

WHEREAS, Brennan P. Mahoney, Lieutenant Colonel, US Army Reserve, was born on March 16, 1964, in Hartford, Connecticut; and

WHEREAS, Lieutenant Colonel Mahoney received the following military training in further ance of his service to our Nation: Basic Training/Advance Individual Training; 1982, Officers' Candidate School (OCS) 1989, Engineer Officer Basic Course (OBC) 1990, Nuclear, Biological, Chemical Defense Course (NBC School 1992, Engineer Officer Advance Course (EOBC) 1997 and Combined Arms Services Staff School (CAS3) 2000; and

WHEREAS, Lieutenant Colonel Mahoney has also achieved distinction in the civilian academic world by receiving a Bachelors of Science Degree from the State University of New York in Buffalo in 1989, a Masters of Science Degree from the University of Bridgeport in 1991 and is a Doctorate candidate at Capella University, Minneapolis, Minnesota; and

WHEREAS, Lieutenant Colonel Mahoney has distinguished himself by receiving the following awards, decoration and badges: Legion of Merit, Army Commendation Medal (4), Army Achievement Medal (2), Army Good Conduct Medal (1), Army Reserve Component Achievement Medal (4), National Defense Service Medal (2), Global War on Terrorism Service Medal (1), Humanitarian Service Medal (1), Iraq Campaign Medal (1), Armed Forces Reserve Medal w/M Device and Silver Hourglass (2), Overseas Service Ribbon (2), Army Service Ribbon (1) and Army Reserve Overseas Training Ribbon (7); and

WHEREAS, Lieutenant Colonel Mahoney has served the United States Army in active duty form 1082 to 1984, the New York National Guard from 1984 to 1990 and has since been a member of the United States Army Reserve from 1990 to the present; and

WHEREAS, Lieutenant Colonel Mahoney is a member of the VFW Post 5491, Mahopac, American Legion Post 1080, Mahopac and the Putnam County Joint Veterans Council; and WHEREAS, Lieutenant Colonel Mahoney provides invaluable service to our Veterans as a Veterans Service Officer with the New York State Division of Veterans' Affairs where he is responsible for assisting Veterans and their families in applying for Veterans benefits for which they are entitled, conducting Veterans benefits briefings to deploying and returning active and reserve forces in large groups as well as processing claims for individuals for benefits such as service connected disability benefits, education benefits and healthcare and death/burial and DIC benefits through the United Stated Department of Veterans Affairs; now therefore be it

RESOLVED, that Peter Pennelle, Commander of the Putnam County Joint Veterans Council do hereby present this Proclamation to Lieutenant Colonel Mahoney in recognition and deep gratitude for his tireless service to his Nation, his State and his fellow Veterans and do hereby call upon all Veterans of Putnam County, New York to pause and thank Lieutenant Colonel Mahoney for his unstinting service to the United States of American.

Chairwoman Conklin recognized Assemblyman Katz who presented Lt. Col. Mahoney with a proclamation from New York State honoring his service to his Country and to local veterans.

Chairwoman Conklin recognized Mr. Denis Castelli, the County Historian, who also serves as Congresswoman Nan Hayworth's Liaison for Veterans Affairs. He presented Lt. Col. Mahoney with a commendation that was read into the Congressional Record by Congresswoman Hayworth recognizing and commending his service to his Country as well as his current responsibilities in assisting local veterans.

Chairwoman Conklin requested Legislator Othmer present the following proclamation to Ms. Adriene Iasoni, a representative from the Youth Bureau.

"Children of Alcoholics Week"

WHEREAS, it is estimated that one in four children in the United States under age 18 is hurt by family alcohol abuse or alcoholism and that countless others are affected by parental drug use; and

WHEREAS, there is strong scientific evidence that alcoholism runs in families with children of alcoholics being 2 to 4 times more likely to develop alcoholism than children of non-alcoholics; and

WHEREAS, parental alcohol abuse or drug use is a significant factor in a large proportion of child abuse and neglect cases; and

WHEREAS, young children of alcoholics exhibit symptoms of depression and anxiety to a greater extent than children of non-alcoholics; and incur increasing health care costs and experience more life problems over their lifespan; and

WHEREAS, young children of alcohol or drug dependent parents often have difficulty in school and are more likely to be truant, drip out of school, repeat grades or be referred to a school counselor or psychologist; and

WHEREAS, children of addicted parents, with interest and support from family, friends, health professionals, teachers, clergy and other can avoid the negative effects of familial alcoholism and drug dependence; now therefore be it

RESOLVED, that Putnam County Executive MaryEllen Odell and the Putnam County Legislature do hereby recognize February 12-18, 2012 as Children of Alcoholics Week and encourage all residents to help break the silence often surrounding family alcoholism and drug addiction and to reach out to support these children and their families.

WHEREAS, Putnam County has participated successfully in the state "I Love NY" promotional program for over a decade; and

WHEREAS, the "I Love NY" program has increased awareness of Putnam County to the regional community, assisted in the promotion of the Putnam County economy and has brought out-of-county revenues to innumerable small businesses, recreations centers and merchants; and

WHEREAS, funds from the "I Love NY" program, which when matched with local funds, have been used to promote many important cultural, historical and athletic events, including:

The Tour de Putnam The Annual 4-H Fair The Half-Marathon Founder's Day in the Village of Brewster Seasonal athletic events in all parts of the County

And many, many more exhibits, events and activities; and

WHEREAS, the current "I Love NY" funding formula has provided funds specifically designated for the promotion of tourism in Putnam County, funds from which have been managed by a knowledgeable and professional local staff sensitive to the various tourist destinations in Putnam County; and

WHEREAS, such "I Love NY" funds have been wisely allocated to enhance tourism opportunities for the entire County; and

WHEREAS, many regional, state and national studies have concluded that for every tourism dollar spent in a particular locale, seven private-sector dollars in ancillary and additional revenues are created and spent in the local economy; and

WHEREAS, it has been proposed that the funding formula for the "I Love NY" program be radically and drastically modified in a manner which could deprive Putnam County, and by extension, its tax payers, the value of such location-specific tourism; and such funding modification could take needed state resources away from promoting tourism in Putnam County; now therefore be it

RESOLVED, that the Putnam County Legislature hereby states its opposition to the proposal for regional funding for tourism and respectfully requests that the Governor of the State of New York, the State Senate and the State Assembly endeavor to continue the "I Love NY" funding program on a county-by-county distribution basis; and be it further

RESOLVED, that a certified copy of this resolution be sent to Governor Cuomo, the President Pro Tem of the Senate, the Speaker of the Assembly, Senator Ball, Assemblywoman Galef, Assemblyman Katz and the New York State Association of Counties.

WHEREAS, the Legislative Re-Districting Commission has recommended that a small portion of Patterson Election District 6 be transferred from Patterson Election District 6 to Patterson Election District 3; and

WHEREAS, the portion of Patterson Election District 6 is bounded and described as follows:

West by the Town of Kent North by Towners Road (as referred to on the Census map and Noonan Road on the Legislative District map);

South by the Town of Southeast

East by Fields Corners Road; and

WHEREAS, the total population of this portion of Patterson Election District 6 contains a population of 175 residents; and

WHEREAS, this portion of Patterson Election District 6 has more of community of interest with Legislative District 4 than Legislative District 3; and

WHEREAS, the Rules Committee has considered and approves of this transfer; now therefore be it

RESOLVED, that the Putnam County Legislature requests that Putnam County Board of Elections transfer the above described parcel of property from Patterson Election District 6 to Patterson Election District 3.

Item # 5e - Approval/Local Law/amend Chapter 70 of the Putnam County Code/Entitled "Legislative Districts" was next. On behalf of the members of the Rules Committee, Legislator Othmer moved the following:

Legislator Albano stated that the goal of the Charter Review Commission was to have all the Legislative Districts have approximately 11,500 residents and to keep "communities of interest" together. In his opinion, the Commission did an excellent job.

Legislator Birmingham stated that this redistricting is required by Charter every ten years after the census. Unlike other states and communities, the Putnam County Charter mandates that the Re-Districting Commission is bi-partisan with equal numbers of Democrats and Republicans. This history of our Charter form of government shows that the Legislative District lines have been drawn by the recommendation of this bi-partisan Commission. It is important to recognize what is special about Putnam County and that is this re-districting was not political. It was an unanimous vote from the Commission for these changes.

Legislative Counsel Van Ross, who chaired the Re-Districting Commission, stated that he wished to thank his fellow members. Mr. Anthony Maccarini and Ms. Karin Greenfield-Sanders were the Democratic representatives. Mr. James DiBella and he were the Republican representatives.

WHEREAS, the County of Putnam, New York (the "County") has the power and authority to issue general obligation bonds of the County for the purpose of, among other things, paying the cost of the reconstruction and improvement of the County Office Building and other buildings and facilities, including original equipment, machinery, apparatus, appurtenances and incidental improvements and expenses in connection therewith, pursuant to the provisions of the Local Finance Law of the State of New York (the "Act"); and

WHEREAS, the County Legislature of the County is considering to proceed under the provisions of the Act to authorize, sell and issue its general obligation bonds and/or notes in anticipation thereof, for said purpose, subject to the terms and conditions set forth in one or more bond resolutions in an aggregate principal new money amount not to exceed \$270,000 to be adopted thereafter in accordance with requirements of the Act; and

WHEREAS, the Internal Revenue Code of 1986, as amended, and the United States Treasury Department regulations promulgated thereunder (together, the "Code") require that an issuer who intends to reimburse itself for monies to be advanced and expended for a capital project form the proceeds of a debt obligation of the issuer, adopt a declaration of official intent to so reimburse not later than sixty days after the payment of any such original expenditures paid with such advanced monies; and

WHEREAS, the Code provides that such declaration may be made in the form of a resolution of the issuer;

NOW, THEREFORE, BE IT RESOLVED, by the County hereby finds and determines:

Section 1. The County Legislature of the County hereby finds and determines:

- (a) By virtue of the Act, the County has been vested with all powers necessary and convenient to carry out and effectuate the purposes and provisions of the Act and to exercise all powers granted to it under the Act.
- (b) It is the intent of the County to authorize, sell and issue its general obligation bonds and/or notes in the aggregate new money principal amount not exceeding \$270,000 (the "bonds" and the "Notes") for the purposed of paying the cost of the reconstruction and improvement of the County Office Building and other County buildings and facilities, including original equipment, machinery, apparatus, appurtenances and incidental improvements and expenses in connection therewith (the "Project"), pursuant to the provisions of the Act.
- (c) It is expected that under Section 149(e) of the Code, interest on the Bonds and/or Notes will not be includable in gross income for federal income tax purposes.
- (d) In anticipation of the issuance of the Bonds and/or Notes, the County hereby states its intention to reimburse general fund monies of the County heretofore and hereafter expended in an amount not to exceed \$270,000 in connection with the Project through the issuance of the Bonds and/or Notes, such reimbursement allocations to be made not later than eighteen months after the date the original expenditure is paid and such expenditure of general fund monies is hereby authorized pursuant to resolutions of this County Legislature authorizing said Project.

Section 2. A copy of this resolution shall be placed on file in the office of the Clerk of the County Legislature where the same shall be available for inspection during business hours.

Section 3. This resolution shall take effect immediately.

Item #7 – Recognition of Public. There was no member of the public who wished to speak.

Item #8 – Recognition of Legislators.

Legislator DiCarlo stated that there had been a preliminary discussion on moving the County's budget process to later in the year during this past year's budget review. Since Putnam County is one of the first Counties in New York State to pass a budget, much of the appropriate information to assist with determining a budget is not yet available when the Legislature begins its review process in September. He would like to recommend that the discussion is continued again. He requested that the Rules Committee make this a future agenda item.

Legislator Birmingham stated that it is traditional in an election year that when a Legislator decides not to run for re-election, he makes that announcement at the end of the meeting at the beginning of the year. He would like to announce this evening that he will not be running for re-election in November. He feels it is time to move on to allow new ideas and vision to be added to the Legislature. He has notified the Party Chairs. He looks forward to working with his colleagues and the Administration through the rest of this year. He will remain a resident and taxpayer in the County.

Legislator Oliverio stated that so many of the current Legislators were "freshmen" or "sophomores". That is a concern for him. He questioned if term limits would adversely affect the Legislature. There is value in the wisdom and knowledge of long time legislators. That will be missing. He questioned if term limits should be re-examined.

Legislator Othmer stated that Legislator Birmingham will be greatly missed. He also recognized the accomplishments of Navy Seal Team 6 for their brave and daring rescue of hostages in Somalia.

Legislator DiCarlo stated that he had the privilege of attending the "Women of Excellence" awards over the weekend. The award winners would be recognized at the Legislature's Regular meeting in March. He also reminded residents that this was the time to call, write or e-mail to the Governor and to their State representatives and demand that underfunded and unfunded mandates be taken away from the Counties.

Legislator Gross stated that he had learned a lot from Legislator Birmingham and he would be missed on the Legislature.

Chairwoman Conklin wished everyone a very Happy Valentines Day.

There being no further business, at 7:55 P.M. Legislator Tamagna made a motion to adjourn; seconded by Legislators DiCarlo and Oliverio. All in favor.
