Upon roll call, Legislators Tamagna, Oliverio, Othmer, Gross, Birmingham, LoBue and Chairwoman Conklin were present. Legislator Albano arrived at 6:35 pm and Legislator DiCarlo arrived at 7:40 pm. Also present was Legislative Counsel Van Ross.

Chairwoman Conklin stated that they would now review the proposed changes submitted by each Committee.

# HEALTH, SOCIAL, EDUCATIONAL & ENVIRONMENTAL COMMITTEE (Chairman Oliverio, Legislators Othmer & Tamagna)

Chairwoman Conklin recognized Legislator Oliverio, Chairman of the Health, Social, Educational & Environmental Committee. On behalf of the members of the Committee, Legislator Othmer and Tamagna, Legislator Oliverio moved the following:

Legislator Oliverio stated that the installation of a Ramp/Lift for the Kent Seniors was a request put forward by the Seniors to Legislator Othmer.

# PHYSICAL SERVICES COMMITTEE (Chairwoman LoBue, Legislators Albano & Othmer)

Chairwoman Conklin recognized Legislator LoBue, Chairwoman of the Physical Services Committee. On behalf of the members of the Committee, Legislators Albano & Othmer, Legislator LoBue moved the following:

Legislator LoBue made a motion to amend what came out of the Physical Services Committee Budget Meeting and remove the amount for the Friday Trolley which would amount to \$10,649.00; seconded by Legislator Birmingham for discussion.

Legislator Birmingham stated that he was concerned that the money we appropriate is used in that line only for PART. If the amount for the Trolley and the PART system are combined in one line, he stated that if we reduce the amount by \$10,000 what in the budget, other than Legislator LoBue saying it, attributes that \$10,000 cut to the Trolley.

County Auditor Alfano-Sharkey stated that it would be specified in the resolution.

Legislator Tamagna stated that we just approved \$10,000 for a handicap ramp without any discussion at all. He believed that the Trolley was just as important to the western side of the County as the transportation is to the eastern side of the County. He stated that unless everyone is going to share the pain, then he did not see why the western side of the County should be singled out.

Legislator Oliverio concurred. He wanted to keep the transportation budget whole. He believed the money could be found. He stated that residents feel very strongly about the need for transportation. He stated that believe it or not, the only transportation on the western side is the Trolley, since the County did away with the Putnam Valley routes three years ago.

Legislator Birmingham stated that budgets are about choices. If the Committee votes down the amendment he would respect that, however, we need to realize what that would set up. If we vote to keep the trolley and vote down the two routes of the PART system, he believed that would send a strong negative message.

Legislator Tamagna stated that he wants the same transportation service provided in 2013 as in 2012. He stated that he couldn't wait for the Task Force Committee to be set up next year. He stated that when the PART system was done away with for Putnam Valley and for Philipstown five years ago, it was done in the blink of an eye. There are people that want to live with the same dignity in these areas as on the eastern side of the County. He was fed up with the fact that the western side of the County, particularly Philipstown, is always singled out.

Legislator LoBue stated that it was one of the things the Administration pointed out. She believed that everyone was in an agreement that next year there needs to be some studies done and possible modifications made to the system. She stated that she did not have a problem with passing this as is as was approved by Committee.

Legislator LoBue stated that she would remove her motion to amend.

Legislator Birmingham removed his second.

Legislator LoBue moved the following:

Legislator Birmingham explained that over the years, some Legislators may have received calls such as; why is the County putting a roof on the xyz buildings? He stated that as Legislators we often don't know the reason for that because we appropriate it in November and the money could get spent in April. In the budget it is a general document. He stated that over the last three or four years, we have moved both this line and the previous item passed out of the actual appropriation lines into subcontingency so that as repairs and capital improvements are needed throughout the fiscal year, the Administration has to come to the Legislature to ask for the money to be moved out of subcontingency.

Legislator Tamagna questioned if it was the intent of this Legislature to put the \$800,000 for Capital Projects for the year 2013 and place it in subcontingency where you can only pull from this line if it is part of the approved Capital Projects that we authorize in 2012 for 2013.

Legislator LoBue said "no". It is only for the Legislature to have control over the funds. As the projects come forward, it comes before the Legislature for approval.

Legislator Birmingham stated that Legislator Tamagna brings up a good point. Our Capital Projects has never been, although he thinks it should be, a limiting document to us. It is our fault that we haven't had a plan. The new Administration has recognized that and they want to make some changes in the Planning Department to take care of some of that planning. To change the Capital budget should be a big deal and it hasn't been. This is a weak attempt, at best, to try and get us in the process. He agreed with Legislator Tamagna stating that he was absolutely right that the process needed to be changed.

Legislator Tamagna stated that in the future, when we have a five year Capital Projects Plan, we need to have these numbers tie into the actual Capital Budget so that we know what we are spending money on.

# PROTECTIVE SERVICES COMMITTEE (Chairman Albano, Legislators Gross & Oliverio)

Chairwoman Conklin recognized Legislator Albano, Chairman of the Protective Services Committee. On behalf of the members of the Committee, Legislators Gross & Oliverio, Legislator Albano moved the following revised Item #7:

Legislator Birmingham questioned if there was any room for discussion on this item as far as the amount.

Chairwoman Conklin stated that she was very concerned about this. Everyone was asked to cut their budget by 10% and here we are increasing this by a huge amount.

Legislator Oliverio stated that the reason why the Committee requested the increase was because the actual overtime so far for this year has exceeded, by a large amount, from the budgeted amount. The Sheriff and his representatives made a strong case for the need of that overtime. Legislator Oliverio stated that he was willing to shave off a small amount. Although, he did not believe the \$200,000 would be enough. The difficulty with the Jail is that you never know the need that will arise. There are many different scenarios that could happen that would require the need for overtime.

Legislator Albano felt that it was a realistic figure. However, it was something that we needed to get more control over.

## ECONOMIC DEVELOPMENT & ENERGY COMMITTEE (Chairman Birmingham, Legislators DiCarlo & Tamagna)

Chairwoman Conklin recognized Legislator Birmingham, Chairman of the Economic Development & Energy Committee. On behalf of the Committee, Legislators DiCarlo and Tamagna, Legislator Birmingham moved the following Item #9:

Legislator Birmingham stated that the move to place the Putnam County Economic Development Corporation money into subcontingency was to allow the EDC Committee to refocus on their mission. However, he was still confused on how this would help them reorganize and refocus their mission if we left them, essentially, with no money as of January 1<sup>st</sup>. He believed that EDC, which is a separate corporate entity of the County, wanted to reorganize or refocus itself, they could do that. He did not see how giving them the money would hinder them in any way. The money could be parceled out on a monthly or quarterly basis, as has been done in the past with other outside agencies. He believed the full amount should be kept in the EDC line. He stated that both of these numbers together do not exceed the funding for this year. There is no increase. He stated that Shop Putnam is a winning program. He stated that last year we gave them \$17,000 and he proposed increasing the \$10,000 to \$12,000.

Legislator Birmingham made a motion to amend the \$10,000 and increase that amount by \$2,000 for a total of \$12,000 for the Shop Putnam program; seconded by Legislators LoBue and Gross.

Legislator Gross stated that the EDC needed autonomy. He believed that if they needed to wait a few weeks before they could receive their funding it would hamper their operations.

## AUDIT & ADMINISTRATION COMMITTEE (Chairwoman Conklin, Legislators Birmingham & LoBue)

Chairwoman Conklin on behalf of the members of the Audit & Administration Committee, Legislators Birmingham and LoBue, moved the following Item #11:

Chairwoman Conklin stated that the Grant Incentive in the Planning Department was an item proposed by the Administration. She believed that this would open up Pandora's Box because why wouldn't this also pertain to other employees of the County who seek grant initiatives.

Legislator Albano believed that we should keep the Grant Incentive position. He stated that many sales based organizations work on incentives. He believed that if every position in the County was incentive based, bring in a million dollars, it would be a great thing. This is an area where there are large grant monies available to the County that we are currently not looking for. He stated that, in the future, the County will be required to do certain things with respect to such items as; bridges, dams, roads and transportation routes. He believed there was a lot of money out there that is made available through grants from the Federal Government. We needed a person to spend time researching these grants. If we spend a little money on this now, he believed it would come back to the County tenfold. He believed strongly that this would benefit us in the future.

Legislator Birmingham stated that he does not necessarily disagree; however, he has a serious reservation about this. He stated that essentially we are putting a bounty on grants being brought into the County. He believed it was part of several employees' jobs already. Many employees have done a great job without this incentive bonus. He was concerned that with that type of incentive, which he understands is based upon the amount of the grant, could incentivize someone to get a grant that has more money even though it might not be a great fit for the County. Just because a grant has more money does not mean it might be something the County needs. We need to have our grant writers and Department Heads focus on getting the grants the County needs and realize that their remuneration for that is their salary. The Administration's proposal is for one position in the Planning Department that is not even in that department yet. He stated that many departments in the County have obtained grants. He believed that to limit this to one individual was an equity issue. He stated that he would vote to take this out and advised his colleagues to do the same.

Legislator LoBue concurred. She stated that on a general note, the Administration unveiled 15 positions; with benefits is over \$1 million dollars, without any long term funding attached to them. She cautioned her colleagues to be very careful with respect to any positions tonight that we create because once the position is created the person leaves with a pension.

Legislator Oliverio stated that to keep this money in the line seems superfluous because we have not voted on the Regional Grant Coordinator and he believes the votes on that

position will be "nay". He stated that he agrees with what Chairwoman Conklin, and Legislators Birmingham and LoBue have stated. He does not believe it is the way to go.

Legislator Gross stated that he has experience with grant writers in the school district and incentives work. He further stated that it does bring in funding and more than pays for their salary. He stated that he does recognize the inequities in other departments but stated incentives do work.

Legislator Tamagna stated that he agrees with Legislator Gross. He stated that it is done at the State and Federal levels. He stated that the County is in desperate need of grant money to offset real property taxes.

Legislator Oliverio stated that during the Personnel Committee section he will put forth a motion to establish a Deputy Commissioner of Planning position.

Legislator Albano stated that we do not have a grant writer. He stated that the person in this position will have to produce. He further stated that in the future things will come up and we will have to spend money on them.

Legislator Oliverio stated that two properties in Putnam Valley could be sold for a total amount of \$350,000. He stated that he feels that we should increase the \$500,000 to \$600,000.

Legislator Oliverio made a motion to amend the resolution to \$600,000, seconded by Legislator Tamagna.

Legislator Gross stated he is concerned about 2013. He stated that he hopes Legislator Oliverio is correct.

Legislator Birmingham stated that he believes these properties will gain more exposure through a realtor. He stated that we have a back log of properties from not having a tax sale this year. He stated that Finance stated that \$424,000 is a conservative number.

Legislator Albano stated he would rather be conservative. He stated that is it something brand new and hopes it will benefit the County.

Legislator Tamagna stated that this program will bring in revenue and he stated that he believes \$600,000 is conservative. He stated that the County has carried the burden of these properties for years.

Legislator LoBue stated she is a pessimist and does not believe the number should be changed.

A vote was called to amend the resolution raising the number to \$600,000.

Legislator Oliverio introduced a resolution to add money to the Sales Tax line based on the numbers from 2012. Seconded for discussion by Legislator Birmingham.

Legislator Tamagna stated that he agreed with Legislator Oliverio. He further stated that when the Administration starts the budget process they do not have real time sales tax numbers.

Legislator Birmingham stated that he is okay with the raised amount. He believes it will offset real property taxes.

Legislator Gross stated that the current price for gas is \$3.86. He further stated that the price of gas goes up and down.

Legislator LoBue stated that the purchasing of cars increases at the end of the year because they are discounted.

Legislator DiCarlo arrived during the recess and apologized for his tardiness. He stated that he had a previous commitment for his primary job that he could not miss.

# PERSONNEL COMMITTEE (Chairman DiCarlo, Legislators LoBue & Oliverio)

Chairwoman Conklin recognized Legislator DiCarlo, Chairman of the Personnel Committee. On behalf of the members of the Committee, Legislators LoBue and Oliverio, Legislator DiCarlo moved the following Item #13:

Legislator Oliverio stated that this money should be restored to the Sheriff's Department line. He stated that the Sheriff made a strong case to have that position in his department. He stated that the Sheriff has relied upon this position for years. Legislator Oliverio believes that outside influences caused the removal of the position. He stated that the Board should defeat this and reinstate this position to the Sheriff's budget. He stated that we have not removed positions from other departments.

Legislator Othmer stated that he is looking at this solely through the eyes of New York State County Law and in his opinion there are not extraneous circumstances that will affect his vote whatsoever.

Legislator Gross stated that looking at this from a financial position; we have a Sheriff's Department and a Law Department. He suggested that we look at what we need.

Legislator Oliverio stated that this is an advisory position it is not a legal counsel.

Legislator Albano asked what is necessary. He stated that he would rather see the money in subcontingency. He stated that the Law Department does not see a need.

**Legislator DiCarlo moved the following Item #14:** 

Legislator Oliverio stated he would rather create a Deputy Commissioner position. He stated that he would like to strike this Regional Grant Coordinator position and the Fiscal Manager position and create an \$80,000 per year Deputy Commissioner position.

Legislator Birmingham asked Personnel Director Eldridge if he had the job description available for the Deputy Commissioner of Planning.

Director Eldridge stated that he did not for the Deputy Commissioner but he did for the others mentioned.

Legislator LoBue stated that she cautions her colleagues because there were 15 positions put into the budget that with the benefits comes to over \$1 million. She stated that once we create these positions we have them for life. She stated that the biggest issue is that we have the Commissioner of Planning and the Director of Real Property vacant as of right now. She stated that she is very leery of creating positions under those managerial positions until those managerial positions are filled. She stated that once those positions are filled we can ask them for their recommendations. She stated that she thought what was desperately needed was a Fiscal Manager.

Legislator Oliverio stated that he has looked at Planning and has spoken with Former Planning Commissioner Lynch and believes that the department needs a Transportation Operations Manager and a Deputy Commissioner.

Legislator LoBue stated she is not sure if she agrees with the addition of a Deputy Commissioner. She stated in her conversations with Former Commissioner Lynch is that a Fiscal Manager is necessary because of the amount of required paperwork. She further stated that she is not comfortable with the Transportation Operations Manager and the decision still at-hand with the bus company. She believes it should be straightened out next year. She reiterated her previous statement questioning how we can be creating positions under a managerial position that is not even filled.

Legislator Gross stated that he agrees with Legislator Oliverio that duties in Planning should be consolidated. He stated the Planning Department needs help. He stated he supports Legislator Oliverio's suggestion.

Legislator Tamagna stated that in his conversations with Former Commissioner Lynch there is a need for a Fiscal Manager.

**Legislator DiCarlo moved the following Item #15:** 

Legislator Oliverio stated that he met with Director of Information Technology Tom Lannon and the duties of this position are far greater than just answering phones. He stated that he supports this after that meeting.

Legislator Tamagna stated that he agrees with Legislator Oliverio. He further stated that it is wise to keep already trained people for support.

Legislator Birmingham stated that we did receive correspondence from Director Lannon and Legislator Birmingham believes that the title should be changed because receptionist is only a small portion of what this individual would be doing. He asked Director Eldridge what this could be changed to.

Director Eldridge stated that this person came off a list for Receptionist and they have tremendous capabilities. He can look at it but this is relatively low pay for a union contract.

Legislator Birmingham stated that there could be a desk audit next year and an increase in salary because they are doing more than a receptionist's duties. He encouraged the County to have the title fit the duties.

Legislator LoBue stated that she is concerned that since this receptionist has been given additional duties already that next year that department will come back and ask for a receptionist. She believes we should keep this position but without benefits.

Legislator DiCarlo stated that he was not here for when the phone system was changed over but the other system he believes was \$700,000 and now it is about \$300,000; a \$400,000 savings. He stated that the County can create any salaried line we want if it is a managerial position.

Director Eldridge stated that is correct, if it is managerial but receptionist positions are union.

Legislator DiCarlo stated that this individual manages the phone systems so why can they not be managerial.

Director Eldridge stated that is not possible.

Legislator Birmingham stated that it seems there is a need for not only a receptionist. He stated that if we make this a management position we do not have to worry about desk audits and step salary increases.

Director Lannon stated that this receptionist has been trained to be the ambassador of the County when people call in but that duty did not take up all of her time during the day so they gave her additional duties. He stated that she is also the receptionist for the Bureau of Emergency Services and she is in charge of web coordination.

Legislator Othmer stated that if someone has additional skills we should utilize and award them. He stated that we have a motivated person that can move ahead in this position.

Legislator Tamagna stated that he believes the Legislature is overthinking this.
