WHEREAS, the key elements of the Plan include the identification of existing vegetation and subsequent removal of vegetation considered undesirable, such as noxious, invasive and poisonous plants, and the selection and replacement of such undesirable vegetation with preferred native plants;

and permanent boat stanchion areas and lake access points; and

WHEREAS, the proposed action is subject to review under the State Environmental Quality Review Act and the Regulations promulgated thereunder (6 NYCRR Part 617); and

WHEREAS, all potential involved and/or interested parties have been identified in regards to the proposed action; and

WHEREAS, the Putnam County Legislature ('Legislature'') intends to act as Lead Agency under the procedures and requirements of SEQRA; and

WHEREAS, a full Environmental Assessment Form ("EAF") has been prepared for the proposed action; and

WHEREAS, the Legislature, after review of the proposed action and the criteria set forth in 6 NYCRR Part 617, has identified the proposed action as a Type I action; now therefore be it

RESOLVED, that the Legislature declares itself Lead Agency for purposes of SEQRA; and be it further

RESOLVED, that the Legislature shall conduct a coordinated SEQRA review for the proposed action and shall serve all involved and/or interested parties with the attached Notice of Intent to Act as Lead Agency and full Environmental Assessment Form for SEQRA review; and be it further

RESOLVED, that this Resolution shall take effect immediately.

WHEREAS, as the \$129,486.00 grant was included in Putnam County's 2015 Budget; now therefore be it

RESOLVED, the Putnam County Legislature accepts the \$127,915.00 grant awarded under the 2014-2015 Public Services Answering Point (PSAP) Operations Grant; and be it further

RESOLVED, that the Commissioner of Finance prepare a Budgetary Amendment for adoption in 2015, reducing the grant amount continued in the 2015 budget by \$1,571.00.

Chairman Albano recognized Legislator Scuccimarra, Chairwoman of the Economic Development & Energy Committee. The County Executive requested that she and Senator Gillibrand be added to the resolve clause in support of this bill.

Chairman Albano stated that this memorialization is important because unfortunately there are many things that are of benefit to New York City which have a negative effect to the residents of Putnam County. He stated that a handful of people cannot make up for millions.

RESOLUTION #315

APPROVAL/ MEMORIALIZATION/IN SUPPORT OF AMENDMENT LIMITING IMPLEMENTATION AND ENFORCEMENT OF NEW CAPACITY ZONE IN HUDSON VALLEY

WHEREAS, the Federal Energy Regulatory Commission recently enacted regulations for a New Capacity Zone for Hudson Valley electric rates; and

WHEREAS, these new regulations have caused Hudson Valley businesses and residential taxpayers' electric bills to rise sharply; and

WHEREAS, these increased rates falls heavily on the residents of Putnam County; and

WHEREAS, Congressmen Maloney and Gibson, representing New York's Hudson Valley, have proposed an amendment to the Fiscal Year 2015 Energy and Water Appropriations Bill which would prohibit funds from enforcing the new capacity zone; and

WHEREAS, this Bill with the amendment passed the House of Representatives and is now awaiting U.S. Senate action; and

WHEREAS, Senator Schumer is sponsoring the amendment in the U.S. Senate; now therefore be it

RESOLVED, that the Putnam County Legislature and the Putnam County Executive requests Senator Charles Schumer and Senator Kirsten Gillibrand to use their best efforts and prestige to see that this amendment is also passed by the U.S. Senate.

Legislator Oliverio questioned if this was a logistic concern where they want representation from every town. He believed that the Alternative member from Putnam Valley would be appointed and was concerned that he was not.

Legislator Scuccimarra stated that she too had concerns. She stated that she was told that the IDA Board wanted representatives from each town. However, she did not believe this was in their by-laws.

Legislator Oliverio made a motion to table this item back to Committee; seconded by Chairman Albano.

Legislator Nacerino stated that she preferred not to table this resolution. She stated that she supported Mr. Ruchala's philosophy to have representation from each town.

Legislator Scuccimarra stated that there is another vacancy that would be coming up, therefore, we could approve these two members at this time.

Legislator Oliverio stated that he wanted it entered into the minutes that discussion will continue upon that vacancy and the gentleman from Putnam Valley could be brought forward.

Legislator Scuccimarra agreed.

Legislator Oliverio withdrew the motion to table; seconded by Chairman Albano.

Legislator LoBue stated that as far as process, she believed that it was the right thing to do as these appointments were approved in Committee, and the Chairman of the IDA probably informed these members that they would be appointed.

Legislator Nacerino concurred. She didn't think we should underscore the position as Chairman of the IDA when he has represented the opinion of his Board.

 - (1) A license/permit bond in the amount of \$25,000.
 - (2) Workers' compensation insurance for all employees.
 - (3) General liability insurance of at least \$1,000,000 per occurrence and \$2,000,000 in the aggregate.
- B. All insurance policies shall contain a provision of continued liability and name Putnam County as an additional insured and certificate holder.
- C. All bonds shall contain a provision identifying Putnam County as an obligee. Notwithstanding the foregoing, any payment issued on behalf of a claim for an aggrieved individual or company, shall be paid directly to said individual or company by the bond company.
- D. Any licensed or certified contractor who has completed the appropriate "no employee" affidavit (Form CE 200) and is found in violation of the workers' compensation waiver shall be subjected to a civil penalty as provided for in this chapter.

Legislator LoBue moved to table this item; seconded by Legislator Nacerino.

Legislator LoBue stated that we received a lot of information from the public asking to be heard and therefore she would like this to be tabled back to the Rules Committee to allow them to be heard.

Legislator Nacerino applauded Legislator Scuccimarra for her efforts on this and believes that this is a very worthy issue brought forth. However, the Legislature has received a lot of feedback through emails and she believed that it was important for us to follow the democratic process and give these individuals the opportunity to speak and vet this issue.

Legislator Oliverio stated that he cautions the Legislature that 90% of the concerns were business related which he believes is profit motive speaking above the health and safety. This makes him very leery. He stated that he won't be here to take part in the debate, however, he asked his colleagues to be cautious. He believed that this was a great initiative. We were not asking the private industry to take part in it. We were just going to ban polystyrene within our County government buildings. The amount of outrage against this surprised him. He stated to be weary of those who protest too much.

Legislator Nacerino concurred. She stated that she wholeheartedly supported this

initiative, however, she believed we should do our due diligence and give the people the opportunity to speak and address this issue.

Legislator Scuccimarra stated that the Legislature has been talking about this issue since last March. There is a lobbyist for the plastic bag industry that came before the Committee at the 11th hour. She believed that we were doing Putnam County residents a disservice by not passing this right away.

Legislator Nacerino stated that the resolution would not be effective until June 1, 2015.

Legislator Tartaro agreed with both Legislators Oliverio and Scuccimarra. What disturbed him about this was that when the gentlemen spoke at the Committee meeting, he was stressing the fact that this material was recyclable. He stated that perhaps it is, however, Kent Recycling deals with a large company that refuses to accept this material. He believed that there was a fair amount of this material ending up in the garbage. He stated that if the concern of the industry is in fact that they want to provide a product and service; he believed it was their responsibility to make the recycling of this material available.

Legislator Gross stated that supposedly the product is recyclable, however, we do not have the ability to recycle it now. He stated that he spoke to a facility in Connecticut that spent \$5 million dollars on a machine that accepts comingled recycling products, except newspapers, and the machine would separate all the products. He stated that the technology is coming. However, at this point he would support the resolution. He stated that we received a lot of correspondence and would like to give the people the opportunity to voice their concerns.

Chairman Albano stated that he supports this resolution. However, he did not have a problem with tabling back to Committee. He stated that the effective date is June 2015, therefore, whether it is approved now or in January, the end result would be the same.

Chairman Albano called for a vote on the motion to table.

BOND RESOLUTION OF THE COUNTY OF PUTNAM, NEW YORK, ADOPTED DECEMBER 2, 2014, AUTHORIZING THE CONSTRUCTION OF IMPROVEMENTS TO PEEKSKILL HOLLOW ROAD AND BRIDGE; STATING THE ESTIMATED TOTAL COST THEREOF IS \$9,515,950; APPROPRIATING SAID AMOUNT THEREFOR, INCLUDING THE EXPENDITUE OF APPROXIMATELY \$6,799,674 IN GRANT FUNDS EXPECTED TO BE RECEIVED; THE EXPENDITURE OF \$5,000 IN COUNTY FUNDS ON-HAND AND AVAILABLE THEREFORE; AND AUTHORIZING THE ISSUANCE OF \$2,251,276 SERIAL BONDS OF SAID COUNTY (IN ADDITION TO THE \$460,000 HERETOFORE ISSUED PURSUANT TO A BOND RESOLUTION ADOPTED ON APRIL 3, 2013) TO FINANCE THE BALANCE OF SAID APPROPRIATION.

THE COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Legislature) AS FOLLOWS:

Section 1. The County of Putnam, New York (herein called "County"), is hereby authorized to construct improvements to Peekskill Hollow Road and bridge. The estimated total cost thereof, including preliminary costs and costs incidental thereto and to the financing thereof, is \$9,515,950, and said amount is hereby appropriated therefor, including the expenditure of (i) approximately \$6,799,674 in anticipated State and Federal grant funds and (ii) \$5,000 County funds on-hand and available therefore. The plan of financing, includes the expenditure of said grant and County funds and the issuance of \$2,251,276 serial bonds of the County to finance the balance of said appropriation, and the levy and collection of taxes on all the taxable real property in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable. The County has heretofore issued \$460,000 serial bonds for such purposes pursuant to a bond resolution adopted by the County Legislature on April 3, 2013.

Section 2. Bonds of the County in the principal amount of \$2,251,276 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance a portion of said appropriation.

Section 3. The period of probable usefulness of the object or purpose for which said bonds are authorized to be issued, within the limitations of Section 11.00 a. 91 of the Law, is fifteen (15) years.

Section 4. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the County for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the County, payable as to both principal and interest by general tax upon all the taxable real property within the County. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds having substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and Sections 50.00, 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the County Legislature relative to authorizing bond anticipation notes, or the renewals thereof, and relative to providing for substantially level or declining annual debt service, and prescribing the terms, form and contents, and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, as well as to executing agreements for credit enhancements, are hereby delegated to the Commissioner of Finance, the chief fiscal officer of the County.

Section 7. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

(a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or

(b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 8. This bond resolution shall take effect upon the approval of the Putnam County Executive, and the Clerk of the County Legislature is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in "*The Putnam County Courier*," "*The Putnam Press*," and "*The Putnam County News & Recorder*," three newspapers, each having a general circulation in the County and hereby designated as the official newspapers of the County for such publications.
