The meeting was called to order at 7:00 P.M. by Chairman Albano who requested Legislator Wright lead in the Pledge of Allegiance. Upon roll call, Legislators Scuccimarra, Oliverio, Tartaro, Nacerino, Gross, Castellano, LoBue, Wright and Chairman Albano were present. Also present was Legislative Counsel Van Ross.

Chairman Albano recognized Legislator Gross who presented the "PreTrial, Probation, Parole Supervision Week" proclamation to Probation Officer Charlene Effinger from the Probation Department.

RECOGNIZING PRETRIAL, PROBATION, PAROLE SUPERVISION WEEK July 13-19, 2014

WHEREAS, Pretrial, Probation, and Parole Officers are all intricate and crucial professionals of the community corrections team; and

WHEREAS, community corrections is an essential part of the justice system; and WHEREAS, community corrections professionals uphold the law with dignity, while recognizing the right of the public to be safe-guarded from criminal activity and are responsible for supervising adult and juvenile offenders in the community; and

WHEREAS, various different agencies are involved in granting the required approval for this project; and

WHEREAS, Putnam County has been requested to forward to each agency a copy of the moratorium resolution; and

WHEREAS, the Health, Social, Educational & Environmental Committee has considered and approved of this request; now therefore be it

RESOLVED, that the Clerk of the Putnam County Legislature send a copy of Resolution #104 of 2014 to each of the agencies contained in the attached list marked Exhibit "A" and request that no permit be issued until the measures called for in the resolution are fully executed.

PHYSICAL SERVICES COMMITTEE (Chairman Albano, Legislators Nacerino & Scuccimarra)

Item #5d – Approval/Bond Resolution/Putnam Bikeway II Phase B – PIN 8761.05 was next. On behalf of the members of the Physical Services Committee, Legislators Nacerino and Scuccimarra, Chairman Albano moved the following:

Legislator Oliverio stated that, as he mentioned several times, he is concerned about the bonding. He stated that he supports the bikeway project and wants it to continue, however, instead of bonding he asked his colleagues to consider paying "cash" for this through the fund balance. He stated that by paying cash we would not be putting future generations and ourselves in debt for 20 years.

Legislator LoBue stated that she has also spoken out in the past about the amount of bonding being done by the County. She stated that the other issue she had was that the County did not have a maintenance agreement going forward with the bikeway. She stated that we keep extending the bikeway, however, we are not quite sure how we are going to pay for the maintenance.

Chairman Albano believed that the County was in good shape with respect to bonding based on reports by Commissioner of Finance Carlin. He believed that we should keep the fund balance available for any unexpected issues that could arise.

Legislator Gross stated that he supports the bikepath. However, he believed that the County was at a crossroads with pending litigation and we need to assess our fund balance and bonding down the line. He stated that currently the County's bonding rating is good, however he stated that he was concerned about pending litigation.

Legislator Nacerino stated that she supported the bikepath and the bonding. She stated that Legislator LoBue brought up an excellent point regarding the O&M. She believed those were the problems we encountered during the discussions of placing advertising signage on the bikepath. She stated that she would like to have the O&M costs incorporated into or discussed as we move forward with this new phase of the bikeway.

Legislator Oliverio stated that he understood that the County's bonding ratio was good, however, we keep adding to the amount we are bonding. We have bonded close to \$13 million dollars in the last three years. He stated that at what point do we say the bonding needs to stop.

Legislator Tartaro stated that he has learned, as a new Legislator, that a significant portion of the County's fund balance is designated to make the school districts whole when resident's school tax bills are not paid on time. He understands that a lot of that money does come back to the County, however, he didn't exactly know what that dollar amount was. He also stated that he didn't know how much of the fund balance was accessible as a surplus cash flow. He believed that there were some restraints on the money leftover in the fund balance. He stated that he has requested through the Chair of the Audit Committee that the Legislature receive from Commissioner of Finance Carlin a report on the status of all the bonds. He stated that in a recent conversation with Commissioner Carlin, it was stated that we are not adding another \$400,000 dollars to the Bond total because older bonds would be coming off.

Legislator Scuccimarra concurred with Legislator Tartaro that we needed to take a broad look at what we have bonded and what bonds will be coming off. She stated that Legislator LoBue bought up a good point about the maintenance of our bike trails. She believed that the maintenance of bikepaths was a problem throughout the Country. She stated that this was the reason why she believed that having small advisement signs on the bikepath would help offset the maintenance costs.

Chairman Albano stated that he was very much in favor of reviewing our bonds. He stated that right now the bonds are at historically low rates. He believed that we might not have this same opportunity in the future.

Legislative Counsel Van Ross stated that the record should reflect that Resolution #42 of 2008 covers the SEQRA requirement.

Legislator Wright stated that he would be voting "no" only because we have requested a comprehensive review of the bonding issue. He believed that there would be no harm in waiting until we had that information in hand.

Legislator LoBue questioned if there was a time constraint with this bond. She questioned if it could be tabled until next month. She believed that the Legislature would be voting in the dark without knowing the amount in the general fund and the amount available.

Chairman Albano requested a roll call vote.

Chairman Albano offered the following resolution and moved its adoption:

BOND RESOLUTION OF THE COUNTY OF PUTNAM, NEW YORK, ADOPTED JULY 1, 2014, AUTHORIZING THE CONSTRUCTION OF NEW RECREATIONAL AREA IMPROVEMENTS TO THE PUTNAM BIKEWAY; STATING THE ESTIMATED TOTAL COST THEREOF IS \$4,118,589; APPROPRIATING SAID AMOUNT THEREFOR, INCLUDING THE EXPENDITUE OF APPROXIMATELY \$3,706,730 IN GRANT FUNDS EXPECTED TO BE RECEIVED; AND AUTHORIZING THE ISSUANCE OF \$411,870 SERIAL BONDS OF SAID COUNTY TO FINANCE THE BALANCE OF SAID APPROPRIATION.

THE COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Legislature) AS FOLLOWS:

Section 1. The County of Putnam, New York (herein called "County"), is hereby authorized to construct new recreational area improvements to the Putnam Bikeway. The estimated total cost thereof, including preliminary costs and costs incidental thereto and to the financing thereof, is \$4,118,589, and said amount is hereby appropriated therefor, including the expenditure of approximately \$3,706,730 in anticipated State and Federal grant funds. The plan of financing, includes the expenditure of said grant funds and the issuance of \$411,870 serial bonds of the County to finance the balance of said appropriation, and the levy and collection of taxes on all

the taxable real property in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the County in the principal amount of \$411,870 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance a portion of said appropriation.

Section 3. The period of probable usefulness of the object or purpose for which said bonds are authorized to be issued, within the limitations of Section 11.00 a. 19(a) of the Law, is twenty (20) years.

Section 4. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the County for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the County, payable as to both principal and interest by general tax upon all the taxable real property within the County. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds having substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and Sections 50.00, 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the County Legislature relative to authorizing bond anticipation notes, or the renewals thereof, and relative to providing for substantially level or declining annual debt service, and prescribing the terms, form and contents, and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, as well as to executing agreements for credit enhancements, are hereby delegated to the Commissioner of Finance, the chief fiscal officer of the County.

Section 7. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 8. This bond resolution shall take effect upon the approval of the Putnam County Executive, and the Clerk of the County Legislature is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in "The Putnam County Courier," "The Putnam Press," and "The Putnam County News & Recorder," three newspapers, each having a general circulation in the County and hereby designated as the official newspapers of the County for such publications.

Item #5g – Approval/Memorialization/Opposing Clean Water Act Regulation Proposed by the Environmental Protection Agency and Army Corps of Engineers was next. On behalf of the members of the Physical Services Committee, Legislators Nacerino and Scuccimarra, Chairman Albano moved the following:

Legislator Oliverio requested that this item be tabled to Physical for further discussion. He believed that the regulations were not as onerous as this memorialization makes them out to be. He requested that we ask the Department of Health to provide their input on this memorialization.

Chairman Albano stated that he has spoken to individuals that would be involved in this such as those in building and planning departments. These individuals had the opinion that we are getting to the point of having so many regulations in place that stops everything.

Legislator Oliverio made a motion to Table this item; seconded by Legislator LoBue.

Legislator LoBue concurred with Legislator Oliverio. She stated that it is a memorialization and believed that it would not hurt to put this off for another month to receive input from our Health Department.

Legislator Wright stated that he opposed tabling on the basis that it is only a memorialization resolution, and as such, he did not think County Departments, Legislators or Legislative personnel should spend any further time on this.

Legislator LoBue stated that in the past, this Legislative body has gotten in trouble because we pushed forward a memorialization regarding the New York Safe Act before giving the public the opportunity to voice their opinion. She stated another issue was a memorialization against Indian Point. She stated that with respect to these two issues, she did not believe that tabling this item for further input would be a problem.

Legislator Nacerino stated that she supported Legislators Oliverio and LoBue. She believed that, as Legislators, we needed to do our due diligence and understand what we are supporting.

Legislator Wright stated that it has been well summed up and therein lies the problem with these memorializing resolutions in general. He did not believe they were a good use of Legislative time as Legislator LoBue refers that it has gotten this Legislature into some past troubles. He did not believe these entities needed our seasoned input spent over months and months; dragging in Departments to give opinions about things that we are not going to be able to affect a result on other than to express an opinion. He believed that every Legislator could write a letter.

Chairman Albano believed that there were times when an opinion should be given. He believed that in the world today there was a lot of over regulation.

Legislator Scuccimarra stated that she did not have a problem tabling this item. However, she did believe that we were totally overregulating as far as our water is concerned, especially on this side of the County. She stated that she disagreed with Legislator Wright and believed that by sending these memorialization resolutions to the different entities was telling them how we feel.

Legislator Oliverio made a motion to table; seconded by Legislator LoBue.

APPROVAL/MEMORIALIZATION/OPPOSING CLEAN WATER ACT REGULATION PROPOSED BY THE ENVIRONMENTAL PROTECTION AGENCY AND ARMY CORPS OF ENGINEERS

WHEREAS, Putnam County affirms its commitment to environmental stewardship and the protection of our natural resources, and recognizes the need to harmonize municipal programs and services with the legislative intent and objectives of the Clean Water Act (CWA); and

WHEREAS, the CWA was not intended to protect ditches and other channels through which waters flows intermittently nor was it intended to capture seeps, wet

areas, isolated man-made ponds and other structures not currently subject to the CWA; and

WHEREAS, the Environmental Protection Agency (EPA) and the United States Army Corps of Engineers (ACOE) have developed a proposed regulation on Definition of "Waters of the United States" Under the Clean Water Act to clarify the EPA and ACOE's understanding and definition of the CWA that will inform all of EPA's regulatory programs and policy actions; and

WHEREAS, this proposed regulation creates greater uncertainty rather than clarify and would now capture a significant number of Putnam County Highway activities and transportation infrastructure that will now be subject to the CWA and its costly and time-consuming permitting and regulatory protocols; and

WHEREAS, the proposed regulation greatly expands the number of projects subject to jurisdictional determination or CWA permitting which do not currently require such oversight at great expense to the taxpayers of Putnam County with little, if any, substantive environmental benefit while diverting scarce resources from other programs that do provide environmental protection and conservation benefits; and

WHEREAS, the financial impact of the proposed regulation to Putnam County will create significant ongoing maintenance costs and delays to County citizens due to the need for jurisdictional determinations and expanded jurisdictional authority of EPA and the ACOE; and

WHEREAS, Putnam County believes that the standards for making jurisdictional determinations under the CWA and clarification or definition of the intent of the CWA should be accomplished only through the U.S. Congress, and limited by the decisions of the U.S. Supreme Court; now therefore be it

RESOLVED, that Putnam County urges EPA and the ACOE to withdraw the proposed CWA regulation immediately, work collaboratively with states and local governments to clarify federal jurisdiction under the CWA that is reasonable, environmentally responsible and respects the authority of state and local governments in ensuring the protection of our water resources; and be it further

RESOLVED, that Putnam County supports any federal legislation consistent with the above recommendations and urges it Congressional and State representatives to intercede with EPA and request that EPA report to them on their response and adaptations regarding the aforementioned concerns; and be it further

RESOLVED, that a copy of this resolution be forwarded to U.S. Senator Charles Schumer, U.S. Senator Kirsten Gillibrand, U.S. House Representative Sean Patrick Maloney, Governor Andrew Cuomo, NYS Senator Terry Gipson, NYS Senator Greg Ball, NYS Assemblywoman Sandra Galef, NYS Senator Stephen Katz, EPA Administrator Gina McCarthy and EPA Region 2 Administrator Judith Enck.

WHEREAS, negotiations with the PBA for a new and/or amended CBA took place on or about June 8, 2012, July 11, 2012, September 14, 2012, October 22, 2012, November 14, 2012, December 17, 2012, January 11, 2013, January 28, 2013 and April 11, 2013; and

WHEREAS, a final draft of an MOA, dated May 7, 2013, was agreed to by the negotiating teams for the County, the Putnam County Sheriff and the PBA, but was voted down by the PBA Membership; and

WHEREAS, a final meeting took place between the negotiating teams of the PBA, the County of Putnam and the Putnam County Sheriff on October 24, 2013, and the PBA presented a final, unacceptable offer to the County of Putnam and the Sheriff; and

WHEREAS, as a result of the parties' inability to arrive at a mutually acceptable Agreement, a Declaration of Impasse was filed by the County of Putnam, with the agreement of the Sheriff, on November 1, 2013 with the Office of Conciliation of the Public Employment Relations Board; and

WHEREAS, mediation sessions took place between the PBA, the County of Putnam and the Putnam County Sheriff with mediator, Laurie Matles, on February 19, 2014, April 4, 2014 and May 12, 2014; and

WHEREAS, comparable arbitration awards were analyzed and indicated that, on average, police units were being awarded 1.5 to 2.5% per year; and

WHEREAS, in an effort to reach an agreement, the County agreed to increase its offer for 2012 and 2013 from a 0% increase to a 1.5% increase in 2012 and a 2% increase in 2013, however, the PBA agreed that no retroactive payment would be required of the County; and

WHEREAS, in light of this compromise, the PBA, the Putnam County Sheriff and the County of Putnam ultimately came to an Agreement concerning all of the terms and conditions of the employment of its members for the years January 1, 2012 to December 31, 2016 after the aforementioned lengthy period of negotiations and mediation; and

WHEREAS, a Memorandum of Agreement ("MOA") was executed by Putnam County Executive MaryEllen Odell, by Donald B. Smith, the Putnam County Sheriff, and the attorneys for both Putnam County and the PBA, in which the specific changes to the underlying Collective Bargaining Agreement were outlined; and

WHEREAS, Governor Andrew M. Cuomo and the Legislative leaders have all pledged on numerous occasions to reduce the burden of local property taxes on businesses and homeowners, including a cap on property taxes, as a way to stimulate the State's economic recovery: and

WHEREAS, recent reforms to pension costs will generate significant savings many years from now, but counties still struggle with growing pension costs over the near term: and

WHEREAS, the provisions of the Taylor Law and the Triborough Amendment, and mandates for new employee leave benefits contribute to higher personnel costs to counties; and

WHEREAS, the Putnam County recognizes and supports recent efforts by the Governor to decrease the costs to municipalities associated with binding arbitration; and

WHEREAS, these mandated personnel cost increases directly lead to budget increases for counties, and translate to added burdens to local taxpayers who have to pay the costs of these new benefits; now therefore be it

RESOLVED, that the State's Taylor Law reforms should include:

- 1. Further reducing or eliminating the costs and use of interest/binding arbitration:
- 2. An arbitration panel shall consider an employer's ability to pay when making award determinations and in no event shall an award cause the municipality to exceed, or further exceed, the 2% tax cap;
- 3. Providing for effective remedies when public employers and unions are found to have refused to negotiate a collective bargaining agreement in good faith;

Item #5r – Approval/Amend the Salaries of Captains in the Putnam County Sheriff's Department Division of Law Enforcement was next. On behalf of the members of the Audit & Administration Committee, Legislators Nacerino and Tartaro, Legislator Castellano moved the following:

Legislator Castellano stated that this came into play because of the recent PBA Agreement in the Sheriff's Department and the disparity of the salaries for the employees in charge who are not part of that bargaining agreement.

Legislator Nacerino stated that we needed to lessen the gap between the union employees and the Captains and Lieutenants. She believed that if this is not done we would be targeting our own growth in the County. Officers will no longer seek these non-union management positions in the Sheriff's Department. She stated that she supported this increase.

Legislator Gross concurred with Legislator Nacerino. He stated that it corrects the inequity that has been going on for quite some time. Some management positions are at a lower salary than the union employees that work under them. This puts that back into perspective. He stated that management employees have more responsibilities and are not paid overtime or receive other union benefits. He stated that this is a problem with not only law enforcement, but also other departments within the County which will be addressed.

Chairman Albano agreed and stated that he also supported this. He stated that it was important at budget time that Department Heads point out where these salary inequities

are occurring. He stated that if the Legislature knows where these inequities exist, then with the Department Heads input, we can address them where they are most appropriate.

RESOLUTION #177

APPROVAL/RESOLUTION TO AMEND THE SALARIES OF CAPTAINS IN THE PUTNAM COUNTY SHERIFF'S DEPARTMENT DIVISION OF LAW ENFORCEMENT

WHEREAS, the Personnel Committee of the Putnam County Legislature considered the approval of the Memorandum of Agreement entered into by the County of Putnam and the Putnam County Sheriff with the Putnam County Police Benevolent Association on June 17, 2014; and

WHEREAS, the MOA was fully ratified at a meeting of the Full Legislature on July 1, 2014; and

WHEREAS, said MOA provides for increases to the base salary of every employee included in the PBA Membership as follows:

Effective January 1, 2012: 1.5% increase to the salary schedule, with no retroactive payment;

Effective January 1, 2013: 2.0% increase to the salary schedule, with no retroactive payment;

Effective January 1, 2014: 2.0% increase to the salary schedule, plus a \$1,000.00 one-time bonus payment

Effective January 1, 2015: 2.0% increase to the salary schedule, plus a \$1,000.00 one-time bonus payment

Effective January 1, 2016: 2.75% increase to the salary schedule; and WHEREAS, there have been no commensurate salary increases for the Captains who manage and supervise the individuals holding the positions included in the PBA Membership; and

WHEREAS, it is the intent of Putnam County to avoid inequities in pay scales and to recognize the fact that the individuals in said positions would have received the increases included in the PBA collective bargaining agreement had they not taken the promotions which led them to their current positions; and

WHEREAS, such promotions resulted in those affected individuals taking on greater responsibilities without a corresponding increase in salary; and

WHEREAS, Putnam County intends to insure that the base salaries of individuals holding the position of Captain cannot be surpassed by those of individuals serving in subordinate positions; now therefore be it

RESOLVED, that the base salary of individuals whose title is "Captain" shall be increased in each of the years covered by the aforementioned MOA such that they remain at least fifteen percent (15%) higher than the base salary of the highest paid individual holding the position of 1st Sergeant at all times; the base salary of 1st Sergeant being defined as the salary contained in the PBA Contract salary schedule Grade 52 Step 1 (said salary equaling \$ 100,838 in 2014); and be it further

RESOLVED, that an additional stipend of \$6262.00 shall be added to the base salary of the position of Criminal Justice Captain as compensation for additional special duties rendered to the County and Sheriff in the following capacities: as a duly licensed attorney at law rendering legal services for the County and Sheriff, as the Sheriff's Office Records Access Officer designated under the County Code, and as the Sheriff's designated representative in collective bargaining and labor management processes, and that said additional stipend shall be paid only so long as the holder of the position of

Criminal Justice Captain shall be a duly licensed attorney at law and shall continue to perform such special duties; and be it further

RESOLVED, that the annual salaries, effective July 1, 2014, for the "Captain" titled positions pursuant to this Resolution will be

RESOLVED, that the County Executive is hereby authorized to enter into contracts and/or agreements on behalf of the County with one or more credit card issuers or financing agencies for the purpose of collecting such payments, including provisions requiring the card holder to pay any and all service, "convenience" or transaction fee charges in connection with the credit card payment, in accordance with Sections 5 and 5-b of the General Municipal Law in form and substance as may be approved by the County Attorney.

WHEREAS, Putnam County is desirous of continuing to occupy the American Legion and use the American Legion for the above stated purposes; and

WHEREAS, Putnam County is desirous of renewing the Lease with American Legion Post #275 for an additional two-year period; and

WHEREAS, the County Executive, with the advice and assistance of the County Attorney, has entered into preliminary discussions and negotiations with American Legion Post #275 for the renewal of the Lease for an additional two-year period, all other terms and conditions to remain the same; and

WHEREAS, pursuant to New York State County Law Section 215, the County Executive requests that the Putnam County Legislature authorize the renewal of the Lease; now therefore be it

RESOLVED, that Putnam County may renew the Lease with American Legion Post #275 for American Legion; and be it further

RESOLVED, that the County Executive, with the advice and assistance of the County Attorney, is authorized to finalize and execute the renewal of the Lease for an additional two-year period, all other terms and conditions to remain the same as on the current Lease, which renewal Lease shall be in substantial conformance with the form attached hereto as "Schedule A"; and be it further

RESOLVED, that this Resolution shall take effect immediately.

In Paragraph E, Subsection 20 provides that the Legislature is permitted, and he would suggest encouraged, to give such guidance and direction. He stated that apparently an examination of recent, if not all, records in the last ten years disposes that this Legislature has not made any such recommendations to the County Executive in connection with the budget review process. He requested that the Budget & Finance Committee meet at least once before the issue of what additional new items we might want to include in the review process is too late to be acted upon.

Item #7 - Recognition of Public

Undersheriff Convery stated that on behalf of Sheriff Smith he wanted to thank the Legislature for resolving the salary inequities of our career professionals and managers in the Sheriff's Department.

Item #8 - Recognition of Legislators

Legislator Scuccimarra stated that summer is here and although during the holidays we are very generous to our food pantries, the summer months are a very hard time for them. She asked that everyone please remember to donate to them. She stated that a little donation goes a long way.

Legislator Oliverio stated that he wished everyone a Happy 4th of July. He stated that there are many activities taking place in the County, including the Putnam County Fair, and wished everyone to stay safe.

Chairman Albano stated that we have an exciting weekend coming up and hope that a lot of people get to visit the Tilly Foster Farm Fair.

Legislator Gross wished everyone a wonderful 4th of July. He stated that there are many activities taking place; Tilly Foster Farm Fair through the weekend and also the Town of Southeast will have their firework display in the Home Depot area.

Chairman Albano stated that because of these activities taking place, there will be different traffic patterns in this area and asked everyone to be prepared and take this into consideration when they are traveling.

Legislator LoBue wished everyone a healthy and happy summer season. She mentioned that the Red Mills Historic District Committee will host an Independence Day concert on July 4th at Red Mills Historic Park which will begin at 7:30 pm.

Reporter for the Putnam County Courier, Eric Gross, requested that the meeting be closed in memory of three long time fire service members in Putnam County.

Legislator LoBue stated that she would like to close the meeting in memory of Chris Kristensen who was a 40 year member of the Mahopac Falls Fire Department; and Jena Nolan, the 14 year old young lady who drowned in Lake Mahopac. She stated that our hearts and prayers go out to their families.

Mr. Eric Gross stated that there were also two gentlemen from the Carmel Fire Department that passed away in the last week; John Duane who was head of the Fire Police for many years and the former Chief Thomas Boyce.

There being no further business, at 7:48 P.M., Chairman Albano made a motion to adjourn; seconded by Legislator Oliverio. All in favor.
