# NATIONAL PROBLEM GAMBLING AWARENESS MONTH MARCH 2014

WHEREAS, Problem Gambling is a public health issue affecting millions of Americans of all ages, races, and ethnic backgrounds in all communities and which has a significant societal and economic cost; and

WHEREAS, Problem Gambling is treatable and treatment is effective in minimizing the harm to both individuals and society as a whole; and

WHEREAS, numerous individuals, professionals, and organizations have dedicated their efforts to the education of the public about Problem Gambling and the availability and effectiveness of treatment: and

WHEREAS, the promotion of National Problem Gambling Awareness Month provides individuals in the Problem Gambling community an opportunity to educate the public and policymakers about the social and financial effectiveness of services available for Problem Gambling; and

WHEREAS, the National Council on Alcoholism and Other Drug Dependencies invite all residents of Putnam County to participate in National Problem Gambling Awareness Month; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby proclaim March 2014 as National Problem Gambling Awareness Month in Putnam County and encourage all citizens to support the theme of "Help and Hope" for problem gamblers by supporting the men, women, and youth who are in treatment and recovery and their families.

NATIONAL INHALANT AND POISONS PREVENTION WEEK - MARCH 16 - 22, 2014

WHEREAS, in 1961, Congress designated the third full week in March to be National Poison Prevention Week and since then this week has helped to raise national awareness of the dangers of potentially poisonous medicines, household chemicals, and other substances; and

WHEREAS, each year, the Nation's poison centers answer more than 4 million calls; and

WHEREAS, approximately 90% of poisonings occur in people's homes and over 50% of poisoning exposures involve children under age 6; and

WHEREAS, 6.8% of student's grades 8-12 in Putnam County have used inhalants to get high in their lifetime, 2.1% of student's grades 8-12 have used inhalants to get high one or more times in the past 30 days (per the 2012 Putnam County Communities That Care Coalition Prevention Needs Assessment Survey); and

WHEREAS, the Putnam County Communities That Care Coalition will support prevention efforts and activities to highlight Putnam County, New York's commitment to protecting its residents from potentially harmful poisonings; and

WHEREAS, the people of Putnam County recognize the importance of coming together as a community to educate ourselves on poison prevention and pledge our commitment to ensuring the safety of ourselves, our families, and our community; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby proclaim

March 16 –22nd, 2014 as National Inhalant and Poison Prevention Week in Putnam County and encourage all citizens to join in this observance.

Chairman Albano stated that the next proclamation was for Edward Irving Sumber who is a 40 year resident of Putnam County. He is a tremendous asset to this town and is a community leader. Chairman Albano requested that County Executive Odell present this proclamation.

County Executive Odell stated that Mr. Sumber was a man whom she has known since she was thirteen years old. She stated that the Sumbers and the Hicks families have been there for each other for many, many years. She stated that it was truly an honor to not only be here as the County Executive, but as a representative of the Hicks family. County Executive Odell invited the members of the Rotary and some of Mr. Sumber's colleagues to come up and participate in the proclamation and say thank you to a man who has given so selflessly of himself.

# HONOREE OF THE CARMEL ROTARY SHOOT OUT EDWARD IRVING SUMBER

WHEREAS, EDWARD IRVING SUMBER, son of Herman and Rose Sumber, was born in Brooklyn, New York, on December 21, 1942. Edward's life was changed radically when he contracted polio in 1949, two years before Jonas Salk would develop his vaccine. Edward spent 1949-1950 in a hospital which offered the Sister Kenny treatment followed by a six month convalescence at St. Agnes Convalescent Home in White Plains. Edward believes that his time in St. Agnes truly opened him up to the acceptance of differences and changed the way he viewed the world; and

WHEREAS, EDWARD IRVING SUMBER, graduated from Wingate High School in Brooklyn in 1960 and then from Brooklyn College with a Bachelor's

Degree in Accounting in 1964. Edward then attended Brooklyn Law School at night and graduated with honors and as Senior Editor of the Law Review in 1969, after which he became a certified accountant and passed the Bar Exam. Edward then founded a stock brokerage firm and became an underwriter; and

WHEREAS, EDWARD IRVING SUMBER, in 1973, relocated with his lovely wife Ada from Forest Hills to Carmel, where he became a law partner at Stockfield, Fixler & Sumber. Edward and Ada are the proud parents of three beautiful children whom were all raised in Carmel. In, 1976 Edward established his own law firm focusing on corporate, tax, and probate law, estate planning, and commercial real estate transactions; and

WHEREAS, EDWARD IRVING SUMBER, joined The Carmel Rotary in 1974 and celebrates his 40<sup>th</sup> Anniversary as a Rotarian in 2014. Edward took on any task that was assigned to him and fully appreciated the Rotary's ambitions of embracing all people to make the world a better place. Edward has held various roles within the Rotary including but not limited to, Club Secretary, Vice-President, Bulletin Editor, and Installation Dinner Chairman. Edward also participated in various other community groups including, Boy Scouts of America, was the Past President of the Putnam County Bar Association, Past Chairman of the Grievance Committee for the Ninth Judicial District, Past President of the Hebrew Congregation in Northern Westchester and Putnam, as co-founder, director, and officer of the first hospice formed in the region, Trustee of Mahopac's Temple Beth Shalom, and counsel to the Boards of Realtors in Westchester and Putnam. Edward also teaches brokerage law and has written over three hundred articles in various publications. Edward also serves as Chairman of the Judicial Election Oversight Committee of the Westchester County Bar Association, serves as Law Guardian in Family Court, is the Director of the Putnam Alliance, and was a founder, director, and first Chairman for four years of the Putnam County Economic Development Corporation; and

WHEREAS, EDWARD IRVING SUMBER, has a profound fondness and love for Putnam County and The Carmel Rotary and expresses these sentiments in every aspect of his family and community life; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby congratulate EDWARD IRVING SUMBER for his many years of service to the community and on being selected as the 2014 Honoree of The Carmel Rotary Shoot Out which is dedicated to eradicating polio.

Legislator Oliverio stated that the State of New York is stating that they would like to establish Regional Centers of Excellence for those individuals suffering from mental illness. He stated that the fear expressed by our Commissioner of Social Services is that these Regional Centers of Excellence may not be able to handle all the needs within each

of the counties. Legislator Oliverio stated that the memorialization is urging the State to consider very carefully the impact of reduced state inpatient psychiatric beds and to know exactly what services are needed in each community before agreeing to state that the "Regional Centers of Excellence" will address those needs.

# APPROVAL/MEMORIALIZATION/ PROPOSED MAJOR REDESIGN/REGIONAL CENTERS OF EXCELLENCE

WHEREAS, the New York State Office of Mental Health (OMH) has proposed a major redesign of the agency under a "Regional Centers of Excellence" (RCE) model and has divided the state into five distinct regions (Western, Central, Hudson River, New York City and Long Island) with fifteen RCE; and

WHEREAS, the OMH Plan calls for the implementation of "Regional Centers of Excellence" that will enhance community resources; and

WHEREAS, the OMH Plan designates the reduction of state operated inpatient beds; and

WHEREAS, in addition to the reduction of state operated inpatient beds, the Hudson River region has already seen a reduction in community based hospital psychiatric beds; and

WHEREAS, the reduction of inpatient psychiatric beds results in more persons with mental illness being treated in the community when previously their symptoms could be better managed in an inpatient setting; and

WHEREAS, there does not exist community based housing with the level of supportive services that can safely manage persons with mental illness in the community; and

WHEREAS, as a result of this, more persons than ever before with mental illness are presented to the Putnam County Department of Social Services as homeless; and

WHEREAS, as has been stated in other areas around the state, the local correctional facilities have become the "largest mental health providers" in each respective county; and

WHEREAS, in the past, closures of state hospitals have brought the unfulfilled promise of enhanced community services; and

WHEREAS, even with the closure of Harlem Valley Psychiatric Center and the Hudson River Psychiatric Center, the outpatient services provided by the New York State psychiatric hospitals to Putnam County have continually diminished; and

WHEREAS, the impact on the community of fewer inpatient psychiatric beds is evidenced by the increased number of law enforcement contact with people with mental illness and a constant and continual increase in the number of 9:45 orders needed to have people psychiatrically evaluated for their own safety and for the safety of the community; now therefore be it

RESOLVED, that the Putnam County Legislature urge Governor Andrew M. Cuomo and the Commissioner of Mental Health, the New York State Senate and Assembly to consider very carefully the impact of reduced state inpatient psychiatric beds and to know exactly what services are needed in each community before agreeing to state that the "Regional Centers of Excellence" will address those needs, and to ensure that the State of New York does not abdicate its responsibility as a provider of mental health services in the community; and be it further

RESOLVED, that certified copies of this resolution be sent to the Commissioner of Mental Health, Governor Andrew M. Cuomo, Senator Greg Ball, Senator Terry Gipson,

Assemblyman Steve Katz, Assemblywoman Sandra Galef, Senate Majority Leader Dean Skelos, Assembly Speaker Sheldon Silver and the New York State Association of Counties (NYSAC).

Legislator Oliverio stated that Legislator Scuccimarra brought this issue forward.

Legislator Scuccimarra stated the Assemblywoman Galef co-sponsored this bill in the New York State Assembly. It prohibits the use of polystyrene (Styrofoam) products in municipalities in relation to food service. Legislator Scuccimarra stated that the use and disposal of polystyrene causes adverse environmental and health effects. Styrofoam is the 5<sup>th</sup> largest source of hazardous waste in the United States. She stated that sources say that Styrofoam lasts for 500 years in the environment and is the main pollutant of our water sources and primary source of litter. She stated that toxic chemicals also leach out of the Styrofoam when it is heated.

WHEREAS, Styrofoam is a notorious pollutant that is very difficult to recycle due to its light weight and low scrap value; and

WHEREAS, the material takes up considerable space in landfills and takes a very long time to fully decompose; and

WHEREAS, this material can have a serious impact on human health, wildlife and the aquatic environment; and

WHEREAS, the Health, Social, Educational & Environmental Committee of the Putnam County Legislature has considered and approved the memorialization of this State Legislation, now therefore be it

RESOLVED, that the Putnam County Legislature fully supports Assembly Bill A04973A and Senate Bill S03419A and encourages its adoption by the State of New York; and be it further

(b) The tentative budget shall be filed with the Clerk of the County Legislature on or before the first (1<sup>st</sup>) day of October and posted on the County's internet website by close of the following business day. The tentative budget shall include such information and detail as may be requested by the County Legislature pursuant to § 7.04(A)(2).

#### Section 2.

Article 7, Section 7.04(B)(1) of the Putnam County Charter is hereby amended to read as follows:

1. Submission to the County Legislature. The Clerk of the County Legislature, upon receipt of the tentative budget from the County Executive as provided in § 7.04(A)(5)(b), shall transmit a copy of said tentative budget to each legislator and cause copies to be printed and made available to the public pursuant to the New York State Freedom of Information Law.

## Section 3.

Article 7, Section 7.04(B)(3) of the Putnam County Charter is hereby amended to read as follows:

3. Review by the Budget and Finance Committee. The Budget and Finance Committee of the County Legislature shall conduct a public hearing on the tentative budget as submitted by the County Executive. The County Executive and the Commissioner of Finance shall be present to answer questions about the tentative budget. The Budget and Finance Committee shall then review the tentative budget submitted by the County Executive and shall file a report with the Clerk of the County Legislature on or before the twenty-fourth (24<sup>th</sup>) day of October and post it on the County's internet website by close of the following business day. The report shall set forth any proposed changes, alterations or revisions to the tentative budget, including any recommendations made by the Budget and Finance Committee. Copies of the report shall be made available to the public.

# Section 4.

Article 7, Section 7.04(B)(4) of the Putnam County Charter is hereby amended to read as follows:

4. Public Hearing by the County Legislature. On or before the twenty-sixth (26) day of October, the County Legislature shall conduct a public hearing on the tentative budget submitted by the County Executive and the report of the Budget and Finance Committee of the County Legislature.

## Section 5.

Article 7, Section 7.04(B)(5) of the Putnam County Charter is Hereby amended to read as follows:

Legislative Action after the Public Hearing. Following completion of the public hearing by the County Legislature and prior to the thirty-first (31<sup>st</sup>) day of October, the Chair of the County Legislature shall convene a regular or special meeting of the County Legislature to consider for adoption the annual operating budget. The County Legislature, by resolution, may change, alter and revise the tentative budget by striking items of appropriations or anticipated revenues from the tentative budget or reduce items therein, excepting appropriations required by law for debt service, or add to or increase all such appropriations or revenue items in such budget. The County Legislature shall state separately and distinctly any change, alteration or revision made to the tentative budget and provide along with the budget it adopts a legislative memorandum detailing its amendments to the tentative budget.

#### Section 6.

This Local Law shall take effect immediately.

IN SUPPORT OF PUTNAM COUNTY'S LIMITED EXEMPTION OF SALES AND USE TAX ON PURCHASES OF QUALIFIED CLOTHING AND FOOTWEAR

WHEREAS, pursuant to authority granted under Article 28 of the New York State Tax Law, Putnam County may elect to exempt from imposing sales and use tax on purchases of qualified clothing and footwear; and

WHEREAS, in accordance with Article 29 of the New York State Tax Law, the exemption of sales and use taxes imposed by a County on purchases of qualified clothing and footwear is a year round commitment and a County's election or repeal of such exemption may only be effectuated annually on March 1<sup>st</sup>; and

WHEREAS, the County Executive previously proposed a limited "sales tax free holiday," more specifically, exemption of Putnam County's sales and use taxes collected on purchases of qualified clothing and footwear during a specific ten-day period in 2013 and Bills were sponsored in both the Assembly (Galef-R) and the Senate (Ball-R) (Gipson-D) under Bill Nos. A07607 and S03878A, respectively, but failed to pass both Houses of the State Legislature in 2013; and

WHEREAS, Bill No. A07607 of 2013, now A07607A, as amended, was re-committed to the Ways and Means Committee in the Assembly for an act to amend the tax law in relation to authorizing the County of Putnam to exempt from county sales and compensating use taxes purchases of qualified clothing and footwear during the period August 15-24, 2014; and

WHEREAS, Bill No. S03878A of 2013, now S03878B, as amended, was recommitted to the Investigations and Government Operations Committee in the Senate for an act to amend the tax law in relation to authorizing the County of Putnam to exempt from county sales and compensating use taxes purchases of qualified clothing and footwear during the period August 15-24, 2014; and

WHEREAS, the County Executive again proposes implementing a limited "sales tax free holiday," namely, exemption of Putnam County's sales and use tax collected on purchases of qualified clothing and footwear during a specific ten-day period in 2014, more particularly, August 15<sup>th</sup> through August 24<sup>th</sup>, which is expected to, among other things, improve retail sales, realize cost benefits to retailers, create jobs and promote economic growth in Putnam County; and

WHEREAS, the County Executive also proposes that in developing a limited "sales tax free holiday," Putnam County, working together in a private-public partnership with the Putnam County Chambers of Commerce and the Putnam County Economic Development Corporation (the "EDC"), will promote and encourage small business growth in Putnam County, which is ultimately in the best interests of Putnam County and its taxpayers; and

WHEREAS, the Putnam County Legislature supports the implementation of the County Executive's proposal to effectuate a limited exemption of sales and use taxes on purchases of qualified clothing and footwear; and

WHEREAS, the most effective manner of implementing such a change is for the Putnam County Legislature to request, as authorized under Municipal Home Rule Law §10, that the New York State Legislature amend relevant New York State Tax Law such that Putnam County may elect to exempt from collection of the County portion of sales and use taxes on purchases of qualified clothing and footwear and only for the limited period of August 15 through August 24, 2014; now therefore be it

RESOLVED, that the Putnam County Legislature hereby requests that the New York State Legislature adopt a Bill, in form and substance to proposed Bill No. A07607A and Bill No. S03878B to amend New York State Tax Law Article 29 by adding a new subsection which would be applicable to Putnam County, permitting Putnam County to effectuate its election to exempt the County's portion of the sales and use taxes on

purchases of qualified clothing and footwear from August 15 through August 24, 2014, notwithstanding any other provision of law to the contrary; and be it further

RESOLVED, that the Putnam County Legislature authorizes the County Executive and the Clerk of the Legislature to file a Home Rule Message for this request under Assembly Bill No. A07607A and Senate Bill No. S03878B for a Bill entitled "AN ACT to amend the tax law, in relation to authorizing the County of Putnam to exempt from county sales and compensating use taxes certain clothing and footwear, during the period commencing on August fifteenth and through August twenty-fourth, two thousand fourteen."

# Item #7 – Recognition of Public

Commissioner of Finance, William Carlin wanted to congratulate County Executive Odell and the Putnam County Legislature for appointing Michael Piazza as Commissioner of Social Services. He stated that Mike is an outstanding individual and he is proud to say that he has served with him for a very long time.

Liz Armstrong, Philipstown.info, requested clarification on the decision to keep groups such as NYSAC in the State Pension System. She believed that they were lobbying groups. She believed that their officers were not members of County government, therefore she questioned if taxpayers should be in any way involved with supporting their pensions through the NYS Pension System.

Legislator Oliverio stated that precedence has been set in the past 40 or 50 years with supporting these groups, including the school boards association. These are individuals who receive very little stipends and the retirement has been an incentive for them to volunteer. He stated that these are groups that support and provide information to our Legislature and School Boards.

Chairman Albano concurred. He believed that we needed a balance in government and that organizations such as NYSAC provide this help and guidance.

Legislator LoBue concurred. She believed that NYSAC helped support the fight against unfunded mandates. This is critical to not only County government, but to local government and school districts as well.

County Executive Odell stated that they are not lobbyists, they are advocates. The definition of a lobbyist is when an organization contributes to a political campaign. She stated that they in fact help keep property taxes low by keeping the pressure on the unfunded mandates which continue to put a further burden on local governments.

Transportation Manager, Vincent Tamagna, stated that when he served as a Legislator, NYSAC not only provided the Legislature with information that was coming forward from the State, but they also provided education through the conferences that they held. He also wanted to thank the Legislature for bringing forward the inclusion of new parcels in the Agricultural District.

# Item #8 – Recognition of Legislators

Legislator Gross stated that the Commissioner of Highways & Facilities, Fred Pena was recognized by the NYS Society of Professional Engineers Westchester/Putnam Chapter with its Outstanding Engineer in Government Award. This group helps woman through their treatment and recovery process who have ovarian and/or breast cancer. Legislator Gross stated that he also wanted to recognize Judy for all the work she has done in helping individuals and their families through the Community Action Program.

Legislator Nacerino stated that in noting this is the "Year of the Senior", she wanted to extend a belated "Happy 75<sup>th</sup> Birthday" to Paul Vava. She stated that he is an employee in the Town of Patterson and heads up the Senior Luncheon and cooks up a "storm"

every single month. He is a very special man and is Deputy County Executive Walker's father-in-law.

Chairman Albano stated that he wanted to recognize Krista Butler who has been a great asset in the Legislative Office. He stated that Krista will be leaving us and moving on to bigger and better things. He wanted to wish her luck and stated that she will be greatly missed.

Legislator Scuccimarra reminded everyone about the 2014 Tree & Shrub Seedling Program. She stated that information could be found on the County's website under the Planning Department.

Chairman Albano stated that Sunday, March 9, 2014 will be the St. Patrick's Day Parade in Mahopac.

Legislator LoBue asked if there could be a moment of silence for two individuals who passed away last month; Peter Creegan and David Diachenko. She stated that our hearts and prayers go out to their families.

# APPROVAL/LITIGATION SETTLEMENT/RDC GOLF GROUP, INC

WHEREAS, in or about April, 2008, the County and RDC Golf Group, Inc. (hereinafter "RDC"), entered into Management and Guarantee Agreements, wherein RDC agreed to manage and operate the Putnam National Golf Club and Banquet Facilities, located at 187 Hill Street, Mahopac, New York, and to pay certain expenses in connection therewith; and

WHEREAS, pursuant to said Guarantee Agreements, and a subsequent amendment thereto, RDC further agreed to guarantee net operating income for each fiscal year, as further specified therein; and

WHEREAS, the parties thereafter began to disagree on their respective duties and obligations under said agreements, which agreements were ultimately terminated; and

WHEREAS, as a result of said disagreements, RDC commenced an action against the County of Putnam on May 6, 2013, in the United States District Court for the Southern District of New York, wherein it sought an award of compensatory and punitive damages; and

WHEREAS, in response, the County filed an Answer with Counterclaims against RDC, seeking to recover compensatory and punitive damages; and

WHEREAS, after motion practice and earnest settlement negotiations, the County and RDC have agreed to settle this matter in its entirety for the proposed amount of ten thousand (\$10,000.00) dollars being paid by RDC to the County; and

WHEREAS, the parties have further agreed to execute respective General Releases, thereby relieving each other of further liability with respect to the above referenced agreements; and

WHEREAS, the parties have further agreed to enter into a mutual nondisparagement agreement, thereby preventing RDC from further discussing this matter; and

WHEREAS, the Putnam County Attorney has approved the instant settlement and recommends that the County so dispose of this matter; and

WHEREAS, the settlement of this matter is in the public interest and will avoid the costs of further litigation, now therefore be it

RESOLVED, that settlement of the matter of <u>RDC Golf Group v. County of Putnam</u> (Civil Action No.: 1:13-CV-03014-JSR) for the sum of ten thousand (\$10,000.00) dollars being paid by RDC to the County of Putnam, along with the above referenced additional conditions is hereby approved.
