Chairman Albano requested that anyone wishing to speak should come up to the microphone, state their name and the town in which they reside.

Ms. Marian Rockwell, Cold Spring Farm owner of 85 acres in the Town of Philipstown.

Ms. Rockwell stated that her application for inclusion into the Agricultural District included a complete plan for a horse boarding facility. She stated that she has been in communication with Dr. Somers, Manager of the State's Agricultural Protection Unit. She stated that the Town of Philipstown has treated her parcel as if it's a major development project. She stated that it would be very difficult to actually do the Agricultural Horse Boarding facility. She stated that she will also have some hay fields and has already converted some of the property into hay fields. She has also planted approximately 40 apple trees to have an apple orchard. She stated that she is grateful for the existence of the farm protection act and without it would not have even considered this as a possibility. She stated that she will continue to develop the property until it is considered feasible to be included in the Agricultural District.
