Item #3) Approval/Resolution/Infrastructural Upgrades/Tilly Foster Farm

Legislative Counsel VanRoss stated the resolution states that the Legislature accepts the infrastructural upgrades contained in the plan entitled "Draft: Tilly Foster Farm Update", it was presented by Commissioner Pena at the July 15, 2015 Physical Services Committee Meeting. He stated that the Bonding for an additional \$1million was passed at the August 4, 2015 Full Legislature Meeting. Therefore, he would like to recommend the wording in the proposed resolution *"being presented at a later date"* be removed.

Chair Albano made a motion to strike the wording as recommended by Legislative Counsel VanRoss; Seconded by Legislator Castellano. All in favor.

Chair Albano made a motion to approve Resolution/Infrastructural Upgrades/Tilly Foster Farm; Seconded by Legislator Castellan. All in favor.

Item #4) Approval/Contract of Sale and Conveyance of Property/Town of Carmel T.M.#65.13-1-38

Legislator Castellano stated that he believes this is great for the County and the residents. These parcels exist throughout the County.

Legislator LoBue stated this is a practice that has been going on in the County for as long as she can remember.

Chair Albano made a motion to approve the Contract of Sale and Conveyance of Property/Town of Carmel T.M.#65.13-1-38 ; Seconded by Legislator Castellano. All in favor.

Item #5) Approval/ Lease Renewals Putnam County Veteran's Residence

Chair Albano made a motion to approve the Lease Renewals Putnam County Veteran's Residence; Seconded by Legislator Wright. All in favor.

Legislator Wright requested that in 2016 the request for the renewal of this lease be presented to the Legislature in June, prior to it expiring.
