Commissioner of the Bureau of Emergency Services Anthony Sutton stated currently, the Indian Point reception center supplies are being stored in closets at George Fischer Middle School and Brewster High School. He stated the trailers being purchased would be utilized to store these supplies, which would give the Bureau of Emergency Services the ability to update the equipment and refresh the inventory on their schedule. He stated the Schools have been very accommodating; however these supplies would be more accessible in trailers. He stated over the summer, a routine check was being conducted on the supplies at Brewster High School and it was discovered that the school would have about 40 tractor trailers in the parking lot that week because they were doing roof and asbestos abatement. He stated this made the supplies unavailable during this time. He stated Indian Point funds will be used to purchase the two (2) trailers for the supplies so they can be used at the designated sights as well as in other locations.

Legislator Nacerino stated the Schools have been generous in offering space for this reason; however they are not always accessible. She stated she is supportive of this purchase.

Chairman Castellano stated having materials in trailers will also make them mobile.

Legislator Nacerino made a motion to approve Fund Transfer 15T269; Seconded by Chairman Castellano. All in favor.
