WHEREAS, Putnam County continuously strives to be in compliance with the Affordable Care Act (ACA); and

WHEREAS, Putnam County previously adopted Resolution #25 of 2015 which outlined the Procedure and Policy regarding eligibility for employer sponsored health insurance; and

WHEREAS, Putnam County employees eligible for health coverage must be charged an amount that meets affordability guidelines as defined by the Affordable Care Act; and

WHEREAS, the Affordable Care Act currently defines affordability as single coverage health insurance which must not cost an employee more than 9.5%; and

WHEREAS, this Resolution does not apply to management employees nor those covered by a Collective Bargaining Agreement; now therefore be it

RESOLVED, that the Putnam County Legislature hereby determines that any employee covered by the Affordable Care Act will be offered single employer health insurance coverage through a plan of the County's choice so long as the health insurance offered meets ACA minimum value; and be it further

RESOLVED, that the Putnam County Legislature hereby determines that any employee covered by the Affordable Care Act will be charged for single coverage in an amount not to exceed 9.5% of the employee's W2 box 1 earnings, or if the ACA is amended, any such amount as defined by the ACA as affordable.

WHEREAS, the Putnam County Administration recommends the acceptance of the negotiated offer of \$15,000.00, and as further specified in the Contract of Sale, which is attached hereto and made a part hereof as Schedule "A"; and

WHEREAS, the Putnam County Legislature has reviewed said negotiated offer, now therefore be it

RESOLVED, that pursuant to the authority vested in the Putnam County Legislature in Section 31-4 and Section 31-8 of the Putnam County Code, the Putnam County Legislature approves the sale of the property identified as 24 Reservoir View Court, Carmel, New York (Kent TM # 43.-2-69) for such amount and upon such other terms and conditions as are contained in the Contract of Sale, which is attached hereto and made a part hereof as Schedule "A"; and be it further

WHEREAS, the Program Plan's objectives include, without limitation, ensuring that the level and quality of public transportation service is provided in a non-discriminatory manner, promoting full and fair participation in public transportation decision-making without regard to race, color or national origin, and ensuring meaningful access to transit-related programs and activities by persons with limited English proficiency; now therefore be it

RESOLVED, that the County Executive, together with the County Legislature, support the County's continued participation in approved FTA programs and activities, as well as continue to be a recipient of FTA financial assistance therefor; and be it further

RESOLVED, that the County Executive, together with the County Legislature, approve the County's Program Plan, which is in substantial conformance in form and substance to the Program Plan annexed hereto and made a part hereof as "Exhibit A;" and be it further

RESOLVED, that the County Planning, Development and Public Transportation Department is hereby authorized to submit to the FTA the Program Plan, which is in substantial conformance with "Exhibit A" annexed hereto and made a part hereof, in compliance with FTA requirements in connection therewith; and be it further

RESOLVED, that this Resolution shall take effect immediately.
