Item #6b – Approval/Fund Transfer (16T066)/Finance/Veterans Home Generator was next. On behalf of the members of the Physical Services Committee, Legislators Castellano and Scuccimarra, Legislator Albano moved the following:

Legislator Gross stated that this item was tabled from last month's Full Meeting because Legislator LoBue questioned where the money was coming from. He stated that he has been a Legislator for the last five (5) years and he is also a veteran. He stated that the

Legislature has always supported veteran's issues and Veterans Affairs at every single level such as: the Veterans Home, transportation and handicap van, a part-time position of Veterans Affairs being moved to a full-time position, the support of the Row of Honor, the support of the Moving Wall coming to Veteran's Memorial Park twice, along with an assortment of activities at Veteran's Memorial Park. He stated that any suggestion that the Legislature did not support veterans is totally false and for a Department Head to post that on social media was uncalled for.

Legislator Addonizio stated that she was in favor last month of the purchase of the generator. She stated that she tabled it due to the fact that she did not have the contingency budget at that time and therefore it was questionable as to why we were using that particular line. She stated that she now has the contingency report and stated that, as of today, the County has almost \$1.6 million in the contingency fund. She stated that she was informed that this fund is used for unexpected expenses and therefore she did not have any issue with the money being taken from that line. She stated that she would fully support the request this evening.

Legislator Albano stated that this fund transfer was reviewed by the Physical Services Committee and the Audit & Administration Committee and he believed that it made sense to him to use the contingency fund because it was an unanticipated expense. He stated that for that reason he voted "no" last month to table it. He stated that it was never a question of whether or not to approve the generator. It was just a question of what line the funds would come from.

Legislator LoBue stated that she was shocked after last month's meeting and the comments made in the photo op in the newspaper suggesting that the Legislature would jeopardize the safety of the veterans when we have numerous generators available. She stated that it was very disappointing and was surprised at the behavior of the two (2) Department Heads from Veterans Affairs.

WHEREAS, the Putnam County Legislature has reviewed said negotiated offer, now therefore be it

WHEREAS, it is intended that USDOT's Fiscal Year (FY) 2016 TIGER discretionary grant funds will be awarded to projects in re capital investments in surface transportation infrastructure as well as projects that will have a significant impact in a Region, with particular focus on capital projects that generate economic development and improve access to reliable, safe and affordable transportation for communities; and

WHEREAS, the FY 2016 TIGER funding is provided in the Consolidated Appropriations Act, 2016, and the deadline for application submission is April 29, 2016; and

WHEREAS, Section 5-1(D)(1) of the Putnam County Code requires the Legislature approve all grant applications prior to their submission and that in the event when time is of the essence requiring submission before Legislature approval is obtained, consideration of the application shall occur at the next Full Legislature Meeting; and

WHEREAS, the County, by and through the Putnam County Department of Planning, Development and Public Transportation, is desirous to competitively seek grant funds through the FY 2016 TIGER grant program and in furtherance therefor submitted its grant application by the April 29, 2016 deadline set forth by the USDOT; and

WHEREAS, the grant funding is eighty (80%) percent reimbursement federal funding and twenty (20%) percent matched funding; and

WHEREAS, the Legislature, by and through the Physical Services Committee, has reviewed and approved the County's application for TIGER grant funding and ratifies the County's request to apply for TIGER grant funding; now therefore be it

RESOLVED, that the County Executive, together with the County Legislature, support the County's application for TIGER grant funding as submitted on April 29, 2016 and ratifies and approves the Putnam County Department of Planning, Development and Public Transportation's request to apply for TIGER grant competitive funding.

WHEREAS, in addition to other municipalities statewide, Putnam County (the "County") was allocated a portion of this funding, more specifically, \$46,042, for the purpose of implementing eligible project(s) to further the intent, purpose and goals of the Program; and

WHEREAS, in keeping local pedestrians' and cyclists' safety a priority, the County proposes to purchase and install additional road intersection signage (the "Signage") at specific locations throughout the County (hereinafter referred to as the "Project"), and, as defined by New York State, the County's proposed Project meets the intent, purpose and goals of the Program; and

WHEREAS, the County, as the Municipality/Sponsor of the Project, desires to make application for funding for the Project and accept the funds allocated to it by New York State, by and through the New York State Department of Transportation ("NYSDOT"), in the amount of \$46,042, thereby reducing the Project's costs therefor by said amount; now therefore be it

RESOLVED, that the Putnam County Legislature hereby approves the aforesaid Project; and it is hereby further

RESOLVED, that the Putnam County Legislature hereby authorizes the County to make application for and accept the accelerated transit capital funding allocated to it by New York State in the amount of \$46,042, thereby reducing the total Project costs by said amount, such application being in substantial conformance with Exhibit "A" attached hereto and made a part hereof; and it is hereby further

WHEREAS, by Resolution #58 of 2002, the Legislature continued its approval of the County's participation in the Project and appropriated the sum of \$75,000 to cover the cost of the County's participation in the Project; and

WHEREAS, by Resolution #148 of 2005, the Legislature continued its approval of the County's participation in the Project and appropriated the sum of \$367,000 to cover the cost of the County's participation in the Project; and

WHEREAS, by Resolution #479 of 2009, the Legislature continued its approval of the County's participation in the Project and appropriated the sum of \$2,900,504 to cover the cost of the County's participation in the Project; now therefore be it

RESOLVED, that the Legislature hereby approves the Project and the County's continued participation therein; and be it further

RESOLVED, that the Legislature hereby authorizes the County to pay in the first instance 100% of the costs or portions thereof associated with the County's continued participation in the Project; and be it further

# Item #8 - Recognition of Public

Town of Southeast Resident, Ms. Alexandra Ballantine expressed her concern about the decision to use contingency funds to purchase the generator for the Veteran's Residence. She expressed her concern when Director of Veteran's Affairs, Karl Rohde, secured a photo and feature story in the May 18<sup>th</sup> addition of the Putnam County Press where he declared that he would take a pay cut for the County to buy the generator. She stated that he made it clear that he was criticizing the rest of us. She explained that it was her understanding the vote to table was to ensure the funding was done responsibly. She stated that she appreciated the Legislators who stood by that vote. She stated that it was her understanding that there was Emergency Services equipment and transportation services that has and will protect those whose lives would be at risk by a lengthy power outage. She stated that most group homes, let along homeowners in Putnam County, could not afford such a generator. She continued and explained that Director Rohde also appeared on the local cable TV talk show "Good Day Hudson Valley" on May 19<sup>th</sup> to describe services offered to veterans; all taxpayer funded. She stated that he differentiated himself from those who held the post before him by noting that, he

unlike they, reaches out to veterans. She stated that her father-in-law, a World War II Navy Veteran, faced three (3) serious health crises recently and spent two (2) months at Putnam Hospital Center and Putnam Ridge Nursing Home. She stated that she was not aware of anyone reaching out to him. She suggested having these local institutions alert Veteran Services when a veteran checks in to these facilities, as a way to reach out. She also suggested using social media to help veterans connect with each other in Putnam. She also explained that she saw an article about a traveling memorial that honors service dogs and other animals that have served our Country. She believed that would be an interesting awareness vehicle for Putnam County.

# Item #9 - Recognition of Legislators

Legislator Scuccimarra stated that the Village of Cold Spring Planning Board will be meeting this Friday, June 10, 2016 at 6:00 pm. She stated that the meeting was originally scheduled for Thursday. She wanted the seniors to be aware of the meeting change. She hoped that this meeting will resolve the problems associated with the Senior Center project.

Legislator Castellano reminded everyone about the firework display scheduled for Saturday, July 2, 2016 at the Home Depot/Kohl's plaza.

Legislator LoBue congratulated all of the graduates of the County and wished them continued success in all of their endeavors. She also wanted to give an honorable mention to Lieutenant John McGinty, a New York City Firefighter from Mahopac. She read an article in the paper which explained how he received, this past April, the Uniform Fire Officers Association Medal from Mayor Bill DiBlasio for the rescue of an unconscious woman trapped in a burning building.

Chairwoman Nacerino stated that she wanted to echo Legislator LoBue's sentiments in congratulating the graduating classes. She wished them much success in their future.
