REGULAR MEETING OF THE PUTNAM COUNTY LEGISLATURE HELD IN THE HISTORIC COURTHOUSE CARMEL, NEW YORK 10512

<u>Tuesday</u> <u>March 1, 2016</u> <u>7:00 P.M.</u>

The meeting was called to order at 7:03 P.M. by Chairwoman Nacerino who requested that Legislator LoBue lead in the Pledge of Allegiance. Chairwoman Nacerino requested Legislator Castellano lead in the Legislative Prayer. Upon roll call, Legislators Scuccimarra, Addonizio, Albano, Gross, Castellano, LoBue, Wright and Chairwoman Nacerino were present. Legislator Gouldman arrived at 7:28 P.M. WHEREAS, PARC educates and assists children with autism and special needs through its Preschool to reach their fullest potential and retain their success through their participation in the public school system; and

WHEREAS, PARC's residential program provides a family atmosphere for more than 130 people in both homes and apartments throughout Putnam County; and PARC's day programs offer meaningful and productive options for people to learn about and explore their communities while building life skills; and

WHEREAS, PARC's clinic provides a support system for both PARC participants and their families through individual, group, and vocational counseling; now therefore be it

APPROVAL/REQUEST ADMINISTRATION TO FORWARD BUDGETARY AMENDMENT/ TRANSFER \$75,000 FROM SUB-CONTINGENCY TO INDUSTRIAL DEVELOPMENT CORP. (IDA)

WHEREAS, Section 927(f) of the General Municipal Law enacted by the New York State Legislature in 1987 permitted Putnam County to establish an Industrial Development Agency (IDA); and

WHEREAS, pursuant to this authority, a seven (7) member IDA was created by Putnam County which agency has continued to this day with various personnel changes; and

WHEREAS, since its inception the IDA has had no problem receiving revenues based on its bonding ability: and

WHEREAS, recently the law was changed removing not-for-profit corporations as a source for IDA bonding; and

WHEREAS, other changes by New York State has further limited the IDA's sources of revenue; and

WHEREAS, due to the down turn in the economy and the limitation of revenue sources from IDA bonding, the Putnam IDA has had serious problems in securing revenue sources, leaving it with a fund balance of approximately \$300.00; and

WHEREAS, Putnam County did not provide for IDA funding in the 2016 budget but did place \$75,000 in a sub-contingency account for a potential IDA funding contribution; and

WHEREAS, members of the IDA perceived no movement by Putnam County for its future financial commitment, and with filing and other requirements due by the IDA the members of the IDA tendered their resignations to the Putnam County Legislature; and

WHEREAS, the Putnam County Legislature is desirous of resolving the problems that exist with the IDA including their revenue problems; and

WHEREAS, \$75,000 was placed in sub-contingency for the benefit of the IDA; and WHEREAS, the Economic Development & Energy Committee has considered and approved of a budgetary transfer from sub-contingency to the IDA for this \$75,000; now therefore be it

RESOLVED, that the Putnam County Legislature requests the Administration prepare and forward a budgetary amendment transferring the \$75,000 in sub-contingency to the IDA.

WHEREAS, the County of Putnam is a member of the East of Hudson Watershed Corporation ("EOHWC"), a not-for-profit local development corporation formed to assist the member municipalities located within the New York City watershed east of the Hudson River in complying with the stormwater retrofit requirements of the Municipal Separate Storm Sewer System Permit ("MS4 Permit"); and

WHEREAS, the County, along with the other member municipalities, are individually subject to a MS4 Permit, pursuant to which municipalities are required to implement stormwater retrofits and are encouraged to participate in a regional stormwater retrofit plan; and

WHEREAS, EOHWC has installed and will continue to install stormwater retrofit projects ("SRPs") or has reimbursed member municipalities for installing SRPs in compliance with the first five-year Regional Stormwater Retrofit Plan, and intends to do so for the second five-year plan to the extent funding is provided by the New York City Department of Environmental Protection ("DEP"); and

WHEREAS, the MS4 Permit requires member municipalities to maintain each SRP for its useful life to ensure that it continues to operate as it was designed; and

WHEREAS, the Board of Directors of EOHWC has adopted an Operation and Maintenance Policy ("O&M Policy") setting forth the equitable share of the costs and responsibilities under such policy by all member municipalities in a manner consistent with the MS4 Permit bubble compliance (a shared responsibility for the installation of

stormwater retrofits) and requiring the legislative body of each member municipality to agree to comply with the terms and conditions of the O&M Policy; and

WHEREAS, approval of the O&M Policy is a Type II action exempt from the State Environmental Quality Review Act ("SEQRA") under 6 NYCRR 617.5(c)(1) as it relates to the routine maintenance of the SRPs; and

WHEREAS, approval of the O&M Policy is in the best interests of the County as it assures continued compliance by the County with the MS4 Permit; now therefore be it

RESOLVED, that the County of Putnam accepts and agrees to the terms and conditions of the EOHWC O&M Policy, attached hereto as "Schedule A", and be it further RESOLVED, that this Resolution shall take effect immediately.

Legislator Wright questioned if a vote was needed to accept the additional material. He stated that the additional Environmental Assessment Form (EAF) that has been presented to the Legislature is different than the one that was presented to the Physical Services Committee.

Chairwoman Nacerino made a motion to accept the additional material; seconded by Legislator Scuccimarra.

Legislator Wright stated that he would not accept the additional material. He stated that the applicant/sponsor is a different person and he didn't know who was responsible for the application. He didn't believe that the WHEREAS paragraph in the resolution, relative to the Legislature having conducted a review of Part 617 and made a finding, is accurate. He stated that he did not want to accept the additional for those reasons.

Legislator Albano questioned if the Legislature could vote on the original document.

Legislator Wright stated that subsequent to the Physical Services Committee's meeting on the matter, the EAF upon which the Committee reportedly acted on has been altered. He stated that there are different responsible parties set forth. He stated that Deputy Commissioner of Highways & Facilities was the original applicant/sponsor and on the revised the applicant/sponsor is the Putnam County Legislature. He stated that there was no review of Part 617 by the Legislature. He believed that the Planning Department did not want the EAF which was before the Committee to be sent to the DEC since they have revised and supplemented it.

Legislator Castellano made a motion to TABLE the resolution; seconded by Legislator Wright.

WHEREAS, the County further desires to have two aboveground fuel storage tanks, associated tank mounted dispensing systems and a fire suppression system installed at an existing County Highway yard outpost facility located at 454 Route 6N (the "Outpost Facility"); and

WHEREAS, the County also desirous to utilize the Outpost Facility for the temporary stockpiling by County contractor(s) of materials that result from tree removal,

trimming, felling, and pruning and/or during major storm events for work being performed along County roads in proximity to the Outpost Facility, as well as the temporary stockpiling of job materials (e.g., Item 4, topsoil, stone, etc.) associated with County projects located in close proximity to the Outpost Facility (such stockpiling collectively referred to as "the Project"); and

WHEREAS, the premises where the Outpost Facility is located is owned by the New York City Department of Environmental Protection (the "NYCDEP") for watershed protection purposes and is subject to the terms of a Land Use Permit and the foregoing Project requires a modification to the existing permit; and

WHEREAS, the proposed action hereunder is subject to review under the State Environmental Quality Review Act and the Regulations promulgated thereunder ("SEQRA 6 NYCRR Part 617"); and

WHEREAS, other possible/potential/interested agencies (the "Involved Agencies") have been identified in connection with the proposed action; and

WHEREAS, a Full Environmental Assessment form (EAF) has been prepared for the Project; and

WHEREAS, the Putnam County Legislature (the "Legislature"), after a review of Part 617, finds that the proposed action is an "Unlisted" action, as defined in 6 NYCRR Part 617.2: and

WHEREAS, pursuant to the requirements of 6 NYCRR Part 617.6(b)(3) a coordinated review of this action will be conducted; now therefore be it

RESOLVED, that the Legislature hereby declares its intent to serve as the Lead Agency under the procedures and requirements of SEQRA, and will circulate a Lead Agency Notice along with the EAF and associated documentation to all Involved Agencies and will follow protocol in accordance with and as required by all relevant rules and regulations.
