REGULAR MEETING OF THE PUTNAM COUNTY LEGISLATURE HELD IN THE HISTORIC COURTHOUSE CARMEL, NEW YORK 10512

<u>Tuesday</u> October 4, 2016 7:00 P.M.

The meeting was called to order at 7:03 P.M. by Chairwoman Nacerino who requested that Legislator Castellano lead in the Pledge of Allegiance. Chairwoman Nacerino requested that Legislator Addonizio lead in the Legislative Prayer. Upon roll call, Legislators Scuccimarra, Gouldman, Addonizio, Albano, Gross, Castellano, LoBue, Wright and Chairwoman Nacerino were present. Also present was Legislative Counsel Van Ross.

PROCLAMATIONS

Chairwoman Nacerino recognized Legislator Gross who presented the "Domestic Violence Awareness Month" proclamation to Faye Thorpe, Co-Chair of PADV (People Against Domestic Violence); Amy Dehais, Senior Probation Officer & member of PADV; Ann Ellsworth, Executive Director of Putnam Northern Westchester Women's Resource Center and Elizabeth Barcavage, Co-Chair of PADV.

DOMESTIC VIOLENCE AWARENESS MONTH

WHEREAS, Domestic Violence is an epidemic affecting individuals in every community including Putnam County, regardless of age, economic status, sexual orientation, gender, race, religion, or nationality; and

WHEREAS, 1 in 3 women and 1 in 4 men have been victims of some form of physical violence by an intimate partner and 72% of all murder-suicides involve an intimate partner; 94% of the victims of these murder suicides are female; and

WHEREAS, The Putnam/Northern Westchester Women's Resource Center served 1574 women, children, and men who were victims of domestic and sexual violence in 2015 and:

WHEREAS, Domestic Violence also affects businesses and the economy because 1 in 5 employed adults is a victim and women make up 46% of the workforce; and

WHEREAS, there are eight million lost work days, \$2 billion in lost wages and productivity and \$4 billion spent in medical and mental health care costs due to Domestic Violence; and

WHEREAS, a study found that 2 in 3 Americans still do not recognize the symptoms of domestic violence; now therefore be it

RESOLVED, that Putnam County Executive MaryEllen Odell and the Putnam County Legislature do hereby proclaim October as "Domestic Violence Awareness Month". We urge all residents to learn more about this terrible problem and take positive action by attending the Putnam County People Against Domestic Violence "Walk to End Domestic Violence" on Saturday, October 22, 2016 in Cold Spring. The Walk steps off at 12:00 noon and all are invited to walk with PADV down Main Street to the Hudson River.

Chairwoman Nacerino recognized Legislator Scuccimarra who presented the "National Substance Abuse Prevention Month" proclamation to Joseph DeMarzo, Deputy Commissioner of Social Services, Mental Health & Youth Bureau.

NATIONAL SUBSTANCE ABUSE PREVENTION MONTH

WHEREAS, Every day, far too many Americans, including Putnam County residents, are hurt by alcohol and drug abuse. From diminished achievement in our schools to greater risks on our roads and in our communities, to the heartache caused by lives cut tragically short, the consequences of substance abuse are profound. Yet, we also know that they are preventable. This month, we pay tribute to all those working to prevent substance abuse in our communities, and we rededicate ourselves to building a safer, drug-free Putnam County; and

WHEREAS, By stopping drug use before it starts, we can prevent the disease of addiction and create stronger neighborhoods across our County; and

WHEREAS, Community-based prevention systems that join stakeholders at every level of government with local organizations can deliver local solutions; and

WHEREAS, All of us can play a role in preventing drug and alcohol abuse. As our children's first teachers, parents and guardians can help by talking to their kids about the dangers of substance abuse. Alongside them, coalitions of teachers, faith-based groups, health care providers, law enforcement officials, and other local leaders are joining together to address substance abuse in their communities: and

WHEREAS, As we observe National Substance Abuse Prevention Month, let us join in those vital efforts and reaffirm our vision for an America where each of us has the fullest opportunity to live in health and happiness; now therefore be it

RESOLVED, That the Putnam County Executive and Putnam County Legislature do hereby proclaim October 2016 as Substance Abuse Prevention Month. Along with the National Council on Alcoholism and Other Drug Dependencies/Putnam and all substance abuse prevention and treatment providers in Putnam County encourage all residents to increase their awareness of alcohol use disorders, the dangers of alcohol abuse, the success of prevention and treatment programs; especially for our youth, and to actively support and encourage referrals for treatment of individuals when a disorder is suspected or present.

Chairwoman Nacerino recognized Legislator Castellano who presented the "National Fire Prevention Week" proclamation to Anthony Sutton, Commissioner of Bureau of Emergency Services and Robert Lipton, Deputy Commissioner of Bureau of Emergency Services.

NATIONAL FIRE PREVENTION WEEK - OCTOBER 9-15, 2016

WHEREAS, National Fire Prevention Week will be October 9 - October 15, 2016, during which attention will be focused on promoting fire safety and prevention. In 2015, there were 1,345,500 reported fires in the United States, 3,280

deaths caused by fires, 175 of which were in New York State, and 15,700 injuries. Those fires resulted in an estimated \$14.3 billion in property damage; and

WHEREAS, The National Fire Protection Agency (NFPA) has adopted the theme of this year's prevention efforts as "Don't wait, Check the Date... Replace smoke alarms every 10 years!" Existing battery powered smoke alarms should be replaced with newer models with permanent batteries that last ten years. To check the age of a smoke detector, look on the back of the alarm for the manufacture date as 10% of smoke alarms do not activate if left in service more than 10 years; and

WHEREAS, Each home and business should also have Carbon Monoxide detectors. It is important to keep in mind that most Carbon Monoxide Detectors expire after 5 years of service; and

WHEREAS, Every family should discuss evacuation routes in case of a fire, including an area to reunite to assure that everyone has safely evacuated. These plans should then be drilled to get everyone is familiar with the procedures. Once safely outside everyone should wait for the Fire Department to arrive and never reenter a burning building; and

WHEREAS, it is recommended that local businesses get involved in Community Fire Prevention efforts, practice fire drills, and evacuation plans with their employees. Employees should be trained on how to properly report an emergency to 911, how to assist fellow employees in an emergency, and how to activate an alarm. Training on how to use a fire extinguisher, perform CPR, and use a Defibrillator should also be discussed during this month; and

WHEREAS, Putnam County is served by dedicated Volunteer Fire Departments whose service we greatly value and appreciate. Last year across this Nation there were 68 firefighter deaths and 63,350 firefighter injuries. Taking time to properly use smoke alarms and plan fire drills protects both residents and our courageous volunteers; now therefore be it

RESOLVED, that Putnam County Executive MaryEllen Odell and the Putnam County Legislature do hereby proclaim the week of October 9 - October 15, 2016 as National Fire Prevention Week in the County of Putnam and remind all citizens of the dangers of fires and of the need to practice home fire drills and to visit their local fire departments' fire prevention programs.

Chairwoman Nacerino recognized Legislator Gross who presented the "National Lead Poisoning Prevention Week" proclamation to Supervisor Public Health Nurse Rebecca Wittenberg.

NATIONAL LEAD POISONING PREVENTION WEEK - OCTOBER 23-29, 2016

WHEREAS, every Putnam County resident deserves to grow up in a healthy, safe environment, free from harmful effects of lead; and

WHEREAS, the major source of lead exposure is the dust from deteriorating lead-based paint or renovations to houses or childcare facilities built before 1978; and

WHEREAS, 73% of lead poisoning cases have lead-based paint as the primary or contributing source; and

WHEREAS, although individuals with lead poisoning often exhibit no symptoms, lead interferes with normal brain development, and is associated with

permanently reduced IQ, learning disabilities, behavioral disorders, and has been cited as an indicator of decreased lifelong learning potential; and

WHEREAS, it is vital that all Putnam County residents, especially parents and child caregivers are aware of the dangers of lead poisoning and seek appropriate screening for their children as a preventative measure; and

WHEREAS, lead poisoning caused by renovations can be prevented by using EPA certified contractors who follow the Renovation, Repair, and Painting Rule: and

WHEREAS, October 23-29, 2016, is National Lead Poisoning Prevention Week and is an opportunity for Putnam County to provide education and raise awareness about lead poisoning prevention measures; now therefore be it

RESOLVED, that Putnam County Executive MaryEllen Odell and the Putnam County Legislature do hereby proclaim October 23-29, 2016 as Lead Poisoning Prevention Week in Putnam County, and invite all citizens to duly note this occasion.

Legislator Gouldman offered the following resolution and moved its adoption:

BOND RESOLUTION OF THE COUNTY OF PUTNAM, NEW YORK, ADOPTED OCTOBER 4, 2016, AUTHORIZING THE ACQUISITION AND/OR INSTALLTION OF VARIOUS SECURITY EQUIPMENT AND IMPROVEMENTS AT THE COUNTY JAIL; STATING THE ESTIMATED TOTAL COST THEREOF IS \$188,153; APPROPRIATING SAID AMOUNT THEREFOR, INCLUDING THE EXPENDITURE OF \$8,153 OF COUNTY FUNDS, AND AUTHORIZING THE ISSUANCE OF \$180,000 SERIAL BONDS OF SAID COUNTY TO FINANCE THE BALANCE OF SAID APPROPRIATION.

THE COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Legislature) AS FOLLOWS:

Section 1. The County of Putnam, New York (herein called "County"), is hereby authorized to acquire and/or install various security equipment and improvements at the county Jail. The estimated total cost of such class of objects or purposes, including preliminary costs and costs incidental thereto and to the financing thereof, is \$188,153 and said amount is hereby appropriated therefor, including the expenditure of \$8,153 of County funds. The plan of financing includes the expenditure of said County funds and the issuance of \$180,000 serial bonds of the County to finance the balance of said appropriation, and the levy and collection of taxes on all the taxable real property

in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the County in the principal amount of \$180,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance a portion of said appropriation.

Section 3. The period of probable usefulness of the class of objects or purposes for which said bonds are authorized to be issued, within the limitations of Section 11.00 a. 32 of the Law, is five (5) years.

Section 4. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the County for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the County, payable as to both principal and interest by general tax upon all the taxable real property within the County. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds having substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and Sections 50.00, 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the County Legislature relative to authorizing bond anticipation notes, or the renewals thereof, and relative to providing for substantially level or declining annual debt service, and prescribing the terms, form and contents, and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, as well as to executing agreements for credit enhancements, are hereby delegated to the Commissioner of Finance, the chief fiscal officer of the County.

Section 7. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with.

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 8. This bond resolution shall take effect upon the approval of the Putnam County Executive, and the Clerk of the County Legislature is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in "The Putnam County Courier," "The Putnam Press," and "The Putnam County News & Recorder," three newspapers, each having a general circulation in the County and hereby designated as the official newspapers of the County for such publications.

BOND RESOLUTION OF THE COUNTY OF PUTNAM, NEW YORK, ADOPTED OCTOBER 4, 2016, AUTHORIZING THE PAYMENT OF A SETTLED CLAIM, STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$350,000; APPROPRIATING SAID AMOUNT THEREFOR; AND AUTHORIZING THE ISSUANCE OF \$350,000 SERIAL BONDS OF SAID COUNTY TO FINANCE SAID APPROPRIATION.

THE COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Legislature) AS FOLLOWS:

Section 1. The County of Putnam, New York (herein called "County"), is hereby authorized to pay a settled claim pursuant to a Stipulation of Settlement in the Matter of Partenza-Mahoney, Inc. v. the County of Putnam, et al., in the Supreme Court of the State of New York, Putnam County (Index No. 2380/2013). The aggregate estimated maximum cost thereof, including preliminary costs, and costs incidental thereto and the financing thereof, is \$350,000 and said amount is hereby appropriated for such purpose. The plan of financing includes the issuance of \$350,000 serial bonds of the County to finance said appropriation, and the levy and collection of taxes on all the taxable real property in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the County in the principal amount of \$350,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance said appropriation.

Section 3. The period of probable usefulness applicable to the object or purpose for which said bonds are authorized to be issued, within the limitations of Sections 11.00 a. 33 of the Law, is five (5) years.

Section 4. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the County for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the County, payable as to both principal and interest by general tax upon all the taxable real property within the County. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds having substantially level or declining annual debt

service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and Sections 50.00, 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the County Legislature relative to authorizing bond anticipation notes, or the renewals thereof, and relative to providing for substantially level or declining annual debt service, and prescribing the terms, form and contents, and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, as well as to executing agreements for credit enhancements, are hereby delegated to the Commissioner of Finance, the chief fiscal officer of the County.

Section 7. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 8. This bond resolution shall take effect upon the approval of the Putnam County Executive, and the Clerk of the County Legislature is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in "The Putnam County Courier," "The Putnam Press," and "The Putnam County News & Recorder," three newspapers, each having a general circulation in the County and hereby designated as the official newspapers of the County for such publications.

Item #7 - Other Business

There was no other business submitted to the meeting.

Item #8 - Recognition of Public

Stephanie Hawkins, Cold Spring resident, referenced agenda Item #4 – Approval of Minutes of Special Meeting September 14, 2016 regarding Butterfield Senior Center. She mentioned her neighbor, Lithgow Osborne, who received an email from Chairwoman Nacerino who stated that the Butterfield project was not on the agenda and she also informed him of the Legislative process for public comment addressing agenda items. Ms. Hawkins stated that because the minutes pertaining to the Butterfield Senior Center were on the agenda, several individuals asked her to take notes to bring to the Legislature's attention. She stated that David Limburg of Nelsonville mentioned that he has written twice requesting greater transparency regarding the Butterfield lease. Ms. Hawkins also read a statement made by Kathleen Foley of Cold Spring which addressed many questions regarding the Butterfield project. Ms. Hawkins also expressed her displeasure on how this project was handled and believed that the budget for this project was not consistent with the needs of their community.

Chairwoman Nacerino requested Legislative Counsel Van Ross to address this matter.

Legislative Counsel Van Ross stated that the lease is not on the agenda. It is only the adoption of the minutes from the Special meeting in September. He stated that the adoption of the lease or an amendment to the lease is not on the agenda.

Chairwoman Nacerino stated that the lease has been deliberated and disposed of and the County Executive has executed her portion.

Ann Fanizzi, Town of Carmel resident referenced Item #6p – Approval of Bond Resolution /Litigation Settlement /Parenza-Mahoney v. County. She stated that she was concerned about the reliance on bonding as a funding mechanism. She believed that if there were reserves available, she did not know why we have relied on bonding for this particular item. She then brought up Item #6w – Approval Law Department /Safety Committee /Grant Award / Putnam County Respiratory Protection Program. She wanted to inform the Legislature that there are counties in the United States that have declared areas around telecommunication cell towers hazmat areas. She believed this was something to look into.

Liz Armstrong, from Highlands Current website and newspaper, stated that Chairwoman Nacerino stated that the County Executive has executed her end of

the Butterfield lease. She questioned if the lease has been signed and if so, is it public and where can the public and the press get a copy.

Chairwoman Nacerino stated that it has not been fully executed, however, being that it has been approved by this Legislature you can certainly request a copy by FOIL and we will submit a PDF copy to you or a hard copy.

Ms. Armstrong questioned if it needed to be obtained through a Freedom of Information Request.

Chairwoman Nacerino said, "no."

Legislative Counsel Van Ross stated that it can be required to obtain anything through FOIL. He stated that the FOIL process is there as a protection to the residents so that they can receive documentation. He stated that this Legislature is making the lease available to anyone who wants it without a FOIL. He stated that eventually when it is completely signed by all parties; it will be posted on the website.

Megan Castellano, Executive Director of Mental Health Association of Putnam County, Inc. and resident of the Town of Carmel spoke to Item #6m – Approval/Budgetary Amendment (16A065)/Veterans Affairs/Peer to Peer Program/Additional Funds Available. She stated that the money that is on the table is for the time period of July through December of 2016. She explained that the Mental Health Association is floating the expenses for that program at this time which is approximately 20% of their budget. She explained the urgency for the approval of these funds for this wonderful program under the leadership of John Bourges. She thanked the Legislature for their public support of this program.

Lynne Eckardt, Town of Southeast Councilwoman, stated that regarding Recognition of the Public, she was not quite clear why this body will not entertain any questions from the public. She believed that the more open you are, the fewer questions you get. She also believed that there were many cases when answers are not even received when attending Committee meetings. She stated that she would like this body to consider opening up public comment question period at the end of this meeting.

Alexandra Ballantine, Town of Southeast resident stated that she wanted to comment on Items #6k, #6m and #6n which pertain to the Veterans Peer to Peer Program. She explained that this suicide prevention program caught her attention when addressed at the Rules Committee meeting and she appreciated Legislator LoBue's idea of addressing this at the next Rules meeting to better understand the scope of this program. She mentioned that there is a suicide prevention walk on October 23rd which starts at the Carmel Firehouse.

Item #9 – Recognition of Legislators

Legislator Gross wished everyone a "Happy Halloween."

Chairwoman Nacerino stated that she would like to close the meeting in memory of Patterson Judge King who passed away yesterday. She stated that his passing will be a great loss to the community.

Legislator Wright explained the he has known Judge King for most of his professional life. His wisdom and insight into his role on the bench was formed by his long service to the State Police which brought a perspective to his local judicial position.

Legislator Wright stated that regarding the comment on public recognition, he requested that some consideration be given going forward in the rules of the Legislature for 2017. He believed that having public comment on Legislative action after it has taken place, although better than no comment, certainly appears counterproductive. He believed that there may be occasions when the Legislature would benefit from information imparted by public comment on a particular item of legislation. He stated that if public comment is only going to be had on an input bases at the Committee level, he believed the rules should state that. He believed to allow public comment after the resolutions are passed almost serves no purpose other than to give the citizens a chance to say what is on their minds in spite of what we have already done.

There being no further business; at 7:58 P.M., Chairwoman Nacerino made a motion to adjourn; seconded by Legislator Albano. All in favor.
