NATIONAL SAFE BOATING MONTH – JUNE 2017

Item #6L – Resolution Urging State Representatives to Co-Sponsor and Pass Legislation that will Require the State to Fully Fund the Cost of any New Mandate or the Expansion of any Existing Mandates on Local Governments or Schools was next. On behalf of the members of the Audit & Administration Committee, Legislators Jonke and Sullivan, Legislator Castellano moved the following:

Legislator Scuccimarra stated that these mandates are crippling the County. She believed that we could do so much more with our budget if 73% were not going towards mandates.

Chairwoman Nacerino stated that it seems the State keeps imposing more and more each year with offering little or no relief.

RESOLUTION #129

RESOLUTION URGING STATE REPRESENTATIVES TO CO-SPONSOR AND PASS LEGISLATION THAT WILL REQUIRE THE STATE TO FULLY FUND THE COST OF ANY NEW MANDATE OR THE EXPANSION OF ANY EXISTING MANDATES ON LOCAL GOVERNMENTS OR SCHOOLS

WHEREAS, counties have long had a central role in the administration and financing of a wide variety of state programs; and

WHEREAS, many municipalities in New York State face significant fiscal challenges that are amplified by a slow economic recovery and a state imposed restriction on local revenues; and

WHEREAS, in most instances, the county fiscal challenges are directly tied to state imposed mandates and reduced state reimbursement; and

WHEREAS, this year's enacted state budget shifted \$39 million more to the county taxpayers to fund Foster Care, a program that the state requires counties to provide and local taxpayers to fund; and

WHEREAS, this year's budget also requires counties to expand Indigent Legal Defense Services and implement the state's provisions to raise the age of criminal responsibility, which will require counties to hire more staff and expand services; and

WHEREAS, this same budget requires counties and local governments to take actions that will reduce property taxes; and

WHEREAS, the hard cap on county Medicaid costs and pension reforms have been very helpful for local governments operations but more reform needs to be done to enable local governments to provide local services, pay for state mandates and stay under the state imposed property tax cap; and

WHEREAS, on January 13, 2017 and January 23, 2017 respectively, Senator Joseph A. Griffo and Assemblyman Anthony Brindisi, proposed legislation (S.2323/A.2922) that would require the State to fully fund the cost of any new mandate or the expansion of an existing mandate that is placed on local governments or schools; and

WHEREAS, passing this bill is a good first step in helping county and local government leaders to protect homeowners and businesses from increasing local taxes to pay for new and expanded mandates from the state; and

WHEREAS, Putnam County wishes to renew the "Mayday for Mandate Relief" campaign to call attention to the impact state mandates have on local property taxes; now therefore be it

RESOLVED, Putnam County asks Senator Terrence Murphy, Senator Sue Serino, Assemblywoman Sandy Galef and Assemblyman Kevin Byrne to consider co-sponsoring the proposed legislation (S.2323/A.2922) and ultimately to pass said legislation, which would require the State to fully fund the cost of any new mandate or the expansion of an existing mandate that is placed on local government or schools; and be it further

RESOLVED, the Clerk of the Putnam County Legislature is directed to forward copies of this resolution to Governor Andrew M. Cuomo, Senator Terrence Murphy, Senator Sue Serino, Senator Joseph A. Griffo, Assemblyman Kevin Byrne, Assemblywoman Sandy Galef, Assemblyman Anthony Brindisi, NYSAC and all others deemed necessary and proper.

Item #6m – Approval/ Support of Putnam County's Limited Exemption of Sales and Use Tax on Purchases of Qualified Clothing and Footwear was next. On behalf of the members of the Audit & Administration Committee, Legislators Jonke and Sullivan, Legislator Castellano moved the following:

Legislator Castellano explained that this request has gone to the State for the last several years. He stated that we hope we receive a positive response this year.

Chairwoman Nacerino stated that she is very supportive of this and believed that any relief to our young families would be significantly helpful.

Legislator Gouldman stated that last year we approved the same resolution and it was approved out of the Senate, but not the Assembly. He hoped that this year the Assembly would do the right thing for Putnam County to help our families that would benefit from this legislation. He believed it was a wonderful idea and hoped that it would be approved in Albany.

RESOLUTION #130

APPROVAL/ IN SUPPORT OF PUTNAM COUNTY'S LIMITED EXEMPTION OF SALES AND USE TAX ON PURCHASES OF QUALIFIED CLOTHING AND FOOTWEAR

WHEREAS, pursuant to authority granted under Article 29 of the New York State Tax Law, Putnam County may elect to exempt from imposing sales and use tax on purchases of qualified clothing and footwear; and

WHEREAS, in accordance with Article 29 of the New York State Tax Law, the exemption of sales and use tax imposed by a County on purchases of qualified clothing and footwear is a year round commitment and a County's election or repeal of such exemption may only be effectuated annually on March 1st; and

WHEREAS, the County Executive proposes that a limited "sales tax free holiday," more specifically, exemption of Putnam County's sales and use tax collected on purchases of qualified clothing and footwear during a specific ten-day period in 2017, more particularly, August 14th through August 23rd, will, among other things, improve retail sales, realize cost benefits to retailers, create jobs and promote economic growth in Putnam County; and

WHEREAS, Bills were sponsored both in the Senate (Murphy-R) and the Assembly (Byrne-R) under Bill Nos. S305 and A07306, respectively, for an act to amend the tax law in relation to authorizing the County of Putnam to exempt from county sales and compensating use taxes purchases of qualified clothing and footwear during the period August 14-23, 2017; and

WHEREAS, the County Executive also proposes that in developing a limited "sales tax free holiday," Putnam County, working together in a private-public partnership with, among others, the Putnam County Chambers of Commerce and the Putnam County Economic Development Corporation (the "EDC"), will promote and encourage small business growth in Putnam County, which is ultimately in the best interests of Putnam County and its taxpayers; and

WHEREAS, the Putnam County Legislature supports and desires to implement the County Executive's proposal to effectuate a limited exemption of sales and use tax on purchases of qualified clothing and footwear; and

WHEREAS, the most effective manner of implementing such a change is for the Putnam County Legislature to request, as authorized under Municipal Home Rule Law

§10, that the New York State Legislature amend relevant New York State Tax Law such that Putnam County may elect to exempt from collection of the County portion of sales and use tax on purchases of qualified clothing and footwear and only for the limited period of August 14 through August 23, 2017; now therefore be it

RESOLVED, that the Putnam County Legislature hereby requests that the New York State Legislature adopt a Bill, in form and substance to the proposed Bill No. S305 and Bill No. A07306, annexed hereto, to amend New York State Tax Law Article 29 by the addition of a new subsection which would be applicable to Putnam County, permitting Putnam County to effectuate its election to exempt the County's portion of the sales and use tax on purchases of qualified clothing and footwear from August 14th through August 23rd, 2017, notwithstanding any other provision of law to the contrary; and be it further

RESOLVED, that the Putnam County Legislature authorizes the County Executive and the Clerk of the Legislature to file a Home Rule Message for this request under Assembly Bill No. A07306 and Senate Bill No. S305 for the Bill entitled "AN ACT to amend the tax law, in relation to authorizing the County of Putnam to exempt from county sales and compensating use taxes certain clothing and footwear, during the period commencing on August fourteenth and through August twenty-third, two thousand seventeen."
