Legislator Addonizio believed that many people did not realize the amount of work that goes into this program by the Putnam Arts Council.

Chairwoman Nacerino stated that they offer a diverse variety set of events that really lend to the culture of Putnam County.

RESOLUTION #43

APPROVAL/ PUTNAM COUNTY HAZARDOUS SPILL POLICY / LAW DEPARTMENT - SAFETY OFFICER

WHEREAS, the County of Putnam seeks to ensure that chemical spills that occur on both County owned roads and property are mitigated in compliance with New York State Department of Environmental Conservation regulations; and

WHEREAS, the County of Putnam is directly responsible for 116 linear miles of roads and operates several dozen facilities throughout County, which itself contains many reservoirs and lakes that provide drinking water for the lower Hudson Valley and the City of New York; and

WHEREAS, in acknowledgement of the environmental concerns resulting from emergency responses to motor vehicle incidents that result in the dispersal of petroleum products and other chemicals it is essential to take into consideration these factors when they occur; and

WHEREAS, this policy has been promulgated as a joint effort between the Putnam County Bureau of Emergency Services, the Putnam County Sheriff's Department, the Putnam County Highway & Facilities Department and the Putnam County Department of Law; and

WHEREAS, the Safety Committee also reviewed and approved said policy; now therefore be it

RESOLVED, that the Hazardous Spill Response Policy developed by the County is hereby adopted by the Putnam County Legislature in substantial compliance with the form attached hereto, provided that the Putnam County Law Department may from time to time amend said policy as it deems necessary, so long as said changes do not materially alter the policies and procedures contained therein.

WHEREAS, County Boards of Elections are responsible for managing election operations, and paying for all or most of the costs of these operations; and

WHEREAS, it is anticipated the Governor's proposed 2017-18 State Budget will require counties to provide and staff early voting sites for all New York residents; and

WHEREAS, last year's Executive Budget also included a plan for early voting that called for early voting hours and access up to 12 days prior to all special, primary, and general elections; and

WHEREAS, this proposal also required polling places be open at least eight (8) hours per weekday (with extended hours at least twice a week) and at least five (5) hours per weekend or holiday during the early voting period; and

WHEREAS, Putnam County takes great pride in their ability to provide quality and efficient services to the people on behalf of the State of New York but due to the State's imposed real property tax cap counties can no longer be required to expand services without accompanying compensation; now therefore be it

RESOLVED, that if the Governor and State Legislature agree to the early voting provisions proposed in the Executive Budget, the State must reimburse counties for the added costs of this new mandate; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature forward copies of this resolution to Governor Andrew M. Cuomo, Senate Majority Leader John Flanagan, Assembly Speaker Carl Heastie, Senator Susan Serino, Senator Terrence Murphy, Assemblywoman Sandra Galef, Assemblyman Kevin Byrne and NYSAC.

WHEREAS, the U.S. Census Bureau's Local Update of Census Addresses Program (LUCA) is the only opportunity offered to tribal, state, and local governments to review and comment on the U.S. Census Bureau's residential address list for their jurisdiction prior to the 2020 Census; and WHEREAS, the Census Bureau relies on a complete and accurate address list to reach all living quarters and associated population for inclusion in the census; and

WHEREAS, by participating in LUCA it helps ensure an accurate decennial census count in communities across New York State; and

WHEREAS, decennial census counts help the federal government distribute more than \$400 billion in funds annually for infrastructure, programs, and services; and

WHEREAS, the decennial helps communities plan for future needs and deal with population based programs; and

WHEREAS, the decennial population counts affect state and federal congressional representation and redistricting; and

WHEREAS, this process has resulted in increased numbers and accuracy in deliver of the Census short form, thereby increasing participation rates and accurate counts for the past decennial Censuses; now therefore be it

RESOLVED, that Putnam County supports efforts to allocate New York State resources and funding to Regions, Counties and Municipalities that to take part in the U.S. Census Bureau Local Update of Census Addresses Program and calls on Governor Cuomo and state leadership to commit to prioritizing local efforts for the local revision of the Census Master Address File and the Local Update of Census Addresses Program; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature forward copies of this resolution to Governor Andrew M. Legislator LoBue stated that Putnam County is one of the 51 counties in New York State that are mandated to operate a Motor Vehicle office. She explained that the State takes 87.3% of all fees collected from the work performed by the County operated DMV.

RESOLUTION #46

APPROVAL/MEMORIALIZATION/ NYSAC RESOLUTION CALLING FOR AN INCREASE IN THE SHARE OF REVENUE COUNTIES RETAIN FOR PROVIDING STATE DMV SERVICES

WHEREAS, New York County Clerks play a historic and important role as public servants; and

WHEREAS, along with the Sheriff and District Attorney, the County Clerk is one of three (3) county officials named in the State Constitution; and

WHEREAS, over 240 years later, the role of the County Clerk as the chief record and filing officer for the county have remained consistent, but their duties have grown much more complex with changes in population, technology, and the state's laws, policies and regulations; and

WHEREAS, today 51 of the 62 New York Counties are mandated by the State to operate a local Department of Motor Vehicles (DMV) Office; and

WHEREAS, this local DMV operation is one of many examples of shared services that counties provide for the state; and

WHEREAS, under current law the State of New York takes 87.3 percent of all fees collected from the work performed by the county operated DMV's; and

WHEREAS, the remaining 12.7 percent county share has not been increased in that same time period; and

WHEREAS, the Governor and the State Legislature have repeatedly stated that lowering the property tax burden on local residents is a key priority; and

WHEREAS, increasing the county DMV revenue sharing rate with the state will not result in any increased costs or fees to local residents or taxpayers and will provide counties with needed revenue to continue to provide necessary local government services; and

WHEREAS, there is a clear inequity present when a county DMV provides all the services, including overhead and staffing needs to fulfill these DMV services needed for state residents, yet the State takes 87.3 percent of the revenue generated from providing these services; and

WHEREAS, the State Senate recognized this inequity placed on counties and attempted to reduce the burden of local property taxpayers by overwhelmingly passing Senator Richie's bill S.4964, which would raise the 12.7 percent county share up to a 25 percent share; and

WHEREAS, the counties recognize the important function of the state DMV in providing both support to counties and resident services; accordingly, any loss in state DMV operational budget that occurs from an increased county revenue should be made whole through the State General Fund; now therefore be it

RESOLVED, that Putnam County calls on Governor Andrew M. Cuomo and members of the State Legislature to require a substantial increase of the county DMV revenue share with the State; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature forward copies of this resolution to Governor Andrew M. Cuomo, Senate Majority Leader John Flanagan, Assembly Speaker Carl Heastie, Senator Susan Serino, Senator Terrence Murphy, Assemblywoman Sandra Galef, Assemblyman Kevin Byrne and NYSAC.

APPROVAL/SUPPORT OF THE HUDSON RIVER WATERFRONT ALLIANCE

WHEREAS, the Hudson River is a federally designated American Heritage River for which special consideration must be given to the effects of actions taken on, around or within the River on the natural, historic, economic and cultural needs of the surrounding communities; and

WHEREAS, in June 2016, the U.S. Coast Guard announced that it was soliciting comments and concerns from the public in an Advanced Notice of Public Rulemaking (ANPRM), Docket #USCG-2016-0132, on a proposal to establish a large number of anchorage grounds for commercial vessels in the Hudson River – 43 berths in 10 locations from Yonkers to Kingston – at the request of shipping industry; and

WHEREAS, by Resolution #197 of 2016, which was adopted by the Putnam County Legislature ("Legislature") on October 4, 2016, the Legislature strongly opposed the adoption of proposed United States Coast Guard Rule 2016-0132 and urged the scheduling of public hearings throughout the Hudson River Valley; and

WHEREAS, the Coast Guard's proposed extension of Hudson River anchorage sites will reverse the pattern of restoring economic and environmental prosperity of the River and its surrounding communities; and

WHEREAS, the Hudson River Waterfront Alliance ("HRWA") was created in recognition of the concern for the economic vitality, environmental health and public safety of the Hudson River and its surrounding communities; and

WHEREAS, the HRWA is committed to the collaborative examination of the local and regional impacts of the proposed anchorages sites; to providing information regarding the proposal to residents and stakeholders; and to utilizing its collective resources to protect and preserve the interest of the Hudson River Communities; now therefore be it

RESOLVED, that the Putnam County Legislature hereby endorses and supports the Hudson River Waterfront Alliance; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature shall forward copies of this resolution to all of the municipalities who are members of the HRWA.

Item #6k – Approval/Memorialization/NYSAC Resolution Calling on the State of New York to Fully Reimburse Counties for District Attorney Salary Increases that are Set and Controlled by the State was next. On behalf of the members of the Personnel Committee, Legislator Albano and Jonke, Chairwoman Nacerino moved the following:

Chairwoman Nacerino explained that the salary increases for the District Attorney are State mandated and are in conjunction with the increases for Judicial salary compensation. She explained that this State mandate offers no relief to the counties and therefore Putnam County is seeking relief to do so to offset our budget.

RESOLUTION #50

APPROVAL/MEMORIALIZATION/NYSAC RESOLUTION CALLING ON THE STATE OF NEW YORK TO FULLY REIMBURSE COUNTIES FOR DISTRICT ATTORNEY SALARY INCREASES THAT ARE SET AND CONTROLLED BY THE STATE

WHEREAS, on December 24, 2015, New York State Commission on Legislative, Judicial, and Executive Compensation voted to recommend increasing all state judge salaries in 2016 and 2018; and

WHEREAS, the recommended increase placed Supreme Court Judges' salaries at \$193,000 in 2016 and \$203,000 in 2018 and placed County Court Judges' at 95% of a Supreme Court Justice's salary; and

WHEREAS, on April 1, 2016 the state approved the Commission's recommendation; and

WHEREAS, New York State Judiciary Law Section 183-a links judicial salaries to county District Attorney (DA) salaries to be equal or higher than either the County Court Judge or Supreme Court Judge in a county, depending on county size and full-time or part-time status; and

WHEREAS, historically, for over 50 years, the state has fully funded all District Attorney salary increases that they imposed on the counties; and

WHEREAS, the District Attorneys Association of the State of New York (DAASNY), recognizing the automatic nature of these increases and its effect on local county budgets, and further to support the counties' position, requested in correspondences with state officials that the state fund this salary increase as well; and

WHEREAS, on April 1, 2016 the State Legislature enacted a \$150 billion State Budget, but did not include the funding for the \$1.6 million in reimbursement costs for the increase in District Attorney salaries: and

WHEREAS, this salary increase recommendation occurred well after all counties set their 2016 budgets in law resulting in a direct cost shift from the state to county taxpayers; and

WHEREAS, the state has been careful over the past few years to avoid shifting costs to the local tax base, mindful of the impact locally with the state imposed property tax cap; and

WHEREAS, for some counties, this salary increase represented approximately one-third of their total allowable property tax growth for all government operation in 2016; now therefore be it

RESOLVED, the Putnam County calls on the State of New York to fully fund this mandated salary increase as part of the 2017-18 budget, including a one-time amount for the retroactive salary increase that was not funded last year; and be it further

RESOLVED, that Putnam County calls on the state to pay for this increase and any similar state mandated salary increase in future years; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature forward copies of this resolution to Governor Andrew M. Cuomo, Senate Majority Leader John Flanagan, Assembly Speaker Carl Heastie, Senator Susan Serino, Senator Terrence Murphy, Assemblywoman Sandra Galef, Assemblyman Kevin Byrne and NYSAC.

Legislator LoBue questioned why this budgetary amendment went to the Audit Committee meeting and not to the Physical Services Committee.

Legislator Castellano stated that it was time sensitive.

Legislator LoBue stated that the backup material shows that there is a net profit of \$137,500. She stated that it does not show the debt service or the chargeback for County employees. She believed that the debt service was climbing over \$600,000.

Legislator Sullivan stated that the amount of \$137,500 mentioned by Legislator LoBue was the proposed 2016 amount. He stated that what was discussed at the Audit Committee meeting was that the net profit at the Golf Course was actually \$214,164. He explained that was one of the reasons why they approved some of these funds to be spent on equipment.

Chairwoman Nacerino concurred and stated that the discussion was that we were reinvesting some of the revenue to be utilized towards the purchase of badly needed equipment in order to keep the Golf Course grounds in good condition.

Legislator LoBue addressed Legislator Sullivan's comment and stated that there was not profit because expenditures were higher than what has come in. She stated that the debt service is over \$600,000 and that was without the chargeback of County employees.

Legislator Albano stated that he did not know where we chargeback for County employees on many of our projects. Their time is utilized where it is necessary.

Legislator LoBue stated that it is a cost against the facility. She stated that there were three (3) separate contracts for this facility. She stated that we were not making a profit and we were continuing to invest money into something that was not making money.

Legislator Albano stated that there was a great improvement to the profitability of the Golf Course over the last few years. He explained that the equipment being ordered was necessary in order to maintain the Golf Course's level of quality. He believed our Golf Course has done very well compared to many other golf courses that have seen a decline in patrons.
