Chairwoman Nacerino explained that the retiree health insurance premium percentage shall not be increased due to an increase in a retiree's pension amount as a result of a Cost of Living Adjustment (COLA).

RESOLUTION #93

APPROVAL/ AMENDMENT TO RESOLUTION #227 OF 2015 SECTION D(1)(A) RETIREE HEALTH INSURANCE BENEFITS / SECTION E(1)(A) & E(1)(B) RETIREE REQUIREMENTS

WHEREAS, the Putnam County Legislature has, on numerous occasions in the past, considered the issues surrounding the mounting costs of health insurance for both its employees and retirees; and

WHEREAS, the Legislature has addressed the increased costs to the taxpayers of Putnam County for providing health insurance to its retirees by adopting a comprehensive contribution structure; and

WHEREAS, it has recently come to the attention of the Legislature that the application of the New York State & Local Retirement System's cost of living adjustment as calculated annually by the New York State Comptroller's Office and issued in September of each year may cause a retiree's contribution level to escalate over time; and

WHEREAS, upon further discussion and evaluation it is the desire of the Legislature not to require retirees to contribute more than the initial percentage calculated under the adopted formula; and

WHEREAS, the Legislature desires to insure that a balance be maintained between the provision of health insurance benefits to Retirees and the cost of providing those benefits to the taxpayers of Putnam County; now therefore be it

RESOLVED that Section D(1)(a) of Resolution 227 of 2015 be amended as follows:

"All current Retirees shall be provided a retirement health insurance benefit in accordance with the following contribution schedule, which amount shall be calculated at the full year amount at time of retirement and shall not be increased due to an increase in a retiree's pension amount as a result of a Cost of Living Adjustment (COLA) thereafter:

| Annual Amount of Pension Benefit | Amount of Premium Payable by Retiree |

| \$40,000 - \$64,999 | 25% |

And be it further

RESOLVED that Section E(1)(a) shall be amended to read as follows:

"Any Retiree receiving health insurance benefits in retirement, as well as any newly retired employee receiving such health insurance benefits in retirement, shall provide the County with a copy of the letter from the New York State and Local Retirement System which outlines the completed calculations and final retirement allowance for said Retiree, or any one of the documents required in subsection (b) below."; and be it further

RESOLVED, that Section E(1)(b) shall be amended to read as follows:

"All Retirees shall be required to provide the Commissioner of Finance with a W-2, 1099 or other proof of income form by no later than March 1st of the first year following retirement, unless otherwise required to be provided by the Commissioner of Finance or in accordance with Subsection (a) above."; and be it further;

RESOLVED, that the remaining provisions and subsections of the aforementioned Resolution shall remain in full force and effect.

On behalf of the members of the Health, Social, Educational & Environmental Committee, Legislators Addonizio and Gouldman, Legislator Scuccimarra moved the following:

Legislator Addonizio stated that she supported this much needed legislation. She stated that it costs Putnam County over \$9 million for Medicaid.

RESOLUTION #95

APPROVAL/MEMORIALIZATION/ERIE COUNTY RESOLUTION/PROPOSAL TO REQUIRE NEW YORK STATE TO COVER THE FULL COSTS OF MEDICAID

WHEREAS, municipalities across New York State struggle to find a balance between funding mandated programs and supporting local infrastructure investment or lowering the tax burden on residents; and

WHEREAS, for fiscal year 2015, nine (9) State mandates consumed 99% of the property tax levy in counties outside of New York City; and

WHEREAS, this severely limited funding for other vital programs tailored to fit the needs of local municipalities and school districts; and

WHEREAS, one (1) of the most burdensome expenses forced on counties is the cost of Medicaid services; and

WHEREAS, Medicaid costs are the largest mandated expense for local governments and \$7 billion of the total \$27 billion spent in New York State on Medicaid comes from counties; and

WHEREAS, on a nationwide basis, local governments fund \$9.7 billion worth of Medicaid expenses each year; and

WHEREAS, Putnam County has sent the State more than \$9 million to cover Medicaid costs in 2016; and

WHEREAS, New York State has been politically unwilling or unable to provide any meaningful mandate relief for the residents of Putnam County; and

WHEREAS, Congressman Chris Collins has introduced legislation that would amend the replacement for the Affordable Care Act to provide for relief at the local level by preventing States from imposing Medicaid costs on local municipalities outside of New York City; and

WHEREAS, forcing New York State to take over Medicaid costs would save the 57 counties outside of New York City a combined total of \$2.2 billion in property taxes, almost as much as the combined total of all other counties in the nation: and

WHEREAS, such a measure would allow counties in New York State the opportunity to lower property taxes for their residents decreasing the costs to live in our State and hopefully spur new private investment here in Putnam County; and

WHEREAS, New York State has failed to make any meaningful reform of Medicaid costs and as a result, the State is second in the nation for overall Medicaid spending at \$60 billion and second in the nation for each recipient with an average of \$10,426 per person, per year; and

WHEREAS, this spending has been forced onto the counties in New York, limiting the impact of Medicaid spending in the State's budget thereby allowing the State to further increase costs; and

WHEREAS, this self-repeating cycle of increasing mandated services and then passing their costs onto counties with no recurring funding source must stop; now therefore be it

RESOLVED, that Putnam County supports Congressman Chris Collins' proposal to require New York State to cover the full costs of Medicaid as opposed to forcing them on local municipalities; and be it further

RESOLVED, that the Putnam County Legislature urges Governor Cuomo to work with Putnam County on other cost saving measures and mandate relief; and be it further

RESOLVED, that that the Clerk of the Putnam County Legislature forward copies of this resolution to Governor Andrew M. Cuomo, Congressman Sean Patrick Maloney, Senate Majority Leader John Flanagan, Assembly Speaker Carl Heastie,

Senator Susan Serino, Senator Terrence Murphy, Assemblywoman Sandra Galef and Assemblyman Kevin Byrne.

BOND RESOLUTION OF THE COUNTY OF PUTNAM, NEW YORK, ADOPTED MAY 2, 2017, AUTHORIZING THE ACQUISITION OF VARIOUS VEHICLES AND EQUIPMENT FOR THE HIGHWAY DEPARTMENT; STATING THE ESTIMATED TOTAL COST THEREOF IS \$983,000; APPROPRIATING SAID AMOUNT THEREFOR, INCLUDING THE EXPENDITURE OF \$483,000 IN FUNDS EXPECTED TO BE RECEIVED FROM THE STATE OF NEW YORK; AND AUTHORIZING THE ISSUANCE OF \$500,000 SERIAL BONDS OF SAID COUNTY TO FINANCE THE BALANCE OF SAID APPROPRIATION.

THE COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Legislature) AS FOLLOWS:

Section 1. The County of Putnam, New York (herein called "County"), is hereby authorized to acquire various vehicles and equipment for the highway department, including (a) various heavy equipment, the aggregate estimated cost of \$715,000 (b) various light equipment, at the aggregate estimated cost of \$120,000 and (c) various other equipment, at the aggregate estimated cost of \$148,000. The estimated total cost of such class of objects or purposes, including preliminary costs and costs incidental thereto and to the financing thereof, is \$983,000 and said amount is hereby appropriated therefor. The plan of financing includes the expenditure of \$483,000 in

funds expected to be received from the State of New York and the issuance of \$500,000 serial bonds of the County to finance the balance of said appropriation, and the levy and collection of taxes on all the taxable real property in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the County in the principal amount of \$500,000 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance a portion of said appropriation.

Section 3. (a) The period of probable usefulness of the class of objects or purposes for which said bonds are authorized to be issued pursuant to Section 1(a) of this resolution, within the limitations of Section 11.00 a. 28 of the Law, is fifteen (15) years.

(b) The period of probable usefulness of the class of objects or purposes for which said bonds are authorized to be issued pursuant to Sections 1(b) and (c) of this resolution, within the limitations of Section 11.00 a. 89 of the Law, is five(5) years.

Section 4. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the County for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the County, payable as to both principal and interest by general tax upon all the taxable real property within the County. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds having substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and Sections 50.00, 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the County Legislature relative to authorizing bond anticipation notes, or the renewals thereof, and relative to providing for substantially level or declining annual debt service, and prescribing the terms, form and contents, and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, as well as to executing agreements for credit enhancements, are hereby delegated to the Commissioner of Finance, the chief fiscal officer of the County.

Section 7. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 8. This bond resolution shall take effect upon the approval of the Putnam County Executive, and the Clerk of the County Legislature is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in "The Putnam County Courier," "The Putnam Press," and "The Putnam County News & Recorder," three newspapers, each having a general circulation in the County and hereby designated as the official newspapers of the County for such publications.

Section 115-6(E)

Any Pet Seller, Pet Dealer, Pet Store, Animal Shelter or other individual or entity located in Putnam County, or any authorized agents thereof, who violate Section 95-14 115-5 of this Local Law, shall be guilty of a violation and subject to a maximum fine of \$250. It shall not be a violation of this law if the Pet Seller, Pet Dealer, Pet Store, Animal Shelter or other individual, entity or any authorized agents thereof, checked with the Registry and the name did not appear thereon.

Section 2.

Section 115-6(F) of the Putnam County Code is hereby amended to read as follows:

Section 115-6(F)

Any Pet Seller, Pet Dealer, Pet Store, Animal Shelter, or other individual or entity located in Putnam County, or any authorized agents thereof, who a second time within two years violates Section 95-14 115-5 of this Local Law shall be guilty of a Class "A" misdemeanor.

Section 3.

Section 115-7 of the Putnam County Code is hereby amended to read as follows:

Section 115-7. Applicability.

This law shall apply to all persons convicted of animal abuse crimes as defined by Section 95-11 of Article III 115-2 of Article I, on or after the effective date of this article.

This local law shall take effect immediately.

WHEREAS, the total available State funding for this grant would be divided among all counties that apply; and

WHEREAS, the amount a County receives is based on a specific formula; and WHEREAS, there is no County match and the funds would be used towards Radio Communications; and

WHEREAS, at the April 17, 2017 Protective Services Committee meeting, the Putnam County Bureau of Emergency Services informed the Committee that \$482,829.00 was awarded to Putnam County under this New York State 2016 Statewide Interoperable Communications Grant Program (2016 SICG-Formula); and

WHEREAS, the performance period for the 2016-17 SICG grant will be 24 months from January 1, 2017 through December 31, 2018 and expenses that the County wishes to claim must occur within that period; and

WHEREAS, the Audit & Administration Committee has reviewed and approves of this application; now therefore be it

RESOLVED, that the Putnam County Legislature approves and authorizes the Putnam County Bureau of Emergency Services to apply for the \$482,829.00 awarded under the Round 5 Statewide Interoperable Communications Grant Program.

Item #7 - Other Business

Item #7a – Approval/Home Rule Request/ Assembly Bill A7048A / Senate Bill S5359 – 2017 was next. Chairwoman Nacerino moved the following; seconded by Legislators Addonizio and Albano.

Legislator LoBue stated that she would be voting "no" as she has done in the past. She believed that the sales tax rate should be reduced in order to be competitive with Connecticut and bring in more revenue.

Legislator Albano stated that everyone that lives in Putnam or travels through Putnam benefits from our roads and all that our County facilities provide. He stated that the

sales tax is an opportunity for everyone to participate in the monies needed to provide these services. He stated that without this extra 1% sales tax, there would be a shortage of approximately \$14 million in revenue. He stated that the only other place to generate that revenue would be from the property owners. He stated that with the 1% additional sales tax, everyone contributes, even people traveling through the County.

Legislator LoBue stated that the idea would be to institute cost controls and lower our spending in order to wean ourselves off this sales tax. She stated that a plan needs to be in place. She explained that the additional sales tax hinders economic development and it needed to be lowered.

Legislator Albano disagreed. He stated that if there was an opportunity to lower taxes it believed it should be property tax.

Legislator Castellano concurred with Legislator Albano. He believed that if taxes were going to be lowered it should be lowered for property taxpayers. He stated that the 1% additional sales tax is not something anyone likes; however, it is \$14 million in revenue. If there was a \$14 million hole in the budget, cuts would need to be made or the amount would come from the property tax owners. He believed the 1% was a fair way to distribute this tax to all people that come to Putnam County. He stated if the tax was eliminated, he did not believe there would be an increase in spending in Putnam County that would equate to \$14 million.

Chairwoman Nacerino concurred with Legislators Castellano and Albano. She stated that it is an overture to shift the burden from the property owner.

RESOLUTION #116

APPROVAL/HOME RULE REQUEST/ ASSEMBLY BILL A7048A / SENATE BILL S5359 - 2017

WHEREAS, by Resolution #27 of 2017 the Putnam County Legislature requested our State Senate and Assembly members to extend the additional 1% sales tax that is set to expire on November 30, 2017; and

WHEREAS, Assemblywoman Sandra Galef has introduced Assembly Bill A7048A to accomplish this request; and

WHEREAS, the Rules Committee of the New York State Senate has introduced Senate Bill S5359 to accomplish this request; now therefore be it

RESOLVED, that the Putnam County Executive and the Clerk of the Putnam County Legislature are authorized to file the annexed home rule request for Senate Bill S5359 and Assembly Bill A7048A entitled "AN ACT to amend the tax law, in relation to the imposition of sales and compensating use taxes in the county of Putnam."

Item #8 - Recognition of Public

Lynne Eckardt, Town of Southeast Councilwoman concurred with Legislator LoBue that the additional 1% sales tax was supposed to be temporary, which she believed has gone far beyond temporary. She believed it was a regressive tax. Although, it hits people

coming from out of town, it is also the wealthier tax at the same rate as our less fortunate citizens that have less money to spend and often are larger families. She believed that we needed to start looking forward as a County. In April we were the only County in the lower Hudson Valley where the house sale prices had declined. She stated that Putnam County has been declining in population. She believed that shopping habits have changed greatly. We are not as competitive as we should be with neighboring counties and we have the highest sales tax. She believed that it was the Legislature's duty to try to lower the tax burden on our residents; the sales tax extension was not doing that.

Item #9 - Recognition of Legislators

Legislator Albano wished all the mothers a "Happy Mother's Day."

Legislator LoBue stated that she would like to close the meeting in memory of Nicole O'Brien (Campanella) who lost her battle with cancer on April 18th. She stated that our thoughts and prayers are with her and her family.

Chairwoman Nacerino stated that she was a very special person who was very involved with Relay For Life.

There being no further business; at 7:43 P.M., Chairwoman Nacerino made a motion to adjourn; seconded by Legislators Albano and LoBue.
