WHEREAS, if grant funding is awarded to the County for its Project Proposal in connection with the aforesaid grant funding by the FTA, the maximum Federal contribution for capital project costs is eighty (80%) percent match, and fifty (50%) percent match for operating project costs, *to wit*:
