Legislator Albano believed this program cost a lot more than \$50,000. He believed they saved the County money in other areas.

Legislator Jonke stated that he reviewed minutes of the SPCA and he explained that he had some reservations about this so he would request a Roll Call Vote on this item.

Legislator Sullivan stated that he recently attended the SPCA's fundraising dinner and he stated that it was quite impressive how many individuals attended to show their support. He believed that the SPCA also took some of the work off the shoulders of our police agencies who are not equipped to handle those types of situations. He believed this was money well spent with the work that they do for the County.

Legislator Nacerino concurred. She stated that this is a small budget. She stated that they came to the County in recent years and each year they assume more and more responsibility in order to fight against animal cruelty. She stated that she would vote in favor of the increase.

Legislator Sayegh stated that the SPCA does a great job and all of our outside agencies do a stellar job. However, this year none of the outside agencies funding was increased therefore she did not want to separate one over another. She stated that she was not in favor of the increase.

Legislator Gouldman stated that the SPCA does a lot of work in Putnam Valley. He stated that he would support the increase.

Legislator Addonizio stated that she would be supporting this as well.

Chairman Castellano explained that he too attended the SPCA fundraising dinner and was overwhelmed by the amount of supporters and the great stories. He believed that there was a need for the SPCA in Putnam County and he appreciated what they do.

Item #4i – Cornell Cooperative Extension – Increase County Contribution \$5,000. Chairman Castellano made a motion to move the following:

Legislator Addonizio stated that Cornell Cooperative Extension is indispensable in Putnam County. She stated that the increase in County Contribution will help with program related expenses along with updated technology needs. She stated that these funds are not for any fringe benefits.

Legislator Nacerino stated that this was a tough decision. She respects everything that Cornell does; as she does for all of the non-profit agencies. However, she would be voting no for this increase. She stated that the County Executive proposed a budget with level funding. She stated that during the Committee meeting there was no request or rationale provided for an increase.

Legislator Albano stated that he was on the fence about this proposal also, however, he stated that they do a tremendous job and offer a great service to the County.

Legislator Sayegh stated that she also wrestled with this. She stated that they do a fantastic job; as do all of our non-profit agencies. However, she would like to keep level funding for the outside agencies this year.

Chairman Castellano stated that all the agencies do a tremendous job.

Item #5a – Consumer Affairs Department – Reduce Vehicle Line.

Legislator Sullivan made a motion to reduce the Vehicle line from \$25,000 to 20,000; seconded by Legislator Nacerino.

Legislator Sullivan stated that Consumer Affairs requested the purchase of an all-wheel drive vehicle. Legislator Sullivan believed that a front-wheel drive vehicle would suit their needs and as a result we could save \$5,000.

Legislator Gouldman concurred with the proposal.

Legislator Sayegh commended Legislator Sullivan for the creative way to lower the budget for the increase in outside funding.

Chairman Castellano thanked Legislator Sullivan to bringing this to our attention at the Budget & Finance meeting last week. He stated that he would have like to hear more from the department as to the need for this vehicle. He stated that he does like the idea of having an all-wheel drive vehicle for the County employees to make sure they get to where they need to be.

WHEREAS, the Putnam County Legislature has met and considered the Tentative Budget as submitted by the County Executive and has held a Public Hearing thereon pursuant to both Article 7.04(b)(4) of the Putnam County Charter and Section 359 of the County Law of the State of New York; and

WHEREAS, this Legislature has made certain adjustments to the Tentative Budget as submitted by the County Executive which are included as part of this budget adoption; now therefore be it

RESOLVED, that the Putnam County Legislature hereby adopts the Tentative Budget, as amended by this Legislature which sets forth the appropriations for the objects and purposes as specified, and further establishes the rates of compensation to be paid provided that said tentative budget as amended does not exceed the tax cap as provided for by state law; and be it further

RESOLVED, that this act takes effect on January 1, 2019.
