WHEREAS, Resolution # 30 of 2019, enacted by the Legislature on January 8, 2019, and approved by the County Executive on January 10, 2019, recognized that Panel had made significant progress toward providing information and recommendations to enable the Putnam County Legislature to set criteria and procedures for the award of, and the design for, a new Putnam County Service Medal; and said resolution extended the Panel's time to complete this important work to honor Putnam County's veterans through December 31, 2019, unless extended by subsequent resolution; and

WHEREAS, in 2019, the Panel recommended the design, and was authorized by the Legislature to begin production, of the Putnam County Service Medal, and

WHEREAS, in 2019, the Panel issued over 200 Putnam County Service Medals to eligible veterans; and

WHEREAS, the Panel has additional medals on hand that are available to award to eligible veterans; and

WHEREAS, the Panel wishes to continue to solicit and consider additional applications from, and award medals to, eligible veterans throughout the year 2020; now therefore be it

RESOLVED, that the Putnam County Veterans' Service Medal Advisory Panel shall be continued, and unless extended by subsequent resolution, the panel shall be dissolved and terminate all activity on December 31, 2020, on which date the panel shall deposit all records of its proceedings with the Clerk of the Legislature.

APPROVAL/LOCAL LAW TO AMEND THE CODE OF THE COUNTY OF PUTNAM CHAPTER 145, ENTITLED "ELECTRICIANS"

Be it enacted by the Legislature of the County of Putnam as follows:

Section I.

Chapter 145 of the Code of the County of Putnam is hereby amended as provided hereinafter:

CHAPTER 145

ELECTRICIANS

§ 145-1 Title.

§ 145-2 Legislative intent.

§ 145-3 Applicability.

Section II.

Section 145-4 of the Code of Putnam County is hereby amended to read as follows:

§ 145-4 Definitions.

For the purposes of this chapter, the following terms shall have the following meanings, unless otherwise indicated by context:

BOARD

The Board of Electrical Examiners for the County of Putnam as provided for by the provisions of this chapter.

BUSINESS ENTITY

As used in this chapter, the term "business entity" shall include any corporation, partnership, limited partnership or joint venture formed for the purpose of engaging in the business and/or trade of electrical work and low-voltage/limited-data communications.

COUNTY

All references to the "County" will be to the County of Putnam, unless otherwise indicated.

COUNTY EXECUTIVE

The County Executive of Putnam County.

DEMOLITION

Any and all removal, relocation, disconnection or disassembly of electrical equipment, live or dead.

DIRECTOR

The Director of the Putnam County Office of Consumer Affairs/Weights and Measures/Trades Licensing and Registration.

ELECTRICAL WORK

The installation, erection, alteration or repair of electrical wiring, apparatus, fixtures, devices or other equipment used or to be used for the transmission of electricity for electric light, heat, cooling, power (including solar), signaling, communication, alarm or data transmission.

FIXED MEMBERSHIP

A specific number of memberships established in the rules governing an organization. Specifically, the fixed membership of the Board of Electrical Examiners is nine.

HELPER

A person who is registered in Putnam County while employed by and working under the supervision of a licensed master electrician or journeyman electrician.

JOURNEYMAN ELECTRICIAN

A person who has successfully completed an examination for licensure as a journeyman who works within the County and is employed by and works under the supervision of a licensed master electrician, with a minimum of 10,000 (ten thousand) hours of experience as a helper or equivalent.

LEGISLATURE

The Putnam County Legislature.

LICENSE

A license issued by the Board to persons who have successfully completed an examination for master electrician, special electrician, low-voltage/limited-data communications technician and journeyman electrician as provided for by the provisions of this chapter. The terms 'licensed' or 'licensing' as used in this chapter shall also specifically refer to a Putnam County issued license.

LOW-VOLTAGE/LIMITED-DATA COMMUNICATIONS TECHNICIAN

Any person with a minimum of 8,000 hours' experience who has successfully completed an examination for licensure in low-voltage/limited-data communications technician, who furnishes and/or installs, repairs, maintains or alters cabling systems for computer networking, telecommunications, cable television, intercom, audio/video, fiber optics, video surveillance systems and any other system operating at 90 volts or less and a maximum of five amperes where such work commences at an outlet receptacle or connection previously installed by a person holding the proper electrical license. For purposes of this definition, any master electrician is qualified to do the work of a low-voltage/limited-data communications technician.

LOW-VOLTAGE NEW YORK STATE ALARM INSTALLER

Any person licensed by the State of New York as provided in Article 6-D of the New York State General Business Law for installing fire and security systems along with associated equipment.

MASTER ELECTRICIAN

Any person who has successfully completed a minimum of 10,000 hours' experience as a helper and a minimum of 5,000 hours' experience as a journeyman electrician (or their equivalent), who has successfully passed an examination for licensure as a master electrician and who performs or supervises the installation, erection, extension, alteration and/or repair of electrical wiring, apparatus, fixtures, devices or other equipment utilized or designed for the utilization of electricity for light, heat, cooling, power (including solar) or signaling.

PERSON

For purposes of this chapter, the term "person" shall include an individual, partnership, corporation, business organization or other similar entity.

SPECIAL ELECTRICIAN

Any person who is in the exclusive employ of the owner, lessee or manager of particular buildings or other structural facilities and whose employment consists solely of the work of a licensed master electrician as defined herein.

SUBSTANTIAL EVIDENCE

Evidence that a reasonable mind could accept as adequate to support a conclusion; evidence beyond a scintilla.

Section III.

Section 145-6 of the Code of Putnam County is hereby amended to read as follows:

§ 145-6 Board of Electrical Examiners.

- A. Board established. There shall be a Board of Electrical Examiners ("Board") consisting of nine members, each of whom shall be a resident of the County or own a business within the County. (See definition of "fixed membership," § 145-4.)
- B. The Board shall interview all candidates for Board membership and submit its recommendations with all candidates' resumes to the Legislature.
- C. Board members shall be appointed by a majority vote of the Legislature. Board members shall serve a term of three years and at the pleasure of the Legislature.
- D. Composition of board. The composition of the Board shall be a representative group of people ranging from those with no experience to a master's level experience with the electrical trade or working as an electrician. However, the Board must contain at least one electrician at all times. At no time, shall the composition of the Board interfere with the viability of the Board to perform its duties and to adhere to its responsibilities. A representative group may include:
 - (1) Licensed, shelved, or former master electricians.
 - (2) Licensed, shelved, or former journeymen.
 - (3) General contractors who have been in business in Putnam County for a minimum of seven years.
 - (4) Representatives of New York State Electric & Gas (NYSEG), Central Hudson Gas & Electric (CHGE), Con Edison, or any successors in interest thereof.
 - (5) Licensed, shelved, or former low-voltage/limited-data communications technicians.
 - (6) Citizens who have never been licensed by the County of Putnam to perform electrical trade work or work as an electrician.
 - (7) Current or former Building Inspectors.
 - (8) Current members of an electrical union.
- E. Secretary. There shall be a Secretary to the Board who shall be appointed by the County Executive. The Secretary shall report to the Director of the Office of Consumer Affairs, Weights and Measures and Trades Licensing.

- F. Chairperson and Vice Chairperson. The Board, by majority vote of the fixed Board, shall elect a Chairperson and Vice Chairperson, each of whom shall serve a one-year term.
- G. Quorum. A majority of the fixed membership of the Board shall constitute a quorum for the transaction of business. A quorum may be achieved by members attending in person or by Board-approved electronic means that allow for simultaneous visual and aural communication throughout the entire deliberative session.
- H. Vacancies. In the event of a vacancy on the Board, the Board shall send its recommendation to the Legislature and the remainder of the vacating member's term shall be filled by appointment by the Legislature.
- I. Removal. A Board member may be removed by majority vote of the Legislature for misconduct or malfeasance in office, incompetence, incapacity, neglect of duty, chronic absenteeism, or other good and sufficient cause.

Section IV.

Section 145-9 of the Code of Putnam County is hereby amended to read as follows:

§ 145-9 Application and examination procedure.

- A. Written application. Written applications for licensure or registration as a master electrician, special electrician, low-voltage/limited-data communications technician, journeyman electrician or helper electrician shall be submitted to the Secretary of the Board on the form prescribed by the Board. At a minimum, each application shall set forth the applicant's name, residence address, business address, e-mail address (if applicable), telephone numbers and trade names plus such additional information concerning his or her qualifications and history, including any criminal record, as the Board may request. Applicants shall include satisfactory evidence to demonstrate to the Board that they are competent electricians and gualified to perform electrical contracting, construction and/or installation work; have working knowledge of electricity, including the laws, properties and functions of electricity and electrical apparatus; practical working knowledge of the National Electric Code and all other applicable provisions of Ohm's Law pertaining to the installation, repair and maintenance of electrical wiring and apparatus. All applications shall be signed by the applicant, whose signature shall be notarized. Applications must be made in the name of the individual seeking licensure. If the applicant is an officer, owner or employee of an electrical contracting business, partnership or corporation, then the application shall set forth the names of all officers and owners thereof as of the date of application.
- B. Proof of current and prior employment, qualifications and fitness for licensure. All applicants must provide proof of experience by providing documentation and information relating to current and prior employment, qualifications, education and fitness for licensure. Proof of employment must include the name and address of the current/former employer, the length of time the applicant worked for the current/former employer and the type of work the applicant performed while working

for the current/former employer. In addition, one or more of the following may be required for adequate proof of employment:

- (1) Resume;
- (2) A notarized letter from current/former employers itemizing residential and commercial experience;
- (3) Work logs; or
- (4) Social security records.
- C. Upon receipt of a complete application, including the application fee, for license testing, the Secretary shall forward a copy of the same to the Chairperson of the Board.
- D. Board review. Upon receipt of an application to test for a license, the Board shall review such application to ascertain whether or not the applicant possesses the minimum qualifications necessary. At the discretion of the Chairperson, a committee of Board members could be convened to review and vote upon an individual's application before being sent to the full Board for final review and vote. Once an affirmative vote of a majority of the fixed Board has been made, the applicant shall be permitted to take the licensing examination.
- E. Written examination.
 - (1) Either the Board or an approved testing agency shall provide written examinations. Should the Board administer the examination, it shall be monitored by at least two members of the Board, who shall sign their names to all parts of the applicant's examination. The date, time and place of testing shall be determined by the Board or the approved testing agency. The Board shall provide applicants with written notice of testing dates. Results of every examination administered under the provisions of this chapter shall be kept on file in accordance with the Putnam County's document retention policies.
 - (2) Passing grade. Applicants must receive a grade of 75% or higher on the written examination to qualify for licensure. Applicants shall be notified of the results of their written examinations within 30 business days after the date of the examination. Activation of licensure within one year of passing the exam is required.
 - (3) If, within one (1) year from application approval, the applicant wishes to retest, a reapplication fee must be submitted for each retest (see Fee Schedule). The fee for the examination itself is separately determined and handled by the testing entity.
 - (4) If, after one (1) year from application approval, the applicant has not passed the examination, a new complete application and application fee must be submitted to continue seeking licensure (see Fee Schedule). The fee for the examination itself is separately determined and handled by the testing entity.
- F. Fees. The fees for applications, licensing, renewal and other fees provided for under the provisions of this chapter shall be proposed by the Board and set by resolution of the Legislature. All fees collected under the provisions of this chapter are nonrefundable.

- G. Exceptions to testing requirements. For possible examination waiver, please see § 145-16, Reciprocity.
- H. Child support obligations. Under New York State General Obligations Law § 3-503, all applicants for a license or renewal license must complete a New York State Department of Labor Form GO 1, Appendix to a License Application, regarding the applicant's child support obligations.

Section V.

Section 145-10-a of the Code of Putnam County is hereby amended to read as follows:

- § 145-10-a Hiring, supervision and responsibility.
- A. No person who is licensed pursuant to this chapter shall hire any person to perform services of a journeyman electrician in Putnam County unless such person has obtained a journeyman electrician license pursuant to the requirements of this chapter.
- B. No person who is licensed pursuant to this chapter shall hire any person to perform services of a helper electrician in Putnam County unless such person has registered as a helper electrician under this chapter.
- C. Any licensed master electrician who has hired a licensed journeyman electrician or registered helper electrician to perform work must supervise such work as required by this chapter.
- D. No person who is licensed as a journeyman electrician may perform work within Putnam County unless such work is performed under the employment and supervision of a licensed master electrician.
- E. No person who is registered as a helper electrician may perform work within Putnam County unless such work is performed under the employment, direct supervision, and control of a licensed master electrician or in the presence of a licensed journeyman.
- F. A licensed master electrician shall respond to the Board's requests for specific employment information regarding the licensed journeymen and registered helper electricians employed by the licensed master electrician. The licensed master electrician must provide the specific information requested by the Board within the specified time frame of such request.

Section VI.

Section 145-19 of the Code of Putnam County is hereby amended to read as follows:

§ 145-19 Shelving of license.

Upon written request by any individual licensed under this chapter, a license may be shelved subject to the following:

- A. Proof that any open electrical permit applications have been closed.
- B. The granting of a request for shelved status shall not be deemed or otherwise considered a suspension of license.
- C. Shelved status may be granted for a period of one year.
- D. The period of shelved status shall commence upon expiration of the current year.
- E. On or before December 31 of each year of shelved status, the licensee must submit a shelving affidavit.
- F. A fee shall be assessed against the licensee during any period of approved shelved status.
- G. Licensees can shelve in consecutive years for a maximum of five years without Board approval. If the licensee wishes to extend shelving beyond five years, the licensee must submit a letter to the Board providing a satisfactory reason for continued shelving.
- H. A licensee granted shelved status must complete, prior to renewal, any applicable continuing education that may be required during the period of time the license is shelved.
- I. Upon reactivation, the licensee shall be required to complete a renewal application and pay the appropriate annual licensing fee regardless of the time remaining in the calendar year.
- J. Any licensee of a shelved license found working in Putnam County shall be deemed unlicensed. He/she shall be subject to fines and penalties as provided for in this chapter.

Section VII.

Section 145-20 of the Code of Putnam County is hereby amended to read as follows:

- § 145-20 Regulation of business.
- A. Licenses may not be issued in the name of a corporate or business entity. In the case of a corporation, partnership, limited partnership or joint venture, the individual(s)

who is responsible for the performance of work covered by this chapter on behalf of such corporation, partnership, limited partnership or joint venture, whether he/she is an employee, officer, owner, or shareholder of the same, must be individually licensed in accordance with the provisions of this chapter.

- B. Such licensed master electrician shall be solely responsible for the proper supervision and layout of any electrical work performed in the name of such business entity. Anyone performing work under such licensed master electrician must be a licensed journeyman electrician or a registered helper electrician.
- C. All such corporations, partnerships, limited partnerships or joint ventures must submit to the Board a certified copy of the applicable business certification as is on file with the Clerk of the County where such business entity maintains its principal place of business.
- D. Whenever a Putnam County licensed master electrician who represents or is employed by an electrical business entity severs his or her relationship or employment with such business entity, it shall be the responsibility of such person and the business entity to provide the Board with written notice of such action within 30 days after such separation. In such event, such business entity shall provide the Board with proof that another duly licensed master electrician is performing the actual work of the business. The failure of the licensee or the business entity to provide such notice and/or proof shall be deemed sufficient cause to deny issuance of a new license.

Section VIII.

This Local Law shall take effect immediately upon filing with the New York Secretary of State.

Item #5r – Approval/ Memorialization/ Imploring the State of New York to Immediately Amend or Delay Implementation of Bail and Discovery Reform Laws that will Endanger the People of New York and Reverse Decades of Bipartisan progress in Reducing Crime was next. On behalf of the members of the Protective Services Committee, Legislators Jonke, Nacerino and Sullivan, Chairman Castellano moved the following:

Chairman Castellano stated that it is taking away some of the power of the judges to make a decision on setting bails on any individual. He stated that we are asking New York State to delay the implementation of this and to take another look at this. He believed there were many issues that needed to be resolved.

Legislator Jonke stated that the presentation made by District Attorney Tendy at the Protective Services meeting was eye opening; along with Sheriff Langley's words that this is really scary for those of us in New York State. He stated, at the very least, we could let the State Legislature know where Putnam County stands on this bail reform.

Legislator Albano stated that it was sad that they didn't spend enough time on this to get it right. He believed they were jumping the gun and it was very obvious that there are potential issues.

Legislator Montgomery was hopeful that this resolution would delay the implementation. She explained that she spoke with many individuals such as the District Attorney, Sheriff and State representatives. She stated that we are speculating that this will cause great trauma for the County and she believed it may. Therefore, she believed we should advocate for what we want to see taken out of the law or put in the law. She believed that with any law there is room for amendments.

Legislator Jonke explained that in the resolve of the resolution is lists what we would like to see happen.

Chairman Castellano recognized Sheriff Langley and gave him the opportunity to make a statement since this would affect his department tremendously.

Sheriff Langley stated that he is already getting orders from the County and local courts to release inmates on December 31, 2019 and January 1, 2020. He explained that one of those individuals who was arrested for vehicular homicide has no ties to this Country whatsoever. He explained that this individual has multiple felonies; none of which meets the statutes for bail under the new bail reform that takes place.

Legislator Albano question if a letter could be sent to the State based on what the Sheriff has informed us.

Chairman Castellano explained that the resolution covers that and certainly we couldn't include every single example. He appreciated the Sheriff mentioning the example of how the bail reform law will affect Putnam County.

Legislator Albano made a motion to amend the resolution to include the example the Sheriff just stated; seconded by Legislator Jonke.

Chairman Castellano opened it up for discussion as to how we would word this properly by adding another paragraph.

Legislative Counsel Firriolo stated that the Whereas clause could memorialize what Sheriff Langley just stated. An individual who was arrested for a vehicular homicide with no ties to the Country will be released because of this change in the law. He stated that we could work with the Sheriff to make sure the details are correct. He believed that we shouldn't name the individual.

Legislator Montgomery stated that it does appear to be somewhat covered in the resolution as Legislator Jonke pointed out. She believed that we would have an opportunity to advocate for what we wanted to amend in this law. She stated when we

see what happens as a result of this law, she believe it will be critical how we communicate with lawmakers on the State level.

Legislator Addonizio stated that the memorialization is letting the State know that Putnam County does not agree with this law. She did not believe they would listen to us regarding making changes to the law. She stated that we hope that as more counties voice their concerns about the law, the State will reconsider it.

Chairman Castellano called for a Roll Call Vote to amend the resolution.

RESOLUTION #310

APPROVAL/ MEMORIALIZATION /IMPLORING THE STATE OF NEW YORK TO IMMEDIATELY AMEND OR DELAY IMPLEMENTATION OF BAIL AND DISCOVERY REFORM LAWS THAT WILL ENDANGER THE PEOPLE OF NEW YORK AND REVERSE DECADES OF BIPARTISAN PROGRESS IN REDUCING CRIME

WHEREAS, protecting the people from harm by enforcing the rule of law is the foundational role of government, and

WHEREAS, County governments are vested by the State of New York with the responsibility to protect the most vulnerable among us, including the socioeconomically disadvantaged, the disabled, the elderly, and children, and

WHEREAS, no group is more vulnerable than the victims of crime, and a just society demands that crime victims should be recognized as key participants within the criminal justice system and be treated with dignity, fairness, and respect, and,

WHEREAS, for the past twenty-five years the State of New York has committed itself to reducing crime, and has succeeded as evidenced by official U.S. Department of Justice Uniform Crime Reporting Statistics showing that New York transformed from the second most dangerous state in America in the early 1990s to the safest large state in America by the early 2000s, and

WHEREAS, in the final stages of adopting its FY 2020 budget, the State of New York enacted sweeping criminal justice reforms including the elimination of cash bail for many specific enumerated crimes and the imposition of stringent discovery mandates on police and prosecutors, and

WHEREAS, under bail reform, beginning January 1, 2020, judges will be stripped of their discretion to set bail for many specific enumerated crimes, which means those suspected of committing these crimes can no longer be held in jail after their arrest, regardless of the strength of the case against these defendants, or the length of the potential sentence faced by these defendants, or the extent of the harm allegedly caused by these defendants, and instead these defendants will be released back into the general public, and

WHEREAS, these crimes include those that result in the deaths of innocent people, including several subcategories of homicide and manslaughter, resulting in those responsible for these deaths being released back into the community of grieving families, and

WHEREAS, these crimes include Making a Terroristic Threat and Money Laundering in Support of Terrorism in the Third and Fourth degree, resulting in those alleged to have supported terrorism in this manner, or who have threatened to commit acts of terrorism, being released immediately from police custody, and

WHEREAS, these crimes include Promoting an Obscene Sexual Performance by a Child; Possessing an Obscene Sexual Performance by a Child; Failure to Register as a Sex Offender; and Patronizing a Person for Prostitution in a School Zone, resulting in suspected child predators being released and returning into our community, and

WHEREAS, these crimes include Aggravated Assault Upon a Person Less than Eleven Years Old; Reckless Assault of a Child by a Daycare Provider; Criminal Sale of a Controlled Substance to a Child; Abandonment of a Child; and Criminal Possession of a Weapon on School Grounds, resulting in those suspected to have physically harmed or endangered children in this manner being free from custody, and

WHEREAS, these crimes include Female Genital Mutilation; Stalking in the Second Degree; and Aggravated Harassment, resulting in those suspected of violating victims in this manner being returned to the community of those victims, and

WHEREAS, these crimes include Endangering the Welfare of a Vulnerable Elderly Person or an Incompetent or Physically Disabled Person, resulting in the potential for further endangerment of seniors and these defenseless individuals, and

WHEREAS, these crimes include Aggravated Cruelty to Animals; Torturing Animals and Injuring Animals, resulting in the immediate release of those suspected of deliberately injuring, torturing and killing animals, and

WHEREAS, these crimes include Assault in the Third Degree, Aggravated Vehicular Assault, and other crimes of physical violence against people, and

WHEREAS, these crimes include Burglary of a Residence, resulting in the immediate release of these individuals back into the neighborhoods they are suspected of targeting, and

WHEREAS, these crimes include Bail Jumping and Unlawfully Fleeing a Police Officer in a Motor Vehicle, resulting in release on recognizance of the very individuals who have demonstrated a propensity to evade the law, and

WHEREAS, all of the offenders mentioned heretofore are at risk of not showing up for court, thereby placing a burden on public employees who, under this law, are required to send multiple court appearance reminders to these offenders, as well as police officers and District Attorneys who must commit resources to tracking and pursuing those who evade prosecution, and

WHEREAS, all offenders who are currently being held in custody for nonqualifying crimes including those mentioned heretofore will be eligible for release from custody on January 1, 2020, and

WHEREAS, Putnam County Sheriff Robert Langley provided the Putnam County Legislature with a real-world example of the serious consequences of this new law, to wit, the required release of a person incarcerated in the Putnam County Jail on vehicular homicide charges who has no ties to the United States and is unlikely to return for trial; and

WHEREAS, the discovery mandates imposed by the State of New York will require police and District Attorneys, beginning January 1, 2020, to turn over voluminous trialrelated materials to defense attorneys within 15 days, creating a mandate that will inevitably not be achieved in some cases and may result in the inability of the People to properly prosecute cases against criminal defendants, and

WHEREAS, the office of New York State's chief law enforcement officer, Attorney General Letitia James, testified at a state legislative hearing on October 28, 2019, that there will be implementation difficulties because prosecutors across the state lack the resources required to fully comply with discovery mandates, and WHEREAS, the Attorney General's office further testified that their own office, which carries a limited criminal caseload, lacks resources required to fully comply with discovery mandates and consequently needs an additional \$10 million in state funding, and

WHEREAS, discovery reform will also result in an opportunity for defendants to gain access to crime scenes that may include a victim's residence, thereby giving defendants accused of burglaries, assaults, rapes and other crimes committed in victims' homes the right to return to those same homes, and

WHEREAS, the issues mentioned heretofore will undeniably impact past, present and future victims of crime in a negative manner, and in so doing, the bail and discovery reforms adopted by the State of New York will themselves further victimize these innocent individuals, and

WHEREAS, these bail and discovery laws, in their current form, represent a clear and present danger to society, will tilt the scales of justice in favor of suspected criminals and away from innocent crime victims, and risk reversing decades of bipartisan progress made by the State of New York in reducing crime, and

WHEREAS, the fundamental responsibility of governments to protect the vulnerable in society demands that the shortcomings of these laws be remedied prior to their effective date of January 1, 2020, now, therefore, be it

RESOLVED, that the Putnam County Legislature hereby implores the State of New York to immediately amend or otherwise delay implementation of these laws by convening an emergency session of the State Legislature, or by emergency executive authority, or by any other means deemed possible by the State, and to do so before December 31, 2019, and be it further

RESOLVED, that the following improvements to these laws be implemented as soon as possible:

- 1. Give judges the discretion to impose bail when appropriate for all of the crimes enumerated in this resolution;
- 2. Increase the discovery timeline from 15 days to a minimum of 45 days;
- Phase in discovery reform by applying these new mandates only to misdemeanors effective January 1, 2020, and then to felonies effective January 1, 2021, and repeal the provision that makes the new discovery mandates applicable to violations of the Vehicle and Traffic Law;
- 4. Require that court appearance reminders are sent not only to defendants but also to the victims of their crimes; and
- 5. Extend appropriate dignity, fairness and respect to crime victims by soliciting input from victim advocate organizations and considering their suggestions for improving these laws, and be it further

RESOLVED, that the Clerk of the Putnam County Legislature forward a copy of this resolution Congressman Sean Patrick Maloney, Governor Andrew Cuomo, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, Senator Susan Serino, Senator Peter Harkham, Assemblywoman Sandra Galef, Assemblyman Kevin Byrne and the New York State Association of Counties.

Item #5s – Approval/ Grant Application/ Sheriff's Department/ State and Municipal Facilities Capital Program (SAM) Grant was next. On behalf of the members of the Protective Services Committee, Legislators Jonke, Nacerino and Sullivan, Chairman Castellano moved the following:

Legislator Nacerino stated we approved the grant, however, utilizing funds is contingent upon having a policy in place.

Legislator Sayegh believed that Carmel and Kent Police already have license plate readers. She believed this made it more important to have some type of policy in place across the whole County.

Legislator Gouldman believed that license plate readers were beneficial tools for the police agencies. He stated that the Taconic Parkway and Route 9 is the most common route from Poughkeepsie to New York City. He believed that most of the drugs and illegal things that happen go up and down those routes.

Legislator Albano stated that he was in favor of them and believed they had tremendous potential if used properly. He stated that he would like to see a policy in place.

Legislator Sullivan stated that we are saying, before we install the license plate readers, that we have a procedure and policy in place to make sure the information collected is handled properly.

Chairman Castellano stated that time was of the essence on this grant application. He stated that he too would like to see a policy completed in the very future as was discussed in Committee meetings.

On behalf of the members of the Physical Services Committee, Legislators Albano, Gouldman and Nacerino, Chairman Castellano moved the following: Legislator Montgomery stated that after she made her comment at the Audit & Administration Committee, it appeared that she wasn't in favor of this. She stated that it is great to speculate how great this project is going to be and the potential for opportunities that this will bring. She stated that it will open up the roads of the Town of Southeast and economic prosperity for Danbury, Connecticut. However, she stated that we only learned of this in September. She stated that based on the discussion at the Audit Committee meeting there were many questions on how we will move forward on this project. She was looking forward in the future of receiving updates on a regular basis. She stated that she has to answer to her constituents who often ask how personnel or stipend positions are created. She stated that this stipend for a Project Manager came to us with no resume or job description. She would like to see more information provided in the future.

Legislator Jonke stated that he was comfortable giving a \$15,000 stipend to an employee in the Planning Department who has a background in transportation and planning to oversee this feasibility study.

Legislator Albano stated that the Metropolitan Transportation Authority (MTA)/ Metro-North Railroad (MNR), the New York Metropolitan Transportation Council (NYMTC) and the City of Danbury are all involved. He stated that he would like to see more information as we move forward; but this is the start.

Legislator Montgomery agreed that it was great to do this in-house, however, if she was a member of the public she would question why an employee of the Planning Department would need an extra stipend to perform a job related to planning. She did not know what Transportation Manager Tamagna's background was. She stated that she has a background in transportation and has a keen interest in this project because it involves the MTA and understanding how they work. She did not know why an employee would receive an extra stipend for work being done in-house.

Legislator Addonizio believed that Transportation Manager Tamagna went back to school and received a Master's degree in Planning.

Legislator Nacerino stated that he is being asked to do something extra that is above and beyond what his job duties are. She believed the stipend was well deserved. She stated, as Commissioner of Planning Fusco has stated, there will be many meetings for him to attend. She stated that he is Putnam County's representative; one of the many stakeholders in this project. She believed it would be unfair to imply that this should be something he should take on as part of his daily function.

Legislator Albano concurred. He stated that it is a stipend for work over and above his normal job duties.

Legislator Sayegh believed that it was well deserved. She stated as a manager he does not qualify for any overtime in any way, shape or form. She explained that traveling to attend meetings in New York City throughout the course of this project was well deserved.

Legislator Montgomery stated that these are all excellent points, however, she would like to see that information prior to having it before us to make the decision.

Chairman Castellano stated that Putnam County certainly needs a voice at the table and if this is the person that will receive the stipend, he believed he would do a great job. He stated that the Legislature does not need to approve this employee getting the position or stipend; management has done that.

Legislator Montgomery stated that we created a Climate Smart Coordinator, which she believed was a big job, however, we did not give that person a stipend.

BOND RESOLUTION OF THE COUNTY OF PUTNAM, NEW YORK, ADOPTED DECEMBER 18, 2019, AUTHORIZING THE REPLACEMENT AND/OR REHABILITATION OF VARIOUS COUNTY FACILITY ROOFS; STATING THE ESTIMATED TOTAL COST THEREOF IS \$1,327,500; APPROPRIATING SAID AMOUNT THEREFOR; AND AUTHORIZING THE ISSUANCE OF \$1,327,500 SERIAL BONDS OF SAID COUNTY TO FINANCE SAID APPROPRIATION.

THE COUNTY LEGISLATURE OF THE COUNTY OF PUTNAM, NEW YORK, HEREBY RESOLVES (by the favorable vote of not less than two-thirds of all the members of said Legislature) AS FOLLOWS: Section 1. The County of Putnam, New York (herein called "County"), is hereby authorized to replace and/or rehabilitate various County facility roofs. The estimated total cost of such class of objects or purposes, including preliminary costs and costs incidental thereto and to the financing thereof, is \$1,327,500 and said amount is hereby appropriated therefor. The plan of financing includes the issuance of \$1,327,500 serial bonds of the County to finance said appropriation, and the levy and collection of taxes on all the taxable real property in the County to pay the principal of said bonds and the interest thereon as the same shall become due and payable.

Section 2. Bonds of the County in the principal amount of \$1,327,500 are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called "Law"), to finance said appropriation.

Section 3. The buildings to be improved is of at least "Class C" construction, consequently, the period of probable usefulness of the class of objects or purposes for which said bonds are authorized to be issued pursuant to this resolution, within the limitations of Section 11.00 a. 12(a)(3) of the Law, is ten (10) years.

Section 4. The proceeds of the bonds herein authorized and any bond anticipation notes issued in anticipation of said bonds may be applied to reimburse the County for expenditures made after the effective date of this resolution for the purpose for which said bonds are authorized. The foregoing statement of intent with respect to reimbursement is made in conformity with Treasury Regulation Section 1.150-2 of the United States Treasury Department.

Section 5. Each of the bonds authorized by this resolution, and any bond anticipation notes issued in anticipation of the sale of said bonds, shall contain the recital of validity as prescribed by Section 52.00 of the Law and said bonds, and any notes issued in anticipation of said bonds, shall be general obligations of the County, payable as to both principal and interest by general tax upon all the taxable real property within the County. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds, and any notes issued in anticipation of the sale of said bonds, and provision shall be made annually in the budget of the County by appropriation for (a) the amortization and redemption of the bonds and any notes in anticipation thereof to mature in such year and (b) the payment of interest to be due and payable in such year.

Section 6. Subject to the provisions of this resolution and of the Law and pursuant to the provisions of Section 21.00 relative to the authorization of the issuance of bonds having substantially level or declining annual debt service, Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and Sections 50.00, 56.00 to 60.00 and 168.00 of the Law, the powers and duties of the County Legislature relative to authorizing bond anticipation notes, or the renewals thereof, and relative to providing for substantially level or declining annual debt service, and prescribing the terms, form and contents, and as to the sale and issuance of the bonds herein authorized, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, as well as to executing agreements for credit enhancements, are hereby delegated to the Commissioner of Finance, the chief fiscal officer of the County.

Section 7. The validity of the bonds authorized by this resolution, and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

(a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or

(b) the provisions of law which should be complied with at the date of the publication of such resolution, or a summary thereof, are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

(c) such obligations are authorized in violation of the provisions of the constitution.

Section 8. This bond resolution shall take effect upon the approval of the Putnam County Executive, and the Clerk of the County Legislature is hereby authorized and directed to publish the foregoing resolution, in summary, together with a Notice attached in substantially the form prescribed by §81.00 of the Law in *"The Putnam County Courier," "The Putnam Press,"* and *"The Putnam County News & Recorder,"* three newspapers, each having a general circulation in the County and hereby designated as the official newspapers of the County for such publications.
