Legislator Montgomery questioned why the purchase of these buses was not included in the Capital Projects Committee budget. She stated these buses are different than the Early Intervention buses being purchased for the same amount.

Commissioner Carlin stated these buses are being purchased with funding from the CARES Act, which has a deadline of the end of this year. He stated to stay within the deadline, the money is being spent now for these buses.

Legislator Montgomery stated since this purchase was not planned for in the Capital Projects budget, she questioned if there is an immediate need for these buses or if the County will have four (4) extra buses.

Commissioner Carlin stated the buses will be replacing older buses.

Legislator Montgomery stated she is unaware why this was not discussed in Capital Projects. She stated if the County is going to have four (4) more buses, service should be expanded to the west side of the County.

Legislator Albano stated these buses may not have been priority, therefore they were not included in the Capital Projects budget at this time.

Commissioner Carlin stated the federal buses have a minimum mileage that they run.

Legislator Montgomery stated her point is that four (4) buses are being purchased that were not originally planned for, which could be resulting in an excess of buses. She stated with he excess of buses, the service could be expanded, especially with this excess of funding from the CARES Act, which covers transportation costs.

Chairman Castellano stated the concerns raised by Legislator Montgomery will be looked into.
