APPROVAL/ PAYMENT IN LIEU OF TAXES FOR THE TOWN OF SOUTHEAST SOLAR PROJECT

WHEREAS, New York Real Property Tax Law § 487 incentivizes investment in renewable energy, by creating a real property tax exemption for the owners or developers of qualifying energy systems, in participating taxing jurisdictions; and

WHEREAS, Putnam County (the "County") is such a participating taxing jurisdiction; and

WHEREAS, NY RPTL § 487(9)(a) permits taxing jurisdictions to recoup a portion of the tax revenue that would otherwise be lost, due to such a tax exemption, by allowing the jurisdiction to enter into an agreement for payment in lieu of taxes, also known as a PILOT agreement, with owners or developers of qualifying energy systems; and

WHEREAS, the Town of Southeast is the owner of a certain property located at 85 Lower Mine Road in the Town of Southeast, designated as Tax Map No. 78.-1-104, (hereinafter the "Property"); and

WHEREAS, the Town of Southeast has awarded a contract to Ameresco, Inc. to lease the Property and construct, through Ameresco, Inc.'s wholly owned subsidiary, Lower Mine Road LLC, a solar energy system on the Property (hereinafter the "Project"); and

WHEREAS, Lower Mine Road LLC represents the Project is a qualifying energy system, as defined by NY RPTL § 487(1)(a); and

WHEREAS, the Town of Southeast and the Brewster Central School District have entered into a PILOT agreement for the Project (hereinafter the "PILOT Agreement"), attached hereto as Schedule "A", with Lower Mine Road LLC as the developer of the Project; and

WHEREAS, the PILOT Agreement requires the County's approval to be finalized; and

WHEREAS, in the absence of said PILOT agreement, Lower Mine Road LLC may obtain the full statutory exemption, as set forth in RPTL § 487, and, by entering said PILOT Agreement, the County will ensure that it receives payments mitigating the potential lost tax revenue; and

WHEREAS, the County desires to assist the Town of Southeast in its efforts to increase renewable energy production; and

WHEREAS, the Putnam County Legislature has reviewed the PILOT Agreement and believes it to be beneficial to the County and the public, in that it will incentivize the increase of renewable energy production within the County; now therefore be it

RESOLVED, the Putnam County Legislature approves the PILOT Agreement and authorizes the County Executive to immediately execute same; and be it further

RESOLVED, that this Resolution shall take effect immediately.

Item #6r – Approval/ Local Law to Amend Article V of Chapter 220 of the Code of Putnam County by Increasing the Income Threshold of the Senior Citizen Property Tax Exemption was next. On behalf of the members of the Rules, Enactments & Intergovernmental Relations Committee, Legislators Nacerino and Sayegh, Legislator Addonizio moved the following:

Legislator Addonizio explained that by increasing the income threshold of the senior citizen property tax exemption, it will allow more senior residents in Putnam County to qualify for the exemption. She stated that we currently have 898 homeowners that would qualify. She explained that there will be a three (3) year phase in period.

Legislator Jonke explained that, as someone who has been involved in the property tax business for the last 34 years, he believed this would truly have a positive impact on our senior citizen population. He stated that more seniors will be able to qualify for more exemptions on their property taxes, which includes school, town and county taxes. He stated that this will be very helpful to the senior population.

Legislator Sayegh explained that Putnam County has one (1) of the highest percentages of senior population throughout all the counties in New York State. She stated that this will be helpful to those individuals, especially if social security benefits increase next year.

Chairman Sullivan stated that he was glad to see the change which will benefit our senior population.

RESOLUTION #239

APPROVAL/ LOCAL LAW TO AMEND ARTICLE V OF CHAPTER 220 OF THE CODE OF PUTNAM COUNTY BY INCREASING THE INCOME THRESHOLD OF THE SENIOR CITIZEN PROPERTY TAX EXEMPTION

Be it enacted by the Legislature of the County of Putnam as follows:

Section 1.

§ 220-29 Exemption granted.

Pursuant to the provisions of the Real Property Tax Law, the real property owned by one or more persons, each of whom is 65 years of age or over, or real property owned by a husband and wife, one of whom is 65 years of age or over, shall be exempt from taxation up to a maximum of 50% of the assessed valuation thereof, as hereinafter provided.

§ 220-30 Schedule of exemptions.

A. All the provisions, conditions and requirements of § 467 of the Real Property Tax Law and amendments thereto shall apply to the application for and the granting of such exemption on the assessment rolls of the towns as they apply to the County of Putnam except that no exemption shall be granted if the income of the owner or the combined income of the owners of the property for the income tax year immediately preceding the date of making application for exemption is: for the year 2023, the sum of \$48,400 or

more; for the year 2024, the sum of \$53,400 or more; for the year 2025, the sum of \$58,400 or more.

B. Real property owned by persons 65 years of age or over shall be exempt from certain County taxes up to a maximum of 50%.

The income of the owner or the combined income of the owners of the property for income tax year immediately preceding the date of the application for exemption from all sources, as set forth in § 467 must be less than \$48,400 for the year 2023; \$53,400 for the year 2024; and \$58,400 for the year 2025. "Income tax year" shall mean the twelve-month period from which the owner or owners file a federal personal income tax return or, if no such return is filed, in the calendar year. When title is vested in either the husband or wife, the combined income of both may not exceed such sum.

§ 220-32 Applicability.

This article shall apply to the assessment roll as follows: for § <u>220-30B(1)</u> commencing for the year 2023 and for the taxable year 2023/2024; for § <u>220-30B(2)</u> commencing for the

year 2024 and for the taxable year 2024/2025; and for § <u>220-30B(3)</u> commencing for the year 2025 and for the taxable year 2025/2026.

§ 220-33 Penalties for offenses.

Any person or persons who willfully make a false statement in the application of this exemption shall be punishable by a fine of not more than \$100 and shall disqualify the applicant or applicants from further exemption for a period of five years.

§ 220-34 When effective.

This article shall take effect immediately.

Section 2.

This local law shall take effect immediately upon its filing with the NYS Secretary of State.

APPROVAL/ LOCAL LAW TO AMEND ARTICLE IX OF CHAPTER 220 OF THE CODE OF PUTNAM COUNTY BY INCREASING THE INCOME THRESHOLD OF THE DISABLED PERSONS PROPERTY TAX EXEMPTION

Be it enacted by the Legislature of the County of Putnam as follows:

Section 1.

§ 220-56 Statutory authority; exemption granted.

Pursuant to the provisions of § 459-c of the Real Property Tax Law (RPTL), real property owned by one or more persons with disabilities, as defined by RPTL § 459-c, Subdivision 2(b), or real property owned by a husband, wife or both or by siblings, at least one of whom has such a disability, and whose income, as defined herein, is limited by reason of such disability, shall be exempt from County real property taxation to the extent of 50% of the assessed valuation thereof as hereinafter provided.

§ 220-57 Maximum income.

All terms, conditions and requirements of RPTL, § 459-c, shall apply to the application for and the granting of such exemption on the assessment rolls of the towns as they apply to the County of Putnam, except that no exemption shall be granted if the combined

income of the owner or owners of the property for the income tax year immediately preceding the date of making application for exemption is: for the year 2023, the sum of \$48,400 or more; for the year 2024, the sum of \$53,400 or more; and for the year 2025, the sum of \$58,400 or more.

§ 220-58 Exemption schedule.

Pursuant to RPTL, § 459-c, real property owned by persons with disabilities shall be exempt from certain County real property taxes up to a maximum of 50% of the assessed valuation pursuant to the following schedules:

§ 220-59 Eligibility.

In order to qualify for an exemption pursuant to this article, the combined income of the owner or owners of the property for income tax year immediately preceding the date of the application for exemption from all sources, as set forth in § 459-c(5)(a) of Real Property Tax Law must be less than \$48,400 for the year 2023; \$53,400 for the year 2024; and \$58,400 for the year 2025. "Income tax year" shall mean the twelve-month period from which the owner or owners file a federal personal income tax return, or if no such return is filed, in the calendar year. When title is vested in either the husband or wife, or ex-husband or ex-wife is absent from the property due to divorce, legal separation or abandonment, then only the income of both may not exceed such sum, except where the husband or wife, or ex-husband or ex-wife is absent from the property due to divorce, legal separation or abandonment, then only the income of the spouse or ex-spouse residing on the property shall be considered and may not exceed such sum.

§ 220-60 Proof of disability.

In conjunction with the provisions of RPTL § 459-c, Subdivision 2(b) an award letter from the Social Security Administration evidencing receipt of Social Security Disability Insurance (SSDI) or supplemental security income (SSI) benefits; or the Railroad Retirement Board evidencing receipt of railroad retirement disability benefits; or a certificate from the State Commission for the Blind and Visually Handicapped stating that such person is legally blind shall be submitted as proof of disability.

§ 220-61 Application for exemption.

Application for an exemption pursuant to this article must be made annually by the owner or all the owners of the property, on forms prescribed by the State Board, and shall be filed in the Assessor's office on or before the applicable taxable status date; provided, however, that proof of permanent disability need be submitted only in the year exemption is first sought or the disability is first determined to be permanent.

§ 220-62 Applicability.

This article shall apply to the assessment roll for § <u>220-58A</u> commencing for the year 2023 and for the taxable year 2023/2024; for § <u>220-58B</u> commencing for the year 2024 and

for the taxable year 2024/2025; for § <u>220-58C</u> commencing for the year 2025 and for the taxable year 2025/2026, and the provisions of § 459-c of the Real Property Tax Law shall govern the granting of such exception notwithstanding any contrary provisions of such section.

Item #8 – Recognition of Public on Agenda Items

Eric Gross, Resident of Carmel and Reporter for the Putnam County Courier and Putnam County News & Recorder, congratulated the Commissioners of the Board of Elections on their appointments: Cathy Croft and Kelly Primavera. He provided some insight to the past 50 plus years and how Putnam County has called into the New York State Elections Services the results of the elections. He stated under the supervision of Cathy Croft, Kelly Primavera, Tony Scannapiecco, the late Bob Bennett and the Board of Elections Staff, there were only two (2) years when Putnam County was not the first to report the first election result and the first to report the final. He stated Putnam County has an "A+" team in the County's Board of Elections.

Jacqueline Annabi, Town of Putnam Valley Supervisor, expressed her appreciation for the approval of the conveyance of Tax Map No. 91.8-1-25 to the Town of Putnam Valley. She stated it will be a huge asset to the business district. She stated the demolition of the existing structure will be paid for from American Rescue Plan Act (ARPA) funds, there will be no cost to the taxpayers. She stated additionally the required testing of the site will be paid for from ARPA funding as well. She also expressed appreciation of the approval to increase the threshold income for the Seniors and the Disabled. She explained that this is an action to help our residents stay in our County. Legislator Montgomery stated as 2022 comes to a close there are literally hundreds of bills on the Governor's desk waiting to be signed into law. She stated the 175-year law does not consider the full measure of lost relationships etc. She stated the "Grieving Families Act" drew enormous bi-partisan support and passed both the New York State Assembly and Senate. She stated she was traumatized that the Chair of the Legislature, on the eve of the nineth (9th) anniversary of her husband's wrongful death, contacted her requesting she sign a letter to the Governor asking her to veto the "Grieving Families Act". She continued to explain her position on this matter.

Legislator Jonke stated he would like to thank both Legislators Albano and Sullivan for their service to Putnam County and he wished them well. He stated he too looks forward to working with the newly elected Legislators. He wished everyone a happy and safe holiday season.

Legislator Sayegh stated she too recognized Legislators Albano and Sullivan and congratulated them on this, their last Full Meeting. She stated she wished them success and stated their institutional knowledge will be missed. She recognized that Hanukkah would begin on December 18, 2022. She stated there has been a lot of antisemitism in our Country. She stated she stands with her Jewish friends and family and she was against antisemitism. She wished everyone a happy Hannukah and Merry Christmas.

Legislator Albano expressed his appreciation to his fellow Legislators for their kind words. He stated it has been a pleasure to serve as a Legislator for the past 12 years. He wished everyone a blessed holiday season.
