Tuesday June 7, 2022 7:00 P.M.

The meeting was called to order at 7:00 P.M. by Chairman Sullivan who requested that Legislator Albano lead in the Pledge of Allegiance and Legislator Sayegh in the Legislative Prayer. Upon roll call, Legislators Montgomery, Gouldman, Addonizio, Nacerino, Albano, Jonke, Castellano, Sayegh and Chairman Sullivan were present. Also present was Legislative Counsel Firriolo.

PROCLAMATIONS

Chairman Sullivan presented the following proclamation to High School Football Coach Todd Cayea.

HONORING CARMEL HIGH SCHOOL FOOTBALL COACH TODD CAYEA

WHEREAS, on December 4, 2021, for the first time in Carmel High School's history the Carmel High School Varsity Football Team won the New York State Class AA title, closing out an undefeated season under the leadership of Coach Todd Cayea; and

WHEREAS, Coach Todd Cayea has been involved with the Carmel High School Football Team since the mid-1990s and proudly holds a 170-81-1 record which includes multiple trips to the New York State Sectionals, Semifinals, Finals, and of course the most recent 2021 New York State Championship; and

WHEREAS, Coach Todd Cayea has relied on not only teaching his players to play well on the field, but the importance of accountability, trust, respect, and perseverance both on and off the field. He also credits the unwavering community support as an important building block in the team's confidence, pride, and success; and

WHEREAS, this year, Coach Todd Cayea was named the Class AA New York State Football Coaches Association Coach of the Year after the team's historical win; now therefore be it

RESOLVED, that Putnam County Executive MaryEllen Odell and the Putnam County Legislature hereby congratulate Carmel High School Varsity Football Team Coach Todd Cayea on this well-deserved honor!

Chairman Sullivan recognized Legislator Albano who presented the "National Safe Boating Month" proclamation which will be delivered to Charlie and Hannah Melchner from the Mahopac Marina.

NATIONAL SAFE BOATING MONTH – JUNE 2022

WHEREAS, recreational boating is a fun and enjoyable sport while being an excellent source of relaxation; however, boating can be a risky sport for the unprepared; and

WHEREAS, knowledge and skills are important in reducing human error and improving judgment when boating. If a person is aware of the risks, they are likely to take precautionary measures to protect themselves, their family, and their friends; and

WHEREAS, the United States Coast Guard Auxiliary, Putnam County Sheriff's Department, Carmel Police Department, has served the County providing boating education courses, making marine dealer visitations, conducting boating safety checks, and tending multi-mission patrols. Using their own boats and equipment, the Coast Guard Auxiliary has been able to reduce boating accidents and fatalities; and

WHEREAS, these vital services offered by the Coast Guard Auxiliary, Putnam County Sheriff's Department, Carmel Police Department, work in conjunction with local law enforcement, specifically the Carmel Police Department and Putnam County Sheriff's Department, to maintain safety on the water. As a result of the careful attention placed on boating, the waters of Putnam County are made safer through spreading messages of boating safety, not only during National Safe Boating Month, but throughout the entire year; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby support the goals of the North American Safe Boating Campaign and proclaim June 2022 as "National Safe Boating Month" in Putnam County and the start of the year-round effort to promote safe boating.

Item #6b – Approval/ Fund Transfer (22T077)/ Sheriff’s Department/ Part-Time Civil Clerk was next. On behalf of the members of the Personnel Committee, Legislators Addonizio and Nacerino, Legislator Jonke moved the following:

Legislator Montgomery made a motion to table this item.

Legislator Montgomery stated that in listening to last month’s Personnel Committee meeting, she realized that a lot of things cited during that meeting justifying the need for this position, including the 2018 Operational Audit, pointed out insufficiencies, however, she stated that the Legislature has never seen the 2018 Operational Audit. She stated that other reasons cited for justifying this position were post Covid workflow, and most of all, training. She stated during the meeting that we already had two (2) full time clerks and there was a need for training them. She stated that we have a very qualified Civil Captain who could easily train these clerks. She stated that it was obvious to her during the Personnel Committee meeting that this was a given that it would be requested in the 2023 budget as mentioned by Legislator Albano. She did not see a need for this position, especially since we still do not have a Civil Sergeant position which she believed there was more of a need for to oversee what is out in the field. She explained that the position was taken out in 2020 to reduce costs because of Covid. She believed that there were plenty of funds for this and probably should not have been taken out, however she still believes the priority is a Captains position.

Legislative Counsel Firriolo stated as a point of procedure, the motion to table requires a second. He stated that if there is a second, it is not debatable and must be voted on immediately. If there is no second, the motion fails.

Chairman Sullivan asked if there was a second on the motion to table. Being no second, the motion failed.

Legislator Jonke stated that there is nobody better able to decide what the Sheriff Department needs, other than our Sheriff. He stated that the Sheriff was very clear of what he wanted in the department and how he wanted them to be trained. He believed that we should leave it to the Sheriff who was elected to perform his job and make these decisions. He stated that he totally supported this resolution.

Legislator Nacerino concurred. She stated that the assessment of what is needed in the Sheriff's Department falls under the purview of the Sheriff. She stated that based on the recommendation, she believed this position was needed because there is limited knowledge of civil procedures with the current staff. She stated that they need someone who can hit the ground running. She stated that whether or not this becomes a full-time position in 2023 is not relevant to the consideration tonight.

Legislator Albano concurred. He stated that he trusts the Sheriff's judgment and believed that he was the right person to make this decision.

Legislator Sayegh pointed out that it was Captain Grossi who has a wealth of experience in civil procedures from Westchester County who has requested the position as a temporary employee. She stated that this particular employee has over 20 years of experience of civil enforcement procedures. She stated that the Sheriff has supported this request.

Legislator Castellano stated that, in his day job with 26 years in the court system in Westchester County, he explained the heavy workload in the civil department after the courts were closed during Covid. He believed that hiring someone to do some of this work would be important to allow the Sheriff's Deputies to perform their duties out in the field. He believed this was the right thing to do right now as the court system is trying to catch up after all the layoffs we had during Covid.

Chairman Sullivan concurred. He explained that Sheriff McConville and Captain Grossi know what is needed.

Legislator Montgomery stated that she is not trying to micromanage the Sheriff. She believed that this was a different scenario than the previous Sheriff who had no purview over what was right for his department. She was not implying that the Sheriff does not know what he is doing. She explained that it was her responsibility as a Legislator to ask these questions. She questioned if other individuals have an opportunity to apply for the position, what is this person's training and is he the most qualified. She did not understand why the Captain, who is really qualified to train his staff at the Civil Division, cannot train these people. She believed that the County Executive has stated, "no new hires in 2022."

Chairman Sullivan stated that he did not agree with some of Legislator Montgomery's comments. Chairman Sullivan called for a Roll Call Vote on the resolution.

Legislator Albano stated that it is imperative to make sure the drinking water at county facilities are tested. He stated that if there is an issue with the water it would need to be addressed.

Legislator Sayegh believed that when Deputy Commissioner of Highways & Facilities John Tully came before the Physical Services Committee, he discussed that they performed water tests at all the County facilities.

Legislator Gouldman questioned if the water testing was being required by the State or the Federal government.

Legislator Albano stated that he did not know the answer to that question. He stated that there are many places in Putnam County that have water quality issues. He stated that the bottom line is that the water should be tested regardless of who mandates it.

Legislator Sayegh stated that the fund transfer states that this is the Department of Health required water supply testing.

Chairman Sullivan stated that the water quality in many of the Putnam County residential wells is mineral rich and requires a lot of testing. He believed that the water testing is performed at all the Putnam County facilities as a regular course of business.

Legislator Montgomery questioned if the resolution could be corrected to say, “all county facilities” instead of “various county facilities.”

Legislator Albano believed that the “various county facilities” are those deemed to be tested and there may county facilities that are not required to be tested.

Legislator Nacerino stated that she supports the wording of “various county facilities.” She stated that the water is not potable in many county office buildings.

Legislator Montgomery explained that this is another expense that the County takes on and she believed it should be taken into consideration when we are negotiating leases at Tilly Foster Farm. She suggested using the funds collected for parking at the events held at Tilly Foster Farm to pay for the water testing.

WHEREAS, Source Properties, Inc. is the owner of certain real property located at 20 Fair Street, Carmel, New York, including the building and appurtenances located thereon; and

WHEREAS, the County and Homeland desire to enter into a public private partnership for the purpose of constructing a one hundred and sixty (160) foot tower (the “Facility”), according to the specifications provided in certain engineering documents produced by Homeland (“Site Plan”), with County emergency service antennas located thereon and which shall provide for the collocation of commercial wireless communication facilities including antennas and related equipment on the Facility, all of which shall be situated on or within a 3,600 square foot lease parcel; and

WHEREAS, the County Legislature intends to also review the proposal to determine whether the Facility should be exempt from local zoning requirements; and

WHEREAS, both the review of the Site Plans and the determination whether the Facility should be exempt from local zoning requirements shall be collectively deemed the “Project”; and

WHEREAS, the proposed action hereunder is subject to review under the State Environmental Quality Review Act and the Regulations promulgated thereunder (“SEQRA 6 NYCRR Part 617”); and

WHEREAS, other interested agencies (the “Interested Agencies”) have been identified in connection with the proposed action, however there are no other Involved Agencies; and

WHEREAS, a long Environmental Assessment form (EAF) has been prepared for the Project; and

WHEREAS, the Putnam County Legislature (the “Legislature”), after review of Part 617, finds that the proposed action is an “Unlisted” action, as defined in 6 NYCRR Part 617.2; now therefore be it

RESOLVED, that the Legislature hereby declares its intent to serve as the Lead Agency under the procedures and requirements of SEQRA, to circulate a Lead Agency Notice along with the EAF and associated documentation to all Interested Agencies and to follow protocol in accordance with and as required by all relevant rules and regulations.

APPROVAL/ FINANCE/ REAL PROPERTY/ WRITE OFF OF DELINQUENT REAL PROPERTY TAXES/ CARMEL TAX MAP PARCEL 64.7-1-31

WHEREAS, the property identified as Carmel tax map parcel 64.7-1-31 has accrued delinquent real property taxes dating from 2010-2022; and

WHEREAS, on February 2, 2022 the Town of Carmel took title to Carmel tax map parcel 64.7-1-31 to correct an erroneous conveyance in 2017 of property to be used in stormwater remediation ; and

WHEREAS, the Town of Carmel has requested that the delinquent real property taxes be written off, as the property is an integral part of a stormwater treatment system for roadways owned and maintained by the Town of Carmel; and

WHEREAS, the Legislature has determined that there may be a legal impediment to the enforcement of delinquent property tax liens pursuant to section 1138 of the NYS Real Property Tax Law; and

WHEREAS; the Audit & Administration Committee has reviewed and recommends that these delinquent property taxes be written off; now therefore be it

RESOLVED, that the Putnam County Legislature approves that these delinquent real property taxes be written off; and be it further

RESOLVED, that the Commissioner of Finance is directed to issue a certificate of withdrawal and write off the delinquent real property taxes for Carmel Tax Map Parcel 64.7-1-31 pursuant to section 1138 of the NYS Real Property Tax Law.

Item #6w – Approval/ Grant Application/ Sheriff’s Department/ State And Municipal (SAM) Facilities Grant Program was next. On behalf of the members of the Audit & Administration Committee, Legislators Albano and Gouldman, Legislator Castellano moved the following:

RESOLUTION #118

APPROVAL/ GRANT APPLICATION/ SHERIFF’S DEPARTMENT/ STATE AND MUNICIPAL (SAM) FACILITIES GRANT PROGRAM

WHEREAS, Section 5-2(E) of the Putnam County Code provided, in relevant part, that an application of any grant application not requiring any Putnam County (the “County”) matching funds shall notify the Putnam County Legislature (the “Legislature”) of the submission of a grant application and further, if the Legislature objects to such grant application, the applicant shall withdraw it forthwith; and

WHEREAS, by and through the State of New York and Office of Senator James Skoufis (NYS Senate), the County can receive a State and Municipal (SAM) Facilities Grant in the amount of \$50,000.00, such grant administered through the Dormitory Authority State of New York (“DASNY”), to subsidize costs associated with the purchase of equipment, to include a license plate reader system, crime scene camera system, computers, a printer/copier/scanner and an alarm enhancement at the Philipstown substation; and

WHEREAS, there is no matching fund requirement by the County to accept the SAM grant for costs associated with the purchase of said equipment; now therefore be it

RESOLVED, that the Putnam County Legislature authorizes and approves the County’s submission through DASNY and awarded by the SAM Facilities Grant Program; and be it further

RESOLVED, that this resolution shall take effect immediately.

Item #7 – Other Business

There was no other business submitted to the meeting.

Item #8 – Recognition of Public on Agenda Items

There was no members from the public that wished to be recognized.

Item #9 – Recognition of Legislators

Legislator Albano stated that the opening of Restaurant Depot is great for Putnam County. He stated that the center is fantastic, and the sales tax revenue will benefit everyone.

Chairman Sullivan concurred. It will provide a service that the County does not have.

Legislator Nacerino expressed her congratulations for the Class of 2022. She also wished all those who are dads a Happy Father's Day.

Legislator Jonke stated that the Town of Southeast will hold their fireworks event on July 3, 2022 at Independence Way (Home Depot Shopping Center). He stated that there is still time to help sponsor the event. He also wished his neighbor and former Assemblyman, Willis Stephens Sr., a happy 97th birthday.

Legislator Montgomery stated that she is still waiting to receive the Bonadio report. She stated the report, which analyzed the sustainability of the Sheriff's Department, cost \$45,000. She also stated that she had requested to have a representative from the Bonadio group attend a legislative meeting. She stated that she had not received a response about this request from Chairwoman Nacerino of the Protective Services Committee. She stated that this request is important in light of recent headlines. She stated that she would like to recognize the mass shooting in Uvalde, Texas. She referred to a local headline which read "Local GOP blasts new gun laws, locally and nation-wide these members continue to insist that mental illness is the cause of mass shootings." She stated that she has been asking for additional funding for mental health. She stated that the Putnam County Legislature and the Putnam County Executive have failed in significantly increasing funding for mental health. She stated that the Putnam County Legislature and the Putnam County Executive decreased funding for mental health in 2021. She stated that there is no hope for Putnam County's response to this crisis. She stated that she felt that after the Sandy Hook massacre, Putnam County responded on a united front by providing resources. She believed the response after the Robb Elementary School massacre consists of condemning legislation meant to keep people safer and blaming the issue on mental health. She stated that in the years between the tragedies at Sandy Hook Elementary and Robb Elementary, Putnam County was not establishing mental health resources. She stated that the Sheriff's Department was supposed to receive tablets, which would provide mental health resources, in February. She questioned where these tablets were. She stated that if the Legislature wants to continue stating that the problem is due to mental health, more funding should be allocated to mental health resources. She stated that with the recent celebration of Memorial Day and the 77th anniversary of D-Day, the best way to maintain the legacy of veterans alive is to make a communal commitment to defend their mission of freedom. She recognized Pride month in relation to freedom. She stated that LGBTQIA+ members and veterans are not mutually exclusive. She explained that economic hardships and mental health struggles are common in veterans, and that the numbers are higher among LGBTQIA+ veterans. She expressed her hope for the Putnam County Veteran's Service Agency to expand the scope of services for veterans who were discharged under the Don't Ask, Don't Tell policy implemented under the Clinton Administration.

Chairman Sullivan explained that on June 1, 2022 the sales tax abatement law went into effect for gasoline. He stated there should be a reduction in gas prices. He also explained how with ARPA funding, mental health would be addressed.

Legislator Sayegh expressed her thanks for the Sheriff's Department for protecting children across Putnam County. She stated that Putnam County has a robust program which includes officers stationed at every school. She thanked the school boards for making the commitment to maintain this program. She stated that mental health is very

important and that she is sickened by children being harmed. She stated that she believes Putnam County does everything possible to protect children.

There being no further business, at 8:04 P.M., Chairman Sullivan made a motion to adjourn; seconded by Legislator Jonke. All in favor.
